2. Nature and/or Description of the Action Being Processed:

This procurement is for maintenance and support of the current Vidyo in room equipment that is used for TeleICU. A new firm-fixed-priced purchase order (base year plus 4 option years) will be awarded on a sole source basis for the procurement of maintenance and support of the previously purchased in-room equipment

FAR13.5 Test Program: This procurement is for maintenance and support of the previously purchased inroom equipment in accordance with FAR 13.5 Test Program for Certain Commercial Items and specifically FAR 13.501 Special Documentation Requirements, where acquisitions conducted under Simplified Acquisition Procedures are exempt from the requirements of FAR Part 6, but still require a justification using the format of FAR 6.303-2.

3. <u>Description of Supplies/Services Required to Meet the Agency's Needs:</u>

VISN 23 has installed Vidyo equipment across monitored sites in VISNs 23, 15 and 20. The implementation of this equipment enhances communication by meeting the latency constraints across the WAN, which allows for clear communication and for the audio to align with the video, which is not currently possible at sites at great distance from the Tele-ICU Support Center. The use of this audio visual equipment will enable greater collaboration, as multiple clinicians will be capable of viewing the same room simultaneously and allows all users in a session to both speak and hear. The equipment and services to be purchased includes all products listed below.

FAR13.5 Test Program: The authority for applying the Commercial Test Program of FAR 13.5 is (Section 4202 of the Clinger-Cohen Act of 1996) and is implemented by for restricting competition on this procurement via FAR 13.106-1(b)(2).

- 5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority): Yorktel is the only trusted video integration and managed service partner for the Philips eCareManager Implementation in dozens of healthcare systems, including VA hospitals in VISN 7, 10, 15, 20 and 23. Yorktel's particular engagement is with the TeleICU program for Philips (former Visicu). We began our work with them in late 2012 to deploy both in-room and mobile TeleICU systems. Their product based upon the Vidyo platform went into production on March 15, 2013. After speaking with both Yorktel and Philips it has been determined that several vendors can support the Vidyo equipment but only Yorktel can provide support to the equipment and the proprietary eCareManager software that Philips owns. This interface combines high definition video conferencing within the eCareManager application allowing for enhanced patient care. The cost of continuing to support the current equipment is far less than replacing all TeleICU software and infrastructure.
- 6. <u>Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable</u>: A sources sought was posted to FBO for several days to search for potential vendors during the market research phase of this procurement.
- 7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable: FAR Part 13.106-3 will be utilized to determine the price fair and reasonable. The anticipated pricing will be determined to be fair and reasonable based upon comparisons with pricing from recent purchases. A final fair reasonable determination will be made prior to award.
- 8. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: A sources sought was posted to FBO on 11/24/2014 looking for potential vendors that could meet the requirements listed in the SOW. The following documents the result of that sources sought: UNICOM Government, Inc. stated they could provide Vidyo Service and highlighted their technical support experience however they are not able to interface with the Philips eCareManager Software. Yorktel provided information that they are the partnered with Philips Healthcare and that they are the video integration and managed service partner for the Philips eCareManager Implementation. VectorUSA stated that they have 25 years of experience in providing service based on NAICS code 334310 however that they can provide service for the project but they did not have the ability to work with the Philips eCareManager software. Further market research showed that Philips was contacted to determine which vendors were capable of providing the required services to the Vidyo equipment. After speaking with both Yorktel and Philips it has been determined that several vendors can support the Vidyo equipment but only Yorktel can provide support to the equipment and the proprietary eCareManager software that Philips owns.
