1. During the Pre-Bid site walk that took place Wednesday 4/29/15, Asbestos was mentioned and alluded to as being present. Is there a report showing this?
2. General Notes AD101 describes the following:
 - a. Note #1 – Asbestos has been reported to exist in the soil below the tunnels. Contractor shall contact VA COTR prior to commencing any work to discuss and coordinate site related abatement. (See specification provide by VA)
 - i. There is note a specification 02 82 11, it has been omitted from the solicitation
 - ii. The supplied ICRA Report does not deal with this issue
 - iii. Is there a report showing this material and the amounts?
 - iv. Is the abatement to be included in the pricing of this project?
 - b. Note #2 – The following materials are assumed to have asbestos containing materials.
 - i. Piping & Duct Sealant
 - ii. Piping & Duct Insulation
 - iii. Flooring Tiles
 - iv. Ceiling Tiles
 - v. Contractor shall contact VA COTR prior to commencing any work to discuss and coordinate site related abatement. (See specification provide by VA)

 3. Is there a report showing this material and the amounts?
 4. Is the abatement to be included in the pricing of this project?

- c. Note #5 – If any hazardous material is found at the site, Contractor is to confirm existence with the COTR prior to commencing any work to discuss and coordinate site related extirpations. (See specification related to asbestos abatement provided by VA)
