**2. Nature and/or Description of the Action Being Processed:** This limited source justification and approval sets forth the facts and request approval to limit competition for the acquisition of endoscopic video accessories for the Stryker 1488 Video System. This acquisition is in direct support of medical care being provided at the VA Sierra Nevada Healthcare System.

**5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** The authority cited in paragraph 4 must be used because there is no other source through which the government can procure the

required accessories for the Stryker Endoscopic System currently in use by the VA Medical Facility. In order for the existing Stryker equipment to operate effectively, the accessories must be Stryker products because they are the only manufacturer that can provide compatible accessories for their systems. American Medical Depot is the sole small business distributor for Stryker equipment which limits the VA's options for this acquisition.

6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** A sources sought notice was posted on FBO on April 1, 2015 which called for all available sources to indicate whether or not they can satisfy the government's requirement. As of the notice's closing date of April 7, 2015, American Medical Depot was the only respondent to the sources sought. In addition, a sources sought notice was concurrently posted to GSA eBUY and by the close date there were no respondents which stated they could satisfy the requirement.
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** The Contracting Officer has determined that the anticipated price will be determined to be fair and reasonable. A Price Negotiation Memorandum (PNM) will detail how the Government has determined that the anticipated cost will be fair and reasonable. As this item has been determined commercial, cost and pricing data will not be required. Price techniques such as those described in FAR 15.404(b)(2), will be used to establish price fairness and reasonableness.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** As described in Section VI above, market research, in accordance with FAR Part 10, was conducted by synopsis of the proposed acquisition on FBO and GSA eBUY, advising industry of the pending acquisition and soliciting inquiries from interested parties. In addition, a search of the VA National Acquisition Center FSS Contracts produced no potential sources or compatible items.
9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** Any supporting data that is the responsibility of technical or requirements personnel (e.g., verifying the Government's minimum needs or requirements or other rationale for limited sources) and which form a basis for the justification have been certified as complete and accurate by the technical or requirements personnel. The evidence for this is the "Technical Data to Support a Restricted Competition" in the contract file.
