The Intended service is to provide comprehensive maintenance services for the Leica SP8 laser-scanning confocal microscope used by the Phoenix VA Health Care System. The SP8 is used by the researchers in the VA to produce 3-dimensional images of microscopic structures in human tissue and cells, as well as animal cell models of human diseases relevant to the Veteran population.

3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The Leica SP8 laser scanner confocal microscope is a proprietary piece of equipment that belongs to Leica Microsystems, which is the original equipment manufacturer (OEM). To date Leica Microsystems has not allowed any other organization or person (with exception of its own employees) to be trained and certified on for service and repair.

4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:

This is a highly specialized and sophisticated computer controlled machine, requiring specialized training and knowledge to diagnose and fix any problems that occur. Breakdowns of the machine can also be minimized with the performance of preventative maintenance visits which will be included in the service contract. Leica uses a unique design that is not similar to the designs of other confocal microscopes. They are the only manufacturer that uses rotating prisms instead of diffraction gratings, or High Definition sensors instead of cascade photodiodes. The SP8 is a new model of instrument, available only since late 2013. This piece of equipment has never before been outside of factory warranty service, and only the manufacturer's technicians have any experience to repair them. In addition to the latter, no other entity with the exception of Leica Microsystems makes parts for this piece of equipment.

5. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

Market Research for this requirement has shown that Leica Microsystems Inc. is the Original Equipment Manufacturer (OEM) and has established proprietary rights. On occasion the OEM has offered training on equipment it manufacturers; in this instance they have not offered any training on this piece of equipment since it is so highly sophisticated. In addition to the latter mentioned, other vendors have substantiated this claim by saying they can fulfill the requirement Only if they subcontracted the actual labor to the OEM. The Sources Sought posted to FBO for this requirement, did not reveal any other certified organizations or persons that are capable of undertaking the requirement of preventive maintenance on this piece of equipment.
