STATEMENT OF WORK

RADIO PHARMACEUTICALS

1. General Description: The contractor must provide and deliver radiopharmaceuticals to the Gulf Coast Veterans Health Care System at two locations. One location is in Biloxi, MS and the other location is in Pensacola, FL. The contractor must be able to provide radiopharmaceuticals to both locations. Radiopharmaceutical preparations of doses, tagging of blood, testing performed at contractor facility provided by a board-certified radiopharmacist and delivered to the Nuclear Medicine Section, Bldg 3, Room 2D114, "Hot Lab", Gulf Coast Veterans Health Care System, Biloxi, MS at 7:00 AM and to the Nuclear Medicine Section 2nd Floor Room 2C106 "Hot Lab", Pensacola, FL at 7:30 AM Monday through Friday. Contractor shall provide emergency deliveries as requested by the VA Nuclear Medicine Departments. Personnel assigned by the contractor to perform services covered by this contract shall be licensed in a State, Territory, or Commonwealth of the United States or the District of Columbia. **Because of the critical need of these supplies in a timely manner, vendor for radiopharmaceuticals must deliver items for emergent (non-scheduled) doses within 120 minutes of the telephone order. This may occur during normal working hours, after hours, week-ends, and holiday.**

In order to minimize patient delays on emergent requests, the vendor must provide daily the following on consignment

- **Tc99m-MDP 30mCi for bone scan calibration times to be determined upon selection of the vendor due to location and travel time**
- **Tc04 30mCi for MUGA or GI Bleed calibration times to be determined upon selection of the vendor due to location and travel time.**
- **TC99m-Sestamibi (MIBI)/Cardiolite 10mCi Mycardial Perfusion-Resting calibration times to be determined upon selection of the vendor due to location and travel time**
- **Tc99m-Sestamibi (MIBI)/Cardiolite 30mCi Mycardial Perfusion-Stress calibration times to be determined upon selection of the vendor due to location and travel time**

Deliveries shall incorporate sufficient lead or other high-density shielding to comply with all applicable federal and/or state standards relating to the shipment of radioactive materials. Shipping containers must comply with all federal and state regulations. This shall include, but not limited to DOT, DOE, NRC, NHPP, and ICC regulations and standards. The vendor shall supply to the VA written proof verifying all of their appropriate employees have received annual radiation safety training regarding the use and transportation of radioactive material as required by the state and/or federal regulations. Vendor shall supply copies of these documents prior to contract award. The vendor shall supply written documentation demonstrating containers, which transport doses of radiopharmaceuticals, meet state and/or federal regulations. This documentation shall be supplied prior to use of such containers. NOTE: "Non-High

Enriched Uranium (HEU) Tc99m” is not mandated by the Department of Veterans Affairs. However, contractor providing non-HEU Tc99m doses shall receive favorable consideration during the proposal evaluation process.

Vendor shall supply all documentations to verify any radiopharmacist preparing radio-pharmaceuticals are appropriately credentialed and licensed to dispense radiopharmaceuticals within the state of Mississippi or Florida (depending on which pharmacy they are working) and that all state and/or federal requirements are met. Vendor shall supply copies of these documents prior to contract award.

Vendor shall hold a current unrevoked US Nuclear Regulatory Commission (USNRC) and MS/FL Board of Pharmacy license to produce and distribute radiopharmaceuticals for human administration. Vendor shall supply a copy of their radioactive material license. Vendor shall immediately notify the VA Gulf Coast Health Care System upon any action by the NRC, FDA and/or others to modify or suspend vendor’s radiopharmaceutical license.

Listing of radiopharmaceuticals required and the estimated yearly use are attached. These quantities are estimates based on our last year usage. If ordering patterns of our providers result in a reduction of quantity required, we shall not be held liable for the differences.

Technetium product radiopharmaceuticals not used shall be returned for credit the next workday.

All doses shall be supplied in unit doses unless otherwise specified. All labeling shall meet federal and state requirements for radiopharmaceuticals. Each dose must contain a label on both the syringe and on the outside of the unit dose shield, which at a minimum shall contain the name and the amount of the radiopharmaceutical and the date and time of calibration. Vendor shall utilize syringes which minimize the residual activity of Tc99m-Sestamibi (MIBI)/Cardiolite.

2. Administration:

- a. Contractor shall bill on a monthly in arrears.
- b. All services rendered will be itemized by date of service, radiopharmaceutical provided, and unit cost.
- c. Technetium product radiopharmaceuticals not used shall be returned for credit the next workday.

3. Security and Confidentiality:

- a. Contractor shall be responsible for maintaining Automated Data Processing (ADP) security.
- b. Contractor shall be responsible for maintaining patient information in the strictest confidence in accordance with the Privacy Act, Healthcare Insurance Portability and Accountability Act (HIPPA), and all other applicable privacy rules and regulations.

4. Work Hours:

- a. The services covered by this contract shall be furnished by the contractor as defined herein. The contractor shall not be required, except in case of emergency, to furnish such services on a national holiday or during non-working hours as described below:

Work hours: Monday through Friday, 7:00 am - 4:30 pm. GCVHCS, Biloxi, MS

Monday through Friday, 7:30 am – 4:00 pm. JACC, Pensacola, FL

5. Delivery Orders:

Orders normally will be placed by 4:30 p.m., delivery shall be required directly to the Nuclear medicine Section, Bldg. 3, Room 2D114, “Hot Lab”, Gulf Coast Veterans Health Care System (GCVHCS), Biloxi, MS at 7:00 AM; and to the Nuclear Medicine Section second floor Room 2C106 “Hot Lab”, Pensacola, FL at 7:30 AM the following work day. Due to the demands of the Medical Center care requirements, there shall be no restriction to the number of orders which may be placed by VA, nor the number of deliveries required per day. In the event that the requirements may be determined in advance, a longer delivery time will be scheduled accordingly.

The delivery order shall specify: contract item (s) and quantity, time (s) of delivery and applicable VA order number.

7. Delivery Commitment:

Past Performance information will be utilized to assess risk of the contractor's Past Performance as it relates to the probability of success of the required effort. The Government will evaluate customer satisfaction, responsiveness to customer needs, and past demonstration of meeting delivery schedules of products and the delivery of quality services. Emphasis will be on Recent and Relevant (definitions described below) Past Performance:

Recent is defined as work performed within the last three (3) years immediately preceding the issue date of the RFP.

Relevant is defined as involvement in contracts or programs involving delivery of Radiopharmaceuticals and Services similar in magnitude to the effort required by this RFQ.

List the following information for each contract:

- Company Name and address
- Types of products and services performed
- Name, telephone number and e-mail address of responsible individuals who have first-hand knowledge of performance relative to the same type of products and services provided
- Dates of contract performance

- Total contract value

Current and relevant information, source of information, context of data, and general trends in Contractor's performance shall be considered as it pertains to the performance of work described in this solicitation. Offerors may provide information on problems encountered on identified contracts and the offeror's corrective action.

Offerors are reminded that the Government will use the submitted information, as well as information obtained from the Past Performance Information Retrieval System (PPIRS), Contractor Performance Assessment System (CPARS), personal knowledge, other evaluation team member's personal knowledge, or any other sources as deemed appropriate to evaluate each Offeror's Past Performance.

Offerors with no relevant Past Performance or whom information is not available shall not be evaluated favorably or unfavorably on Past Performance (i.e. will receive a neutral rating), but a neutral rating will not carry the same weight as someone with favorable Past Performance history.

FACTOR 3 – PRICE:

Price shall be evaluated for fair and reasonableness. Price will not be evaluated adjectivally. Offeror's pricing is to be placed in Section B Schedule of Supplies/Services and Prices/Costs of the RFP. The proposed prices shall be inclusive of all requirements in this solicitation. The Evaluation Preference contained in FAR 52.219-4 Notice of Price Evaluation Preference for HUBZone Small Business Concerns, will be applied if required.

V. SELECTION PROCEDURE: The Government expects selection of the contractor to encompass several steps including a trade-off method to determine **best value** to the Government, considering the selection criteria (factors are listed in descending order of importance) identified in FAR 52.212-2, in the Addendum to FAR 52.212-1, and as noted under BASIS FOR AWARD below. However, the Government may initiate action to award a contract at any point without discussions after review of the proposals. Therefore, each proposal should reflect the Offeror's best terms, both from a price and a technical standpoint.

BASIS FOR AWARD: The Government intends to make a single award based on the best value to Government by performing a price/technical and past performance tradeoff analysis. This process will permit the Government to make tradeoffs among price and non-price factors which allows the Government to make award to other than the lowest price proposal or other than the highest technically rated offer. However, price may become the deciding factor for award should the Government determine that non-price factors between proposals are approximately equal.

Technical and Past Performance, when combined, are significantly more important than Price.

VI. CONTRACT AWARD: A firm-fixed price Radiopharmaceutical Contract will be awarded to the offeror whose proposal represents the best value and is most advantageous to the Government, considering price and non-price factors as listed in FAR 52.212-2 - EVALUATION--COMMERICAL ITEMS (Jan 1999).
