The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. ## B.4 NOTICE TO OFFEROR

### 1. Introduction:

The Veteran Integrated Service Network (VISN) 22, Network Contracting Office (NCO) intends to establish a Lowest Price Technically Acceptable (LPTA) single award firm-fixed price (FFP) contract to provide Arrhythmia (event) and Holter monitoring service for VA Long Beach Healthcare System (VALBHS).

- 2. Submission of Quotes:** Quotes must be returned to the below listed address no later than the date and time specified in block #8, Page #1 of the SF 1449. Quotes shall not be hand carried. Faxed quotations shall not be accepted. Emailed quotations are the only method of submitted quotes (5MB email limit). The Government reserves the right to make award solely on initial quotes received. Offerors bear the burden of ensuring that all portions of the offer (and any authorized amendments) reach the designed office before the deadline specified in the solicitation. Quotations can be delivered to address shown in block #9, Page #1 of the SF 1449. **This RFQ shall be completed in its entirety, signed, and dated, failure shall not be considered for award.**

- 3. Contract Authority:** The Government will solicit and award this contract using Simplified Acquisition Procedures, in accordance with FAR subpart 13.5. As a result of this authority, certain requirements for soliciting, awarding, and notification are streamlined. In accordance with FAR 12.102(c), when a policy is inconsistent with FAR 12, Part 12 shall take precedence.

- 4. Period of Acceptance of Offerors:** The pricing terms and conditions of the quotes shall be valid for 30 days unless stated otherwise in the quote.

### 7. Format Of Quotations:

This section specifies the contents and format that offerors shall use when submitting quotations. All offerors shall submit a technical quote and a price quote. Offerors must include the name, title, address, and phone number of the individual responsible for the inquiries to the quote. Offerors shall submit one quote. To expedite the review of quotations, offerors shall submit their quotes in sections based on the following format:

- a. Standard Form of the Contract (1449), Amendments: Standard Form of Contract (SF 1449). Blocks 17a, 30b, and 30c of page I of Standard Form 1449 shall be completed by offerors and Block 30a shall be signed to show the offeror has read and agrees to comply with all terms, conditions, and instructions provided in the solicitation document. SF 1449 shall be filled out in its entirety, signed, and dated, failure shall not be considered for award.
- b. Amendments. All amendments issued shall be signed and dated, failure shall not be considered for award.
- c. Price Quote: Price quotes shall contain pricing information. The prices shall be provided in the SF 1149, failure to provide pricing shall be cause for rejection of the quote. Offers shall include pricing for the base year and all option years.
- d. Technical Proposal: **Technical shall not contain pricing information nor contractors name, logo or trademarks.** General statements that the offeror can comply with the requirements will not be adequate. Failure to provide the technical information requested or providing

unclear/inadequate information may be cause for rejection of the quote. One copy of the technical proposal shall be submitted unbound (email), to allow for reproduction for source selection purposes.

## B.5 STATEMENT OF WORK

1. **Introduction:** The purpose of this Statement of Work (SOW) is to outline the need for Arrhythmia (event) and Holter monitoring service that includes equipment, monitoring, and training for patients located the Veterans Affairs Long Beach.
2. **Place of Performance:** The selected contractor shall be providing equipment and off site monitoring. No travel fees will apply. All delivery, disposable items, and equipment are included in the item price.  
Location:

3. **Performance Period:** Base year with one (1) Option Year, base year starts 20 July 2015 to 19 July 2016.
4. **Scope of Work:** The contractor will provide Arrhythmia (event) and Holter monitoring for patient care in the Medical Services Section. They will provide the following:
  - a. The contractor shall furnish, for the life of the contract, the following equipment at no additional costs to the Government:
    - 1) Personal cardiac event (arrhythmia) monitors.
    - 2) Personal cardiac holter monitors.
    - 3) Personal cardiac event/holter monitors combination.
    - 4) Current operator's manual(s).
  - b. The system shall have an on board manual to include system operation and troubleshooting. The contractor shall repeat the monitoring study at no additional costs to the Government for the following reasons:
    - 1) Device provides unsatisfactory results.
    - 2) Device fails to transmit or download information.
    - 3) Information is not retrievable through the use of the web based system.
    - 4) There is an imaging defect or artifact determined by the VA to be substandard.

**5. Equipment:**

- a. All equipment offered shall be U.S. Food and Drug Administration (FDA) approved.
- b. All cardiac event and holter monitors shall be provided by the contractor for VA use and shall be state-of-the-art equipment, lightweight, and simple for patients to use. Patients will use the event monitor for approximately thirty-days (30), or as specified by the VA provider. Samples shall be provided to each site during the training or orientation process.
- c. The contractor and facility COR will determine an equipment inventory level at the time of contract award that shall remain at each facility location at all times. This equipment inventory must be adequately restocked at all times to ensure that the facility can always meet the daily patient demand.
- d. All equipment remains the sole property of the contractor including the initial delivery of the units. The contractor is responsible for all service maintenance and repairs of the equipment and hardware.
- e. The contractor shall supply a postage-paid return container for the cardiac event, holter, monitors.
  - 1) Equipment that is assigned to patients shall require monitoring 24 hours a day, while the device is in use.
  - 2) Capability of event transmissions being sent via wireless/cell phone technology.
  - 3) Event Auto Trigger Technology.
  - 4) Full Disclosure Recording capabilities.
  - 5) Per hour calculation of the burden # of premature ventricular contractions (PVC's) or premature atrial contractions (PAC's).
  - 6) Recordings available online.
  - 7) Two part service: 24/48 hour holter followed by 10-30 day event/arrhythmia monitoring.
  - 8) On-call services for patients shall be available 24/7.
  - 9) Both patients and VA staff shall have unlimited 24/7 telephone access to contractor's support staff that are knowledgeable and shall supply help in resolving any monitoring problems.
  - 10) Contractor shall transmit the data, analysis, and interpretation electronically to the appropriate VA Long Beach facility for review within 24 hours of receipt unless there is a potentially life-threatening arrhythmia and/or event. ***In the event of a life threatening arrhythmia and/or event, the contractor shall call 911 and dispatch emergency services to ensure the patient receives adequate treatment.***
  - 11) **All events of an emergency or STAT nature shall immediately be phoned to the appropriate VA Long beach facility no later than one hour (1) after receipt and recognition of such data.**
  - 12) The contractor shall provide a detailed monthly report for all Veteran patients receiving full services to the COR (Contracting Officer Representative) at the end of the current billing period. Full services are defined as patients that have been identified by a VA provider as requiring monitoring services, have been assigned a monitor that has been returned to the contractor for interpretation, the interpretation has been reported back to the appropriate medical center, and the interpretation report is determined to be without technical error.
  - 13) At the end of the patients monitoring period, the contractor shall provide a detailed summary report of the patient's arrhythmia burden. Report shall include: arrhythmia summary, atrial fibrillation burden, bradycardia burden, tachycardia burden, symptoms, and event strips.

**6. Instrument Capabilities: Arrhythmia & Holter**

- a. Small and lightweight design.
- b. Capability of event transmissions being sent via wireless/cell phone or advanced technology.
- c. Event Auto Trigger Technology.
- d. Customizable monitors.
- e. Two part service: 24/48 hour holter followed by 10-30 day event/arrhythmia monitoring.
- f. Pacemaker pulse detection.

- g. Instrument/Monitor has a date and time stamp for clinical reports.
  - h. Instrument/Monitor can correlate between time and symptom.
  - i. Holter monitors must provide 3 continuous diagnostic channels, ECG for up to 48 hours, set 3-channel pacemaker annotation, and the ability to correlate symptoms and activity with ECG changes.
  - j. All consumable items (batteries, patches) are provided to patient by contractor who returns the item after monitoring period.
  - k. Contractor equipment shall provide a thirty-day (30) battery life, using standard size batteries readily available, and easily changed by the patient.
  - l. There shall also be an internal back-up battery capable of storing the recorded data for at least thirty days.
  - m. Multiple programming options.
  - n. Accelerated transmission speed (4x).
- 7. Training:** The contractor shall provide comprehensive training to each of the VA Long Beach Medical Centers. Each site may require multiple training sessions for numerous staff. The training shall consist of proper use of the monitoring devices, instructions on how to upload patient information into contractor provided software and/or websites, and how to maintain or provide basic quality assurance tests. Contractor shall also provide each participant at each facility copies of manuals, equipment checklists, surveys, and specific contact information in the event that a medical center staff person needed to contact the contractor 24/7.
- 8. Technical Support:** Technical support is required via telephone for troubleshooting of method and/or problems. The response time for telephone technical assistance shall be within one (1) hour from the time of the initial call for technical support. Contractor must also show availability 24/7 for patient support. Contractor must have appropriately trained personnel available by phone throughout the duration of all tests for patient support.
- 9. Quality:**
- a. **Maintenance:**
    - 1) All monitors at each location will be kept at OEM specs. All portable arrhythmia, and holter, monitoring equipment shall be cleaned, disinfected, and decontaminated according to accreditation standards, each time before it is sent to patients. Unclean equipment should be stored in an area separate from cleaned equipment to prevent cross contamination.
    - 2) Contractor shall demonstrate set procedures for proper inspection and maintenance of the portable monitoring equipment and shall provide each location a copy of the inspection checklist.
    - 3) The contractor shall have a formal procedure to validate the functional integrity of any device before it is provided to a patient, and shall, at a minimum, complete and document such validation procedure whenever a device is returned with non-diagnostic or unsatisfactory results, or when visual inspection suggests the possibility of device damage.
    - 4) Contractor shall report on the failure rate of their equipment and supply maintenance records.
    - 5) When upgrades to the analytical software or hardware are available that are designed to improve the performance of the analytical system, those upgrades shall be made available to the VA Long Beach Medical Centers at no additional costs.
    - 6) The contractor shall coordinate installation of upgrades with the COR.
    - 7) The contractor shall provide customer notifications and latest operator's manual within 10 days after their release/publication.



**b. Quality Program:**

- 1) The contractor shall maintain a quality system that ensures conformance to contractual requirements and meets the requirements of ISO 9001, or an equivalent quality system during performance of this contract.
- 2) Contractor must have a clearly defined process by which it collects the required data, performs root cause analysis, and can supply easily understandable reports.
- 3) Contractor must demonstrate that their information systems are HIPAA compliant and that the raw data can be transferred securely and with accuracy to the VA.

**10. Deliveries:** Deliveries to the VA Long Beach Medical Centers are to be made Monday through Friday, excluding holidays, between the hours of 8:00 AM to 4:00 PM local time. All items shall be coordinated with the COR. Orders shall be delivered 2nd day delivery, however, emergency orders shall be made overnight.

**11. Government holidays:**

The contractor is not required to provide service on the following National holidays, nor shall the contractor be paid for these holidays.

If a holiday falls on Sunday, the following Monday shall be observed as the National Holiday. When a holiday falls on a Saturday, the preceding Friday is observed as a National Holiday by U.S. Government agencies. Also included would be any day specifically declared by the President of the United States.

**12. Overtime and holidays:** Any overtime or holiday pay that may be entitled to Contractor personnel performing under this contract shall be the sole responsibility of the Contractor and shall not be billed to nor reimbursed by the Government.

**13. Parking policy:** It is the responsibility of contractor personnel to park only in designated parking areas. Parking information is available from the VA Police. The VA shall not invalidate or make reimbursement for parking violations of contractor's personnel under any circumstances.

**14. Smoking policy:** Contractor personnel may smoke only in designated areas. Smoking is allowed in all outside areas that are 25 feet away from entrances to buildings unless indicated otherwise. Enclosed patios connected to facility buildings are considered part of the building and as such are non-smoking areas.

**15. Ordering activity:** Contractor shall not accept any instructions issued by any person other than the CO or COR acting within the limits of his/her authority.

**16. Changes to Contract:** Only those services specified herein are authorized. Before performing any service of a non-contractual nature, contractor shall advise the CO of the reason(s) for the additional work and/or service. Prior authorization shall be obtained from the CO before performing the services.

**17. Complaints:** Contractor shall promptly and courteously respond to complaints within 3 working days. Including complaints brought to contractor's attention by the CO. Contractor shall maintain a written record of all complaints, both written and oral showing the identity of the individual, the nature of the complaint, and contractor's response. Contractor shall permit the Government to inspect such records upon reasonable notice.

**18. Badges:** All contractor personnel shall be required to wear VA provided identification (I.D.) badges above the waist at all times while on the VA grounds. Contractors shall be required to coordinate with COR in order to obtain the VA provided I.D. badges for all staff. All VA provided I.D. badges shall be returned at the end of the contract or upon completion of service. Failure to wear ID badges may result in removal from any of the VA facilities and/or otherwise referred to federal property.

(1) The total number of employees in the contractor's workforce, by job category and hiring location, who are disabled veterans, other protected veterans (i.e., active duty wartime or campaign badge veterans), Armed Forces service medal veterans, and recently separated veterans;

(2) The total number of new employees hired during the period covered by the report, and of the total, the number of disabled veterans, other protected veterans (i.e., active duty wartime or campaign badge veterans), Armed Forces service medal veterans, and recently separated veterans; and

(3) The maximum number and minimum number of employees of the Contractor or subcontractor at each hiring location during the period covered by the report.

(c) The Contractor shall report the above items by completing the Form VETS-100A, entitled "Federal Contractor Veterans' Employment Report (VETS-100A Report)."

(d) The Contractor shall submit VETS-100A Reports no later than September 30 of each year.

(e) The employment activity report required by paragraphs (b)(2) and (b)(3) of this clause shall reflect total new hires, and maximum and minimum number of employees, during the most recent 12-month period preceding the ending date selected for the report. Contractors may select an ending date—

(1) As of the end of any pay period between July 1 and August 31 of the year the report is due; or

(2) As of December 31, if the Contractor has prior written approval from the Equal Employment Opportunity Commission to do so for purposes of submitting the Employer Information Report EEO-1 (Standard Form 100).

(f) The number of veterans reported must be based on data known to the contractor when completing the VETS-100A. The contractor's knowledge of veterans status may be obtained in a variety of ways, including an invitation to applicants to self-identify (in accordance with 41 CFR 60-300.42), voluntary self-disclosure by employees, or actual knowledge of veteran status by the contractor. This paragraph does not relieve an employer of liability for discrimination under 38 U.S.C. 4212.

(g) The Contractor shall insert the terms of this clause in subcontracts of \$100,000 or more unless exempted by rules, regulations, or orders of the Secretary of Labor.

## **C.8 VAAR 852.215-71 EVALUATION FACTOR COMMITMENTS (DEC 2009)**

Submission of payment requests by mail may be required for:

(1) Awards made to foreign vendors for work performed outside the United States;

(2) Classified contracts or purchases when electronic submission and processing of payment requests could compromise the safeguarding of classified or privacy information;

(3) Contracts awarded by contracting officers in the conduct of emergency operations, such as responses to national emergencies;

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the

Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

Award: Will be made to the responsive and responsible Offeror whose quote conforming to the solicitation is determined Lowest Price Technically Acceptable (LPTA) to the Government. Therefore, the Offeror with the lowest cost or price alone may not necessarily be awarded the contract.

**E.7 52.217-5 EVALUATION OF OPTIONS (JUL 1990)**

Except when it is determined in accordance with FAR 17.206(b) not to be in the Government's best interests, the Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).
