3. Specific Tasks

General Requirements:

1. All services to be completed no later than Aug 30, 2015.
2. Phoropter PM includes the following (at a minimum)
 - 2.1.1.CLEANING OF ALL OPTICAL SURFACES.
 - 2.1.2.REMOVE OLD LUBE AND PUTTING FRESH LUBE IN ALL BEARING SURFACES.
 - 2.1.3.ALIGNMENT OF ALL OPTICAL AXIS’.
 - 2.1.4.REPAIR OF ANY FUNCTION AND REPLACEMENT OF BROKEN OR WORN PARTS WITH FACTORY SUPPLIED PARTS.
3. Contractor is to provide all parts (excluding consummables) and labor to perform in-depth preventive maintenance on the Reichert phoropters owned by the Portland VA (and its other campuses or CBOCs.)
4. Any parts provided must be OEM approved and meet OEM specifications for build and design.
5. After the PM, the unit must perform in accordance to the OEM operational specifications.
6. If any repairs are required, the contractor will notify Biomedical Engineering at [REDACTED] immediately. Costs for repairs will be handled separate from this PM contract.
7. Contractor must be able to be onsite within 2 hours under normal conditions in the event of an emergency or a callback resulting from the preventive maintenance that was performed.
8. Contractor must have received OEM training on the specific manufacturer Reichert and model of equipment at the Portland HCS.
9. Contractor must be experienced in performing repairs and preventive maintenance on phoropters and other eye equipment.

4. Performance Monitoring

The tasks are well defined and can, therefore, be easily monitored by the Government point of contact (POC), who shall represent the government for this process. The contractor performance will be monitored and the work certified by the POC. The POC will assure contractor quality by routine inspections, product sampling, and monitoring of work while work is being performed.

5. Security Requirements

The contractor will be required intermittent access to VA Facilities as a result of this purchase order. The contractors must report to Human Resources and be issued a flash badge. The contractor will be escorted by authorized VA personnel at all times. There will be no access to any secure area or any area which may contain patient information.

7. Inspection and Acceptance Criteria.

The POC is responsible for certifying that the work done under this contract is performed to standard. The POC is also responsible to assure the inspection and acceptance of products provided incidental to services.

8. Place of Performance.

Work will primarily be performed at the Portland VA, Vancouver campus, Hillsboro CBOC and Bend CBOC.
