Subj: Homeless Program Reporting Requirements

To Network Directors (10N1-23)  
VISN Chief Medical Officers (10N1-23)

1. In a memorandum from my office (Attachment A) dated December 21, 2010, titled "VA Participation in the Homeless Management Information System (HMIS)"; VISNs were informed that VA was embarking on a plan to fully participate in the Department of Housing and Urban Development's (HUD) HMIS over the next 12 months. HMIS is a Web-based software application that records and stores client level information, serving the needs of individuals who experience homelessness, and assisting communities to coordinate care and manage operations. This effort is a critical component of the performance and management plan contained in VA's plan to Prevent and End Homelessness among Veterans.
2. VA's Homeless Operations Management and Evaluation System (HOMES) is a component that will link with HMIS. HOMES is a patient information system used by VA staff delivering specialized homeless services to Veterans seen at VA. HOMES became operational on April 20, 2011. The intent is to have VA's HOMES fully link with HUD's HMIS system so Veteran-level data can be accurately captured.
3. To ensure full HOMES and HMIS participation, it is necessary that the following steps are taken:
  - a. All VA staff assigned to a specialized homeless program must enter data into HOMES. Starting July 1, 2011, monthly reports on VISN and VA Medical Center (VAMC) compliance with HOMES data entry requirements were issued by the National Homeless Program Office. If VISNs have deficiencies in HOMES reporting, they will be required to submit monthly corrective action reports to the National Homeless Program Office.
  - b. VAMCs must ensure that all programs with a primary mission of serving homeless Veterans are included in their community's Continuum of Care (CoC) Housing Inventory Count (HIC). For guidance concerning programs that must be included in the HIC, HMIS data entry responsibility, and proper coding classification, please reference Attachment B.
  - c. To assist you in coordinating this effort, Attachment A provides a list of local CoC HMIS points of contact (POCs). This information is also



available and updated on HUD's Homelessness Resource Exchange (HRE) at [www.hudhre.info](http://www.hudhre.info). The homeless coordinator or designee should work with the local HMIS POCs to ensure local HIC information is accurate.

4. VA grant and contract providers must enter data directly into HMIS. Grant and Per Diem providers began doing so on April 1, 2011. It is now necessary for Health Care for Homeless Veterans (HCHV) residential contract and emergency housing providers to also enter data directly into HMIS. To facilitate compliance with this memorandum, VISNs must direct their contract officers to modify existing contracts, or when issuing new contracts, require that contracts include the following text:

*Veterans served through VA's HCHV residential contract/emergency housing program must have client level data entered into the local community Continuum of Care's (CoC) HMIS. Data entered must include, at a minimum, the Universal Data Elements from the 2010 HMIS Data Standards.*

1. In 2009, Secretary Shinseki unveiled a 5-year plan to prevent and end homelessness among Veterans. In June 2010, Opening Doors, the Federal Strategic Plan to Prevent and End Homelessness, was also announced to end Veteran homelessness in 5 years. Both plans require accurate and timely data regarding the prevalence of homelessness among Veterans and other key demographics.

2. The United States Interagency Council on Homelessness (USICH) is finalizing a performance management plan that will monitor and report the progress of all Federal partners and communities in achieving the goal of zero homelessness among Veterans by the end of fiscal year 2014. A critical component of the performance and management plan is the use of the local Homeless Management Information System (HMIS) to collect and report data.

3. HMIS is a web based software application that records and stores both program and client information at the local continuum of care level. A Continuum of Care (CoC) is a regional or local planning body that coordinates housing and services funding for homeless families and individuals. Each CoC selects and implements an approved HMIS software product to store and report their data to the Department of Housing and Urban Development (HUD). HUD currently uses HMIS to understand patterns of homelessness, to produce unduplicated counts of homelessness, and to evaluate the effectiveness of homeless programs.

4. HMIS has been implemented in 450 CoCs to collect data, report on trends, service utilization and performance being provided to homeless individuals and families. CoC provider's participation in HMIS is required in order to receive HUD funding, except when prohibited by law such as the Violence Against Women Reauthorization Act. Data from the HMIS is aggregated and provided to Congress in the Annual Homeless Assessment Report (AHAR) as well as the Quarterly Homelessness Pulse Report. The VA, the Department of Labor and the Department of Health and Human Services are all being asked to consider HMIS as the single point of data collection in each community.

5. Over the next 12 months, VA plans to fully participate in HMIS. As an initial first step to using HMIS as the data collection system, the National Homeless and Residential Rehabilitation and Treatment program office is requesting your assistance by requiring your local community partners, including Grant and Per Diem Providers, to begin entering client level data into the CoC's HMIS as soon as possible, but no later than March 31, 2011.

6. To assist you in coordinating this effort, Attachment A contains a list of local CoC HMIS points of contact (POC). This information is also available and updated on HUD's Homelessness Resource Exchange (HRE) at [www.hudhre.info](http://www.hudhre.info). We ask that your homeless coordinator, as well as your Grant and Per Diem partners, contact the CoC HMIS POC as soon as possible to determine what steps are necessary to begin participating in the HMIS.

7. Additionally, the program office has arranged for a series of teleconferences for both VA homeless program staff and community agencies to learn more about HMIS and how to enter data into HMIS. A Live Meeting for VA staff is scheduled for January 21, 2011 at 2:00 pm EST and a meeting with community providers is scheduled for January 28, 2011 at 2:00 pm EST. 8. Additional information on HMIS implementation can be found at HUD's HMIS website at [www.hmis.info](http://www.hmis.info). Updated information regarding VA's strategy to fully participate in HMIS and how HMIS ties in to the VA Homeless Registry will be made available later this fiscal year.
