1. Within the solicitation it is stated that the IDIQ established min and max dollar amounts are \$25,000/\$925,000 respectively for base and all option years. Are these values per year or are they to be divided amongst the potential full time of the contract, such as the base year plus the four option years, a total of five years?

The minimum is for the base period (first year of performance). The maximum amount is for the full length of the contract if all options were exercised. It's highly likely that the full estimated quantity will be required each year but, that amount is only an estimate.

2. Within the solicitation there is a past performance questionnaire to be completed. Is the completion of this questionnaire required for initial contractors/offers?

No. If a contractor doesn't have any past performance (or customers to complete a past performance questionnaire) they will receive a neutral rating on past performance. However, if you have past performance similar in scope to this requirement, completed past performance questionnaires can help your business achieve a rating higher than neutral for the past performance evaluation factor.

3. Are you able to provide examples of a QASP or give direction to resources that may be available?

There is a QASP attachment for this solicitation. Offerors don't need to develop their own QASP. All that is needed is a signature on the QASP and the Contractor program manager identified.

4. Is there currently an incumbent performing the service to VA Black Hills Health Care System?

Yes, this service has been required by the VA Black Hills Health Care System for over ten years. The incumbent contractor is Wong Pharmacy Services, Inc.

5. Will the September 7, 2015 deadline date be extended?

There are no plans to extend the proposal deadline at this time.
