2. Description of Supplies or Services:

This is a request for other than full and open competition for the procurement of the qualified personnel, materials, equipment, and services necessary to install and perform site prep for continuation of two ceiling lift systems. This equipment is required to meet the lifting and repositioning needs of the radiology and/or dialysis clinics, support the VHA directive to eliminate and/or minimize manual lifting of patients and provide sufficient SPH equipment to meet facility patient lifting needs in all situations.

3. Authority:

4. **Rational/explanation to support cited authority:** It is desired that Prism/ Waverly Glen lifts are to be installed based on training; for this particular lift is already installed in more than 125 rooms at this facility. Standardization of rail system, motor and accessory items are desired because maintaining the same vendor allows for consistency of operation among staff and the ability to interchange accessory items between present and future equipment. Omni charge or continuous charge track and compatible motor system are desired. Subcontract installation staff also must have oversight and responsibility by a Waverly Glen/ Prism Project Manager.
5. **BRAND NAME ONLY:** This buy is estimated to exceed \$25,000 and this documentation will be posted along with the RFQ on e-Buy, as required by FAR 8.405-6(b)(3).
