To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. STATEMENT OF WORK

Project Title:

Water Sampling and Analysis

Objective:

To acquire routine water sampling and analysis services compliant to Department of Veterans Affairs VHA standards, guidelines and VHA Directive 1061 dated August 13, 2014.

Type of Contract:

The government intends to establish a Blanket Purchase Agreement (BPA) for its ongoing requirement for water sampling and analysis services. Offerors will submit a pricing schedule based on the requirement of this Statement of Work that will be incorporated into the awarded Blanket Purchase Agreement. The Government's intent is to establish the awarded BPA for a period of five years; however the agreement will be reviewed annually to determine its ongoing need. The Government is obligated only to the extent of authorized purchases actually made under this BPA. The Master BPA will not obligate any funds. Funds will be obligated upon completion of scheduled sampling and analysis events. There will be no minimum purchase required under this BPA.

Period of Performance:

The Government's intent is to establish the awarded BPA for a period of base plus four one year option periods available; however the agreement will be reviewed annually to determine its ongoing need.

COR:

The COR monitors all technical aspects of the contract and assists in contract administration. The COR is authorized to perform the following functions: assure that the Contractor performs the technical requirements of the contract; perform inspections necessary in connection with contract performance; maintain written and oral communications with the Contractor concerning technical aspects of the contract; issue written interpretations of technical requirements, including Government drawings, designs, specifications; monitor Contractor's performance and notifies both the Contracting Officer and Contractor of any deficiencies; coordinate availability of government furnished property, and provide site entry of Contractor personnel. A letter of designation issued to the COR, a copy of which is sent to the Contractor, states the responsibilities and limitations of the COR, especially with regard to changes in

cost or price, estimates or changes in delivery dates. The COR is not authorized to change any of the terms and conditions of the resulting order.

Project Scope:

The Contractor will provide all management, supervision, labor, materials, supplies and equipment, and will plan, schedule, coordinate and assure effective performance of all services described herein. This agreement will include the collection of water samples and the laboratory analysis of the collected water samples. Sampling will be conducted at all buildings located on the Chalmers P. Wylie VA Ambulatory Care Center campus and at Chalmers P. Wylie VA Ambulatory Care Center associated Community Based Outpatient Clinics when deemed necessary.

General Requirements:

This service is to collect water samples and analyze the collected water samples in a healthcare environment in accordance with current VHA standards, guidelines and VHA Directive 1061. The contractor will demonstrate an adequate standard of care when performing the sampling and analysis of water samples by utilizing published or enunciated, peer reviewed industry appropriate standards of practice.

All routine sampling will occur at the Chalmers P. Wylie VA Ambulatory located at 420 North James Rd., Columbus, Ohio 43219. Additionally, non-routine sampling may be required at the direction of the Chalmers P. Wylie VA Ambulatory Care Center point of contact at the following Community Based Outpatient Clinic locations:

1. Sampling Requirements

- i. The collection of samples will be performed in accordance with the protocol established by the laboratory used to analyze the samples and will be collected by person(s) trained/experienced/certified and knowledgeable of appropriate potable and non-portable water sampling standards of practice and laboratory sampling protocol. Samples will be stored and shipped in accordance with the laboratory sampling protocol.
- ii. The contractor will develop an annual schedule to include the dates and times planned to perform each quarterly sampling event. The schedule will consider all federally observed holidays. The schedule will be approved by the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
- iii. The contractor will confirm the dates and times of each quarterly sampling event with the Chalmers P. Wylie VA Ambulatory Care Center point of contact at least two weeks prior to arrival onsite.
- iv. The contractor will be accompanied by Chalmers P. Wylie VA Ambulatory Care Center staff during the course of the sampling when deemed necessary. The contractor will not deviate from the original provisions of the contract unless specifically instructed otherwise in writing by the Chalmers P. Wylie VA Ambulatory Care Center point of contact.

2. Legionella Specific Sampling and Analysis

a. Hot and Cold Potable Water Distribution System Outlet Sampling

- i. The contractor will collect water samples from outlets on each building's hot and cold water distribution system(s) and incoming municipal water supply for Legionella Test Bundle analysis (see table 2). At a minimum, samples will be collected quarterly (4 times per federal fiscal year). The quantity of samples to be collected is defined in table 1.
- ii. The contractor will develop a routine sampling plan utilizing appropriate standards of practice to accommodate a stratified, random sampling methodology to ensure that samples are representative of all water lines and outlets during each quarterly sampling event. In addition to the protocol to be used for identifying the random sampling locations, the sampling plan will include, but is not limited to the following content and will be by the Chalmers P. Wylie VA Ambulatory Care Center point of contact:
 1. The sampling plan will include a means of easily identifying each sampled location (e.g., drawing, matrix, naming convention, etc.)
 2. The sampling plan will include a means of identifying the distribution system (i.e., hot or cold) from which the sample was collected.
- iii. At the time each water sample is taken, the contractor will:
 1. Sample first draw water for all fixture samples (i.e. sinks, showers, ice machines, drinking fountains, etc.)
 2. Collect minimum sample volumes of 250 ml. All samples must be collected in sterile, screw-top bottles.

- a. Collect a minimum of 1,000 ml samples when samples are collected for the investigation of possible or definite Healthcare Acquired Legionella Disease.
3. Test and document the Potable Water Quality Test Bundle for each Legionella sample collected. The Potable Water Quality Test Bundle includes the following tests (See table 3):
 - a. Water temperature
 - b. Level of residual biocide
 - c. pH (temperature corrected).
 - These water quality parameters will be tested in the field using appropriate test instruments, properly calibrated and traceable to a NIST standard (See table 3).
 - Potable Water Quality Test Bundle sampling will be carried out in accordance with part 4 of the General Requirements section of this scope of work.
- iv. Water samples will be randomly collected from points in the water distribution systems listed in table 1 where the end user comes in contact with the water (e.g., faucets, showers, ice machines, and drinking fountains, etc.) and will be inclusive of all water lines and outlets. Samples will be collected in the quantities listed in table 1.

b. Cooling Tower System Sampling

- i. The contractor will collect water samples from the cooling tower system(s) for Legionella Test Bundle analysis (see table 2). At a minimum, samples will be collected quarterly (4 times per federal fiscal year). The quantity of samples to be collected is defined in table 1.
- ii. The contractor will develop a routine sampling plan utilizing appropriate standards of practice to accommodate an appropriate sampling methodology to ensure that samples are representative of the entire cooling tower system during each sampling event. The sampling plan will include, but is not limited to the following content and will be approved by the Chalmers P. Wylie VA Ambulatory Care Center point of contact:
 1. The sampling plan will include a means of easily identifying each sampled location (e.g., drawing, matrix, naming convention, etc.)
 2. The sampling plan will include a means of identifying the system from which the sample was collected.
- iii. At a minimum, water samples will be collected from the following points on the cooling tower system:
 1. Incoming (make-up) water supply to the cooling tower.
 2. Storage tanks or reservoirs in the system such as chilled-water return tanks or header tanks.

3. The basin or sump of the cooling tower at a location distant from the incoming make-up water.
 4. The water returning from the circulation system at the point of entry to the tower.
- iv. In addition to the quarterly sample collection identified in 2(b)(i) above, the contractor will collect weekly Cooling Tower Water Quality Test Bundle samples (52 times per federal fiscal year). Weekly Cooling Water Quality Test Bundle sampling may be reduced or eliminated over time at the discretion of the VA Point of Contact or once continuous monitoring capabilities have been implemented.
 - v. In order to prevent redundant sampling, Water samples collected during the quarterly Legionella Test Bundle sample collection event will satisfy the weekly sampling requirement for that period.
 - vi. Routine Legionella samples will be collected in the quantities, frequencies and locations established in table 1 unless otherwise directed by the Chalmers P. Wylie VA Ambulatory Care Center point of contact.

c. Legionella Sample Analysis

- i. Once collected, that contractor will have the samples processed by a testing laboratory with experience in microbial testing of potable and non-potable water.
 1. Analysis of water samples will be performed by a laboratory currently certified by the Centers for Disease Control and Prevention (CDC) Environmental Legionella Isolation Techniques Evaluation (ELITE) program as proficient at performing the culture of Legionella from environmental samples. Information about ELITE certified laboratories can be found at <https://wwwn.cdc.gov/elite/Public/MemberList.aspx>.
 2. In addition to the requirement for current CDC ELITE certification, the laboratory performing the analysis of water samples will have an environmental microbiology accreditation by a nationally recognized accrediting body (e.g., A2LA, NELAP).
 3. The laboratory used to analyze Legionella samples must not have a limit of detection higher than 10 CFU/ml.
 4. The laboratory will analyze each water sample for Legionella by performing the tests listed in the Legionella Test Bundle identified in table 2. The laboratory will have the capabilities of determining if the Legionella pneumophila is serogroup 1, serogroup 2-14, and *Legionella species*.
 5. When appropriate, the laboratory will concentrate water samples prior to plating the samples on selective media to increase the sensitivity of the assay.
 6. The laboratory will neutralize biocides, via the collection containers, that have been added to the building's potable water distribution systems prior to analysis.
 7. The contractor will follow certified laboratory guidance regarding sample collection, handling, storage and transport.
 8. Rapid testing methods, such as polymerase chain reaction (PCR) and direct fluorescent antibody (DFA), can only be utilized if combined with a culture method.

9. When directed by the Chalmers P. Wylie VA Ambulatory Care Center point of contact, the contractor must provide Legionella Test Bundle analysis results within 3 calendar days (48-72 hours for culture growth and 1 day for handling).

d. Legionella Analysis Reports

- i. Once analyzed, the laboratory will prepare and submit an analysis report to the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
 1. The analysis report will include an enumeration of Legionella concentrations for each result above the quantification limit.
 2. The analysis report will include the serogroup for all results determined to be above the quantification limit.
 3. All quantifiable/enumerated results will be reported in CFU/ml. All results determined to be below the quantification limit will be reported as “ND” (i.e., Non-Detected) or “Negative”.
 4. Analysis reports will be submitted via email and hard copy to the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
 5. Legionella Test Bundle results will be reported within 14 calendar days (10 days for culture growth and 4 days for shipping, handling, weekends, etc.).
 - a. In the event of positive ISO 11731 method cultures, the Chalmers P. Wylie VA Ambulatory Care Center may choose to require that the contractor use a culture method that will provide Legionella Test Bundle analysis results within 3 calendar days (48-72 hours for culture growth and 1 day for handling).
 6. The laboratory will have the capability to provide access to all sampling reports and supporting data through an internet-based tool at all times.

3. Heterotrophic Plate Count Specific Sampling and Analysis

a. Dental Water Line Sampling

- i. The contractor will collect water samples from Dental Service water lines for Heterotrophic Plate Count analysis. At a minimum, samples will be collected quarterly (4 times per federal fiscal year). The quantity of samples to be collected is defined in table 1.
- ii. The contractor will develop a routine sampling plan utilizing appropriate standards of practice to accommodate a sampling methodology to ensure that samples are representative of all water lines and outlets during each quarterly sampling event. The sampling plan will be consistent with the Chalmers P. Wylie VA Ambulatory Care Center Dental Service Waterline Testing and Treatment Standard Operating Procedure.
 1. Dental Water Line sampling requires the manipulation of instruments and equipment. Special instructions or assistance from Chalmers P. Wylie VA Ambulatory Care Center will be necessary to collect the samples appropriately and safely and in order to prevent damage to equipment.
- iii. In addition to the protocol to be used for identifying the sampling locations, the sampling plan will include, but is not limited to the following content and will be approved by the Chalmers P. Wylie VA Ambulatory Care Center point of contact:
 1. The sampling plan will include a means of easily identifying each sampled location (e.g., drawing, matrix, naming convention, etc.)
 2. The sampling plan will include a means of identifying the system from which the sample was collected.
- iv. Samples will be collected in the quantities listed in table 1 and as defined in the Chalmers P. Wylie VA Ambulatory Care Center Dental Service Waterline Testing and Treatment Standard Operating Procedure and other guidelines as appropriate.

b. Heterotrophic Plate Count Sample Analysis

- ii. Once collected, that contractor will have the samples processed by a testing laboratory with experience in microbial testing of potable and non-potable water.
 1. Analysis of water samples will be performed by a laboratory currently certified by the Environmental Protection Agency (EPA) to perform microbiological analysis of public drinking water. The laboratory will be proficient at performing the analysis of Heterotrophic Plate Count (HPC) using EPA/ELAP method SM 9215B from environmental samples.
 - a. The VHA is currently working to secure a national contract for analysis of Dental Water for Heterotrophic Plate Count. Once the national contract is in place the vendor must submit all Dental samples to the VHA contracted laboratory for analysis.

2. In addition to the requirement for current Ohio EPA certification, the laboratory performing the analysis of water samples will have an environmental microbiology accreditation by a nationally recognized accrediting body (e.g., A2LA, NELAP).
3. The laboratory will analyze each water sample for Heterotrophic Plate Count (HPC) using EPA/ELAP method SM 9215B.

c. Heterotrophic Plate Count Analysis Reports

- i. Once analyzed, the laboratory will prepare and submit an analysis report to the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
 7. The analysis report will include an enumeration of Heterotrophic Plate Count concentrations for each result above the quantification limit.
 8. All quantifiable/enumerated results will be reported in CFU/ml. All results determined to be below the quantification limit will be reported as “ND” (i.e. Non Detected) or “Negative”.
 9. All results will be compared against the action levels listed in the Chalmers P. Wylie VA Ambulatory Care Center Dental Service Waterline Testing and Treatment Standard Operating Procedure and identify the appropriate corrective actions. All sample results exceeding the defined action levels will be conspicuously identified in the analysis report.
 10. Analysis reports will be submitted via email and hard copy to the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
 11. The laboratory will have the capability to provide access to all sampling reports and supporting data through an internet-based tool at all times.
 12. Heterotrophic Plate Count analysis results will be reported within 3 days (48-72 hours for culture growth and 1 day for handling).
 13. The laboratory will have the capability to provide access to all sampling reports and supporting data through an internet-based tool at all times.

4. Water Quality Sampling and Analysis

a. Potable Water Quality Test Bundle Sampling

- i. The contractor will collect water samples from outlets on each building's hot and cold water distribution system(s) and incoming municipal water supply for Potable Water Quality Test Bundle analysis (See table 3). At a minimum, samples will be collected quarterly (4 times per federal fiscal year). The quantity of samples to be collected is defined in table 1.
 1. Quarterly Potable Water Quality Test Bundle samples will be performed in conjunction with the Legionella Test Bundle sample collection identified in part 2(a)(iii) of the General Requirements section of this scope of work and table 1.
- ii. In addition to the quarterly sample collection identified in 4(a)(i) above, the contractor will collect weekly Potable Water Quality Test Bundle samples (52 times per federal fiscal year). Weekly Potable Water Quality Test Bundle sampling may be reduced or eliminated over time at the discretion of the VA Point of Contact or once continuous monitoring capabilities have been implemented.
 1. In order to prevent redundant sampling, Water samples collected during the quarterly Legionella Test Bundle sample collection event will satisfy the weekly sampling requirement for that period.
- iii. Total Dissolved Solids (TSD) samples will be collected from the incoming municipal water supply only and are not required to be collected from the hot and cold water distribution outlets.
- iv. Samples will be collected in the quantities, frequencies and locations established in table 1 unless otherwise directed by the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
- v. The contractor will develop a routine sampling plan utilizing appropriate standards of practice to accommodate an appropriate sampling methodology to ensure that samples are representative of incoming supply of potable water during each sampling event. The sampling plan will include, but is not limited to the following content and will be approved by the Chalmers P. Wylie VA Ambulatory Care Center point of contact:
 1. The sampling plan will include a means of easily identifying the sampled location (e.g., drawing, matrix, naming convention, etc.)
 2. The sampling plan will include a means of identifying the distribution system (i.e., hot or cold) from which the sample was collected.

b. Water Quality Sample Analysis

- iii. Once collected, that contractor will have the samples processed by a testing laboratory with experience in testing of potable and non-potable water.
 1. Analysis of water samples will be performed by a laboratory currently certified by the Environmental Protection Agency (EPA) to perform

microbiological analysis of public drinking water. The laboratory will be proficient at performing the water quality test methods listed in table 3.

2. In addition to the requirement for current EPA certification, the laboratory performing the analysis of water samples will have an environmental microbiology accreditation by a nationally recognized accrediting body (e.g., A2LA, NELAP).
3. The laboratory will analyze each water sample for the oxidant residual, total dissolved solids, temperature, and pH (temperature corrected) using the approved test methods listed in table 3.
- iv. Alternatively, total dissolved solids, oxidant residual, temperature, and pH (temperature corrected) may be tested in the field using appropriate direct read test instruments, properly calibrated and traceable to a NIST standard (See table. 3).
 1. Field instruments used in accordance with EPA equivalent/approved sampling methods (i.e., Hach Method 8021 – *Chlorine, Free, DPD Method (2.00 mg/L)*) must also be properly calibrated and traceable to a NIST standard when appropriate.

c. Water Quality Analysis Reports

- ii. Once analyzed, the laboratory will prepare and submit an analysis report to the Chalmers P. Wylie VA Ambulatory Care Center point of contact.
14. The analysis report will include an enumeration of water quality concentrations for each result above the quantification limit.
15. All quantifiable/enumerated results will be reported in the following units:

19. The laboratory will have the capability to provide access to all sampling reports and supporting data through an internet-based tool at all times.

- i. Laboratories used to perform analysis of all samples mentioned in this SOW must submit copies of current accreditation/registration/certification certificates to the Chalmers P. Wylie VA Ambulatory Care Center point of contact prior to initial sample analysis. Uncertified or unaccredited laboratories will not be used to satisfy the terms of this contract at any time.
- ii. The contractor will routinely validate that the laboratory continues to maintain a current CDC Environmental Legionella Isolation Techniques Evaluation (ELITE) program certification, EPA Microbial Analysis of Potable Water certification and current accreditations from the American Association of Laboratory Accreditation (A2LA), the National Environmental Laboratory Accreditation Program (NELAP) or other nationally recognized laboratory accrediting body.

- iv. Laboratories used to perform analysis of all samples mentioned in this SOW will submit current copies of laboratory sampling, sample transport guidelines, sample storage guidelines, sample analysis guidelines and quality control guidelines for all sampling and analysis performed under this contract. Revised guidelines must be submitted to the Chalmers P. Wylie VA Ambulatory Care Center point of contact upon publication.
 - a. Alternatively, the laboratory may make current copies of all guidelines available online for continuous review by the Chalmers P. Wylie VA Ambulatory Care Center.

Working Hours:

Working hours for the contractor will normally be between the hours of 8:00 a.m. and 4:30 p.m. during the week (Monday - Friday). If the contractor desires to work during periods other than these, approval will be obtained from the Contracting Officer (CO) two weeks (10 working days) in advance to allow assignment of additional inspection forces if they are reasonably available.

Cleanup:

The Contractor will bag and dispose of all waste materials generated during the course of the water sampling of off-facility in accordance with Federal, State, and local regulations and in a manner to prevent spillage.

Security:

The contractor will follow all established facility security protocol while on-site.

Notice to Proceed:

The Contracting Officer will issue Notice to Proceed after Government approval of the Submittal and the Work Schedule.

(i) Government personnel and authorized users performing business on behalf of the Government; or

(ii) The Contractor, when viewing data on itself; and

(2) The publicly-available segment, to which all data in the non-public segment of FAPIS is automatically transferred after a waiting period of 14 calendar days, except for—

(i) Past performance reviews required by subpart 42.15;

(ii) Information that was entered prior to April 15, 2011; or

(iii) Information that is withdrawn during the 14-calendar-day waiting period by the Government official who posted it in accordance with paragraph (c)(1) of this clause.

(c) The Contractor will receive notification when the Government posts new information to the Contractor's record.

(1) If the Contractor asserts in writing within 7 calendar days, to the Government official who posted the information, that some of the information posted to the nonpublic segment of FAPIS is covered by a disclosure exemption under the Freedom of Information Act, the Government official who posted the information must within 7 calendar days remove the posting from FAPIS and resolve the issue in accordance with agency Freedom of Information procedures, prior to reposting the releasable information. The contractor must cite 52.209-9 and request removal within 7 calendar days of the posting to FAPIS.

(2) The Contractor will also have an opportunity to post comments regarding information that has been posted by the Government. The comments will be retained as long as the associated information is retained, i.e., for a total period of 6 years. Contractor comments will remain a part of the record unless the Contractor revises them.

C.2 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (MAY 2015)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

(1) Within a reasonable time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) *Invoice.*

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, contract line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) *Payment.*—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected contract line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government

for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title*. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability*. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances*. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts*. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence*. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

(1) The schedule of supplies/services.

(2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;

(3) The clause at 52.212-5.

(4) Addenda to this solicitation or contract, including any license agreements for computer software.

(5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) *System for Award Management (SAM)*.

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to

review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) Unauthorized Obligations.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor's representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

(e)(1) Notwithstanding the requirements of the clauses in paragraphs (a), (b), (c), and (d) of this clause, the Contractor is not required to flow down any FAR clause, other than those in this paragraph (e)(1) in a subcontract for commercial items. Unless otherwise indicated below, the extent of the flow down shall be as required by the clause—

(B) Alternate I (MAR 2015) of 52.222-50 (22 U.S.C. chapter 78 and E.O. 13627).

(xii) 52.222-51, Exemption from Application of the Service Contract Labor Standards to Contracts for Maintenance, Calibration, or Repair of Certain Equipment—Requirements (MAY 2014) (41 U.S.C. chapter 67).

(xiii) 52.222-53, Exemption from Application of the Service Contract Labor Standards to Contracts for Certain Services—Requirements (MAY 2014) (41 U.S.C. chapter 67).

(2) While not required, the contractor may include in its subcontracts for commercial items a minimal number of additional clauses necessary to satisfy its contractual obligations.

C.4 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within THIRTY DAYS.

C.5 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within THIRTY DAYS; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least SIXTY DAYS days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed SIXTY SIX MONTHS.

C.6 52.228-5 INSURANCE—WORK ON A GOVERNMENT INSTALLATION (JAN 1997)

(a) The Contractor shall, at its own expense, provide and maintain during the entire performance of this contract, at least the kinds and minimum amounts of insurance required in the Schedule or elsewhere in the contract.

(b) Before commencing work under this contract, the Contractor shall notify the Contracting Officer in writing that the required insurance has been obtained. The policies evidencing required insurance shall

contain an endorsement to the effect that any cancellation or any material change adversely affecting the Government's interest shall not be effective—

(1) For such period as the laws of the State in which this contract is to be performed prescribe; or

(2) Until 30 days after the insurer or the Contractor gives written notice to the Contracting Officer, whichever period is longer.

(c) The Contractor shall insert the substance of this clause, including this paragraph (c), in subcontracts under this contract that require work on a Government installation and shall require subcontractors to provide and maintain the insurance required in the Schedule or elsewhere in the contract. The Contractor shall maintain a copy of all subcontractors' proofs of required insurance, and shall make copies available to the Contracting Officer upon request.

(End of Clause)

C.7 SUPPLEMENTAL INSURANCE REQUIREMENTS

In accordance with FAR 28.307-2 and FAR 52.228-5, the following minimum coverage shall apply to this contract:

(a) Workers' compensation and employers liability: Contractors are required to comply with applicable Federal and State workers' compensation and occupational disease statutes. If occupational diseases are not compensable under those statutes, they shall be covered under the employer's liability section of the insurance policy, except when contract operations are so commingled with a Contractor's commercial operations that it would not be practical to require this coverage. Employer's liability coverage of at least \$100,000 is required, except in States with exclusive or monopolistic funds that do not permit workers' compensation to be written by private carriers.

(b) General Liability: \$500,000.00 per occurrences.

(c) Automobile liability: \$200,000.00 per person; \$500,000.00 per occurrence and \$20,000.00 property damage.

(d) The successful bidder must present to the Contracting Officer, prior to award, evidence of general liability insurance without any exclusionary clauses for asbestos that would void the general liability coverage.

C.8 52.232-34 PAYMENT BY ELECTRONIC FUNDS TRANSFER—OTHER THAN SYSTEM FOR AWARD MANAGEMENT (JUL 2013)

(a) Method of payment. (1) All payments by the Government under this contract shall be made by electronic funds transfer (EFT) except as provided in paragraph (a)(2) of this clause. As used in this clause, the term "EFT" refers to the funds transfer and may also include the payment information transfer.

(2) In the event the Government is unable to release one or more payments by EFT, the Contractor agrees to either—

(i) Accept payment by check or some other mutually agreeable method of payment; or

(ii) Request the Government to extend payment due dates until such time as the Government makes payment by EFT (but see paragraph (d) of this clause).

(b) Mandatory submission of Contractor's EFT information. (1) The Contractor is required to provide the Government with the information required to make payment by EFT (see paragraph (j) of this clause). The Contractor shall provide this information directly to the office designated in this contract to receive that information (hereafter: "designated office") by SAM AND AUSTIN FINANCIAL MANAGEMENT SYSTEM. If not otherwise specified in this contract, the payment office is the designated office for receipt of the Contractor's EFT information. If more than one designated office is named for the contract, the Contractor shall provide a separate notice to each office. In the event that the EFT information changes, the Contractor shall be responsible for providing the updated information to the designated office(s).

(2) If the Contractor provides EFT information applicable to multiple contracts, the Contractor shall specifically state the applicability of this EFT information in terms acceptable to the designated office. However, EFT information supplied to a designated office shall be applicable only to contracts that identify that designated office as the office to receive EFT information for that contract.

(c) *Mechanisms for EFT payment.* The Government may make payment by EFT through either the Automated Clearing House (ACH) network, subject to the rules of the National Automated Clearing House Association, or the Fedwire Transfer System. The rules governing Federal payments through the ACH are contained in 31 CFR part 210.

(d) Suspension of payment. (1) The Government is not required to make any payment under this contract until after receipt, by the designated office, of the correct EFT payment information from the Contractor. Until receipt of the correct EFT information, any invoice or contract financing request shall be deemed not to be a proper invoice for the purpose of prompt payment under this contract. The prompt payment terms of the contract regarding notice of an improper invoice and delays in accrual of interest penalties apply.

(2) If the EFT information changes after submission of correct EFT information, the Government shall begin using the changed EFT information no later than 30 days after its receipt by the designated office to the extent payment is made by EFT. However, the Contractor may request that no further payments be made until the updated EFT information is implemented by the payment office. If such suspension would result in a late payment under the prompt payment terms of this contract, the Contractor's request for suspension shall extend the due date for payment by the number of days of the suspension.

(e) Liability for uncompleted or erroneous transfers. (1) If an uncompleted or erroneous transfer occurs because the Government used the Contractor's EFT information incorrectly, the Government remains responsible for—

(i) Making a correct payment;

(ii) Paying any prompt payment penalty due; and

(iii) Recovering any erroneously directed funds.

(2) If an uncompleted or erroneous transfer occurs because the Contractor's EFT information was incorrect, or was revised within 30 days of Government release of the EFT payment transaction instruction to the Federal Reserve System, and—

(i) If the funds are no longer under the control of the payment office, the Government is deemed to have made payment and the Contractor is responsible for recovery of any erroneously directed funds; or

(ii) If the funds remain under the control of the payment office, the Government shall not make payment and the provisions of paragraph (d) shall apply.

(f) *EFT and prompt payment.* A payment shall be deemed to have been made in a timely manner in accordance with the prompt payment terms of this contract if, in the EFT payment transaction instruction released to the Federal Reserve System, the date specified for settlement of the payment is on or before the prompt payment due date, provided the specified payment date is a valid date under the rules of the Federal Reserve System.

(g) *EFT and assignment of claims.* If the Contractor assigns the proceeds of this contract as provided for in the assignment of claims terms of this contract, the Contractor shall require as a condition of any such assignment, that the assignee shall provide the EFT information required by paragraph (j) of this clause to the designated office, and shall be paid by EFT in accordance with the terms of this clause. In all respects, the requirements of this clause shall apply to the assignee as if it were the Contractor. EFT information that shows the ultimate recipient of the transfer to be other than the Contractor, in the absence of a proper assignment of claims acceptable to the Government, is incorrect EFT information within the meaning of paragraph (d) of this clause.

(h) *Liability for change of EFT information by financial agent.* The Government is not liable for errors resulting from changes to EFT information provided by the Contractor's financial agent.

(i) *Payment information.* The payment or disbursing office shall forward to the Contractor available payment information that is suitable for transmission as of the date of release of the EFT instruction to the Federal Reserve System. The Government may request the Contractor to designate a desired format and method(s) for delivery of payment information from a list of formats and methods the payment office is capable of executing. However, the Government does not guarantee that any particular format or method of delivery is available at any particular payment office and retains the latitude to use the format and delivery method most convenient to the Government. If the Government makes payment by check in accordance with paragraph (a) of this clause, the Government shall mail the payment information to the remittance address in the contract.

(j) *EFT information.* The Contractor shall provide the following information to the designated office. The Contractor may supply this data for this or multiple contracts (see paragraph (b) of this clause). The Contractor shall designate a single financial agent per contract capable of receiving and processing the EFT information using the EFT methods described in paragraph (c) of this clause.

(1) The contract number (or other procurement identification number).

(2) The Contractor's name and remittance address, as stated in the contract(s).

(3) The signature (manual or electronic, as appropriate), title, and telephone number of the Contractor official authorized to provide this information.

(4) The name, address, and 9-digit Routing Transit Number of the Contractor's financial agent.

(5) The Contractor's account number and the type of account (checking, saving, or lockbox).

(6) If applicable, the Fedwire Transfer System telegraphic abbreviation of the Contractor's financial agent.

(7) If applicable, the Contractor shall also provide the name, address, telegraphic abbreviation, and 9-digit Routing Transit Number of the correspondent financial institution receiving the wire transfer payment if the Contractor's financial agent is not directly on-line to the Fedwire Transfer System; and, therefore, not the receiver of the wire transfer payment.

SECTION E - SOLICITATION PROVISIONS

E.1 52.209-7 INFORMATION REGARDING RESPONSIBILITY MATTERS (JUL 2013)

(b) The offeror [] has [] does not have current active Federal contracts and grants with total value greater than \$10,000,000.

(c) If the offeror checked "has" in paragraph (b) of this provision, the offeror represents, by submission of this offer, that the information it has entered in the Federal Awardee Performance and Integrity Information System (FAPIS) is current, accurate, and complete as of the date of submission of this offer with regard to the following information:

(1) Whether the offeror, and/or any of its principals, has or has not, within the last five years, in connection with the award to or performance by the offeror of a Federal contract or grant, been the subject of a proceeding, at the Federal or State level that resulted in any of the following dispositions:

- (i) In a criminal proceeding, a conviction.
- (ii) In a civil proceeding, a finding of fault and liability that results in the payment of a monetary fine, penalty, reimbursement, restitution, or damages of \$5,000 or more.
- (iii) In an administrative proceeding, a finding of fault and liability that results in—
 - (A) The payment of a monetary fine or penalty of \$5,000 or more; or
 - (B) The payment of a reimbursement, restitution, or damages in excess of \$100,000.

(iv) In a criminal, civil, or administrative proceeding, a disposition of the matter by consent or compromise with an acknowledgment of fault by the Contractor if the proceeding could have led to any of the outcomes specified in paragraphs (c)(1)(i), (c)(1)(ii), or (c)(1)(iii) of this provision.

(2) If the offeror has been involved in the last five years in any of the occurrences listed in (c)(1) of this provision, whether the offeror has provided the requested information with regard to each occurrence.

(d) The offeror shall post the information in paragraphs (c)(1)(i) through (c)(1)(iv) of this provision in FAPIIS as required through maintaining an active registration in the System for Award Management database via <https://www.acquisition.gov> (see 52.204-7).

E.2 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (APR 2014)

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). - (5) Terms of any express warranty;
- (6) Price and any discount terms;
- (7) "Remit to" address, if different than mailing address;
- (8) A completed copy of the representations and certifications at FAR 52.212-3 (see FAR 52.212-3(b) for those representations and certifications that the offeror shall complete electronically);
- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required

representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions or commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

(3) Acceptable evidence to establish the time of receipt at the Government installation includes the time/date stamp of that installation on the offer wrapper, other documentary evidence of receipt maintained by the installation, or oral testimony or statements of Government personnel.

(c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.
