## B.3 Statement of Work

### **Scope of Work**

#### **Background**

The 1201085701X - Constellation XLT Vision System is an ophthalmic microsurgical system that is indicated for both anterior segment (i.e., phacoemulsification and removal of cataracts) and posterior segment (i.e., vitreoretinal) ophthalmic surgery.

#### **Summary**

The full service contract will cover repair, exchange, labor, and maintenance on each unit, plus needed repairs during the term of the contract, excluding misuse or abuse of the scope. Replacement parts will be furnished on an exchange basis at Contractor's expense and will be a new part or reconditioned part equivalent to new. Replaced parts become the property of the contractor.

#### **Scope of Work**

##### **A. Preventative Maintenance**

Contractor is to identify the amount of scheduled visits required to maintain equipment functioning at manufacturer's recommendations. These scheduled services shall be arranged with the designated VA representative. The preventative maintenance visit will include a system verification of the equipment by a trained technician. Any identified work should be completed at this time and at no cost to the VA

##### **B. VA Requested Services**

Under the term of this contract, the Contractor shall perform requested service calls during the VA set working hours of 8:00 am to 4:30 pm. Any work scheduled out of the set working hours shall be billed separately. ***This will not occur without prior authorization of the Contracting Officer.***

##### **C. Parts and Labor**

Contractor is to provide all labor, parts, and material.

##### **D. Call Center**

Contractor is to be available via phone access 24 hours a day and 7 days a week. This service is to be included in cost.

##### **E. Additional Services**

Contractor is to provide a list of other services that may be rendered not noted within requirement that may assist or enhance the services of this potential requirement.

## SECTION C - CONTRACT CLAUSES

## **SECTION E - SOLICITATION PROVISIONS**

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
