**(2) NATURE AND/OR DESCRIPTION OF ACTION BEING APPROVED:**  
A Limited Source Justification to provide specialized laboratory reagents, supplies, and equipment needed for patient testing for FY16. Service and maintenance are also a part of the Cost Per Reportable Test Contract# V797P-7090A. This is a VA National Acquisition Center contract. At this time this contract is active through April 16, 2016 with an anticipated renewal prior to that date. The period of performance for the requirement being considered by this Limited Source Justification is October 1, 2015 through September 30, 2016. These items are found on Schedule 66 (III) of the VA National Acquisition Center's catalog and are therefore require mandatory consideration by VA medical centers. The pricing model for this requirement has been established by the VA National Acquisition Center. Total annual cost is estimated based on price per test and historical volume. There are numerous test types in the catalog, and all are priced separately. The government is invoiced only for the tests used.

**(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:**  
Beckman Coulter, Inc. is the current vendor that provides our DxC880i chemistry analyzers, Contract# V797P-7090A. Chemistry testing for veteran patients includes chemistry profiles, lipid profiles, metabolic profiles, cardiac markers, tumor makers, etc. This contract includes the use of the DxC880i chemistry analyzer, reagents, calibrators, controls, supplies, consumables, and maintenance and service

The FSS contract# V797P-7090a includes the use of the DxC880i chemistry analyzer, reagents, supplies, consumables/disposables, calibrators, standards, controls, plus maintenance and service coverage. The reagents and supplies used are unique to the Beckman Coulter DxC880i chemistry analyzer. Beckman Coulter Inc. is an excellent company that has been in the chemistry analyzer business for decades. The equipment in question is currently in use at the facility. Installation of such equipment is labor intensive, time consuming and often requires modification of laboratory space.

To change vendors requires several months of work that includes interface connections, correlation studies between new and old analyzers and between analyzers, analytical measurement range studies, linearity studies, assay sensitivity studies, precision studies, reference range validation studies, etc. Both the outgoing and incoming equipment must be run in parallel at the same time, on each sample to ensure corresponding results – this is very costly.

New instruments, especially new vendors, include new training in the operation and analysis of specimens, maintenance procedures, troubleshooting procedures, recoding of instruments and tests associated with the College of American Pathologist (CAP) proficiency programs, and writing of new procedures. Quality control programs for new immunoassay analyzer vendors require new processes to be set up to meet various accreditation agencies requirements; The Joint Commission, CAP, Clinical Laboratory Improvement Amendments (CLIA), etc. All of the above requirements and tasks involve significant cost for various test kits to perform these studies. Additionally, the months of medical technologist labor to perform the above studies is significant. No analyzer can be placed "on-line" until all validation studies, instrument training, and procedure manuals have been written, reviewed, and approved. Every time a new piece of instrumentation enters the laboratory all precautions are taken to provide the necessary training on the analyzers to prevent delay in testing and operator errors that could lead to erroneous results. New instrumentation and new vendors increase the odds of errors due to learning the new system. In summary, the cost associated with changing laboratory equipment and processes is very high and only becomes advantageous when the market offers a solution with clearly defined cost savings at the per-test level. At this time cost savings are not a likely outcome of further competition, even if other sources could meet the need.

Beckman Coulter, Inc. equipment is currently installed in our laboratory. Several months are required to execute a competitive procurement and several more months are required to transition from one vendor to another. The transition process is time consuming, requires at least thirty (30) days of parallel testing and would involve notable cost.

**(5) DESCRIBE WHY YOU BELIEVE THE ORDER REPRESENTS THE BEST VALUE CONSISTENT WITH FAR 8.4 TO AID THE CONTRACTING OFFICER IN MAKING THIS BEST VALUE DETERMINATION:**

In accordance with 8.404 (d), GSA and the VA National Acquisition Center [FSS] has already determined the prices of supplies, fixed-price services, and rates for services offered at hourly rates, under schedule contracts to be fair and reasonable. High complexity laboratory analyzers represent the state-of-the-art in medical technology and provide little relative comparison for determining price reasonableness. It is for this reason that the VA NAC center conducts price reasonable activities for the VA community.

Market research is an ongoing process. VA Ann Arbor Laboratory staff reviewed offerings from several available sources. Due to the nature of high tech laboratory equipment the pool of possible contractors is limited to the few conducting relevant research and development in these areas. The sources included in the market research are Beckman Coulter DxC880i, Siemens Vista, and Ortho Clinical Diagnosis Fusion. VA Ann Arbor laboratory staff concluded that the Beckman Coulter DxC880i chemistry analyzer is the only vendor that provides the closed-tube sampling system, offers the best value regarding quality of results and test menu, turnaround time, and maintenance. The Beckman Coulter reagents and supplies are unique to the Beckman Coulter DxC880i systems. After market research was conducted, Beckman Coulter was determined the only contractor that could practicably meet the needs of the laboratory. Initially selected in 2011, Beckman Coulter is the only vendor that provides a vast test menu, ease of operation, and high throughput of patient test results for its value.

**(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:**

Market research is a continuous process to evaluate other vendors on the FSS that offer chemistry/immunochemistry platforms. Market research consisted of site visits, FSS and GSA searches, as well as internet searches. At the time of market research, other sources could not provide the specific requirements requested for a chemistry/immunochemistry platform. Laboratory staff engage industry on a regular basis to determine if the needs of the VA can be better met by emerging or recently established technology.

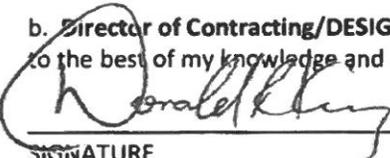
