

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW FAR 13.106-1
(OVER MICRO-PURCHASE THRESHOLD(\$3K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. 3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The GeneXpert is only compatible with the Cepheid cartridges. Currently, the department uses the GeneXpert which calls for these specific cartridges. Some characteristics on this system are as follows: The sample process is fully automated and integrated with an automated real-time PCR system. Contributes to ease of use, productivity, reproducibility and reduced turn-around time, simplicity and ease of use for true employability and sustainability. Batching is not required to achieve either operational efficiency or cost savings. Allows true 24/7 results; random access capability; and a closed system. Does not require separately processed controls with each run. Utilizes primarily freeze dried reagent technology vs. liquid reagents.

4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:

Cepheid is the only distributor for these reagents at this time.
