

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW FAR 13.106-1
(OVER MICRO-PURCHASE THRESHOLD(\$3K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). 2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

LEC services for various Region 1 locations (Portland, Boise, Walla Walla, Seattle, Spokane, and Roseburg) covered under the Satcom Direct Footprint

3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The sole source for this action is with Satcom Direct Communications. Based on extensive market research, it is determined that Satcom Direct remains the only responsible source capable of providing this service to the VA. No other contractor can provide the required service due to access to the proprietary technical data within the existing Region 1 infrastructure. Only Satcom Direct possesses the necessary Satellite Communications circuitry for the existing Region 1 infrastructure in these service locations. This would involve a transition period of up to 120 days for each change in service provider, due to a new service provider installing all new equipment, cabling, and circuits. This would cause harm and impact to Region 1 locations as a result of the disruption of service.

4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:

Failure to access the Satcom Direct systems infrastructure and disruption of service would result in no Emergency Satellite communication (phones). Only Satcom Direct Communications, due to proprietary technical data within Region 1, can provide these services within these locations. Not having Emergency Satellite communication would violate the VA's Emergency protocols for maintaining emergency communications when LEC services fail.

5. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

Any Other Facts Supporting the Restriction of Competition:

This is a follow-on contract to an existing contract (VA260-15-J-4884) to provide mandatory LEC (Emergency Communication) services for Region 1 locations. Market research determined this service is commercial in nature; however, see Paragraph 3 as to rationale for the sole source determination.
