

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW FAR 13.106-1
(OVER MICRO-PURCHASE THRESHOLD(\$3K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). 2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

LEC (Voice) Services for various Region 1 Alaska facilities. These are covered under the Alaska Communications footprint. This is a 3-month bridge contract until the TAC can execute the new requirement.

3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The source for this action is with Alaska Communications Systems Communications. Based on extensive market research, it is determined that currently Alaska Communications Systems remains the only responsible source capable of providing services to the VA. No other contractor can provide the required services because they do not have access to the proprietary technical data within the existing Region 1 infrastructure. Only Alaska Communications Systems possesses the necessary proprietary LEC circuitry for the existing Region 1 infrastructure. VA does not own the proprietary LEC outside plant. Any other source would require access to the current proprietary infrastructure in order to provide the current LEC services. If this action was competed, it could potentially create two moves to two different service providers in one year. This would involve a transition period of up to 120 days for each change in service provider, due to a new service provider installing all new equipment, cabling, and circuits. This would cause a significant disruption of services.

4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:


Failure to access the Alaska infrastructure coupled with disruptions of service would result in significant harm (no phones, no access to data and records, and ultimate harm to patient care).

5. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

This is a follow-on contract to an existing contract (VA260-15-P-0226) to provide mandatory LEC services for Region 1 locations. Market research determined this service is commercial in nature; however, see Paragraph 3 as to rationale for sole source determination.
