1. Addendum to SF 1442, Block 10,

The organized site visit for October 22, 2015 at 9:00 am shall be rescheduled for October 27, 2015 at 9:00 am and begin at the Facilities Management Conference room in Building 3132. We shall go over the Scope and conduct an escorted walk of the areas included in the project. This site walk shall be conducted rain or shine, so be prepared for inclement weather. Please arrive early as parking may be a challenge.

2. Additional Site Visit requests IAW 52.236-27 SITE VISIT (CONSTRUCTION)

Site Visit requests shall be for site investigation only. These visits must be requested with a minimum of 48 hours' notice, and will be provided an escort only to the extent as necessary to provide access to restricted areas. During these visits any probative questions that are asked and answered shall be published to all offeror via amendment to the solicitation; the preferred method for RFIs being the proscribed method described in block 10 of the 1442.

3. Addendum to Section 4.1 Scope of Work, Section III, SCHEDULING, PHASING, AND WORKING HOURS

W.H.E.N. Hours shall be defined as follows

A. **W.H.E.N** (Weekends, holidays, evenings and nights) hours. For the purposes of this requirement

1. Evening's hours are defined as 5.PM to 12 AM.
2. Nights 12:00 AM to 6 AM.
3. Weekends: Saturday-Sunday.

4. Revision to Proposal Preparation and Evaluation Information, Evaluation Factor 4

The following section shall be removed from Evaluation Factor 4: Technical qualifications

“(4)Submit copy of current, valid Architect’s License issued by any United States federal, state, or local government agency for Architectural Contractor, who will be of record.”

Offerors shall not be required to submit a valid architect’s license as the Architectural Contractor of Record has been retained under a separate contract.

5. RFI answers

RFI #1 Concerning Factor 4 – Technical Qualifications (pg 8 of 649). Requirements include submission of (3) a valid General Contractor License and (4) a valid Architects License. Do these licenses have to be from the offeror (the Prime) or can they be from a subcontractor that will work for the Prime?

- **The licenses can be from which ever firm will be the contractor of record. This can be the Prime Contractor, or the Sub-contractor. Architect License is no longer a requirement. See item 4 of this Amendment.**

RFI #2 It is stated that 120 days are allowed for the construction duration from NTP. The metal building will take 10 - 12 weeks for fabrication ONLY. Will the VA consider extending the duration or will the submittals be reviewed prior to the NTP execution?

- **Block 11 of the 1442 shows that the 120 days is negotiable. Evaluation Factor 3 is Schedule. The schedule submitted with your proposal should be fully supported by your technical approach and satisfying the requirements of this project. Contractors shall be held to the timeline submitted with their proposal.**
