

VISN 23 has a requirement for Automated High Maintenance/High Complexity Clinical Chemistry and Immunochemistry (schedule 66 III, category 605-6a and 605-1a). The desired instrumentation shall have the capability of performing testing that meets the performance characteristics for accuracy and precision as defined by the 1988 Clinical Laboratory Improvement Act (CLIA) and the Clinical and Laboratory Standards Institute (CLSI).

- b. An estimate of lab volumes.
- c. An LIM Fileman or similar report of test workflow.
- d. Onsite observation.
