2. Site Visit

The Government will conduct a site visit during the solicitation period for this requirement on December 3, 2015 at 8:30 am at the Lake Nona VA Medical Facility, at 13800 Veterans Way, Orlando, FL 32827. The purpose of the site visit is to provide an opportunity for interested Offerors to ask questions, view the facilities, and for the Government to explain or clarify specifications and requirements.

All interested firms may attend with a limit of two (2) attendees per firm. Please submit, in writing, the names and organization of attendees as well as the date which your organization will attend to the Contracting Officer, Edwin Roldan via email at edwin.roldan@va.gov no later than 10:00 AM EDT on November 30, 2015. The names provided will be used to admit personnel to the Lake Nona Medical Facility and for solicitation site visit.

All questions derived from the site visit shall be submitted in writing via email to edwin.roldan@va.gov . Pertaining questions will be answered electronically and posted to the FBO solicitation. Attendance is at the contractor's expense. Personnel should arrive at the **Facility Warehouse, Building #5** no later than 8:25 am prevailing local time to receive additional instructions. Close toed shoes are required to enter into the main facility as it is still an active construction site. Hard hats, safety glasses, and safety vests can be provided. Any other safety apparel is strongly encouraged but not mandatory. Maps and directions may be requested at the time of attendance confirmation.
