STATEMENT OF BID ITEM(S)

A. **ITEM 1, GENERAL CONSTRUCTION:** Work includes demolition, general construction, grading, drainage, landscape planting, landscape irrigation, plumbing, mechanical and electrical work.

B. **ITEM 2, DEDUCTIVE ALTERNATE:** Reduce plant sizes for landscaping plants; refer to Landscape drawings for schedule of alternate plant sizes.

C. **ITEM 3, DEDUCTIVE ALTERNATE:** Delete/omit gravel overlay in parking area north of new construction; refer to civil drawings for defined limits of work.

Item #1 Shall be prepared as the Base Bid. The base bid shall be prepared IAW all price proposal instructions including required price breakdowns.

Items #2 & #3 may be presented as lump sum prices within the price proposal.
