Job Description:

The Government requires a contractor to service SHIMADZU HPLC FOR QC pump for routine maintenance and service. The services are to include all required maintenance repairs, equipment, materials and parts. Contractor will not use any refurbished and/or gray market parts. Upkeep of these instruments is essential for production of the radiotracers used for Positron Emission Tomography in Nuclear Medicine.

Shimadzu high Performance Liquid Chromatography (HPLC) and Gas chromatography (GC) instruments are some of the most critical parts of many of the production and quality control systems in our Cyclotron Lab.

HPLC Pump is a critical part of purification system in many of the radiopharmaceutical production set-ups in the laboratory. Without HPLC, production of many of the radiotracers with acceptable purity will not be possible. In addition, analytical HPLC, GC, and their detector systems are used in quality control of every radiotracer used in our Cyclotron lab.

The routine maintenance, service, and upkeep of these instruments are essential for production of the radiotracers used for positron Emission Tomography in our Cyclotron Lab.

In other words, the quote, as submitted, either meets the acceptability requirements of the criterion, or it doesn’t. No other rating or quantitative value will be assigned

Once technical acceptability has been established, the Contracting Officer shall award to the Lowest Price Technically Acceptable.

Non Cost Factors

1. Technical Qualifications

Offeror shall submit documentation which indicates and certifies that the designated technicians servicing the equipment have been properly trained, certified and authorized to work on Shimadzu equipment by Original Equipment Manufacturer (OEM). Documentation shall consist of the following:

- A. Current/Valid OEM documentation such as; Certificates, license, training, which certifies the designated technician is certified to service the referenced equipment herein. As there are multiple equipment that requires servicing, designated technician must be certified on all equipment identified.
2. Provide a letter or memo stating that Contractor will not use any refurbished and/or gray market parts in performance of this contract.

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).
