C.2 52.203-99 PROHIBITION ON CONTRACTING WITH ENTITIES THAT REQUIRE CERTAIN INTERNAL CONFIDENTIALITY AGREEMENTS (DEVIATION) (FEB 2015)

(a) The Contractor shall not require employees or contractors seeking to report fraud, waste, or abuse to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(b) The contractor shall notify employees that the prohibitions and restrictions of any internal confidentiality agreements covered by this clause are no longer in effect.

(c) The prohibition in paragraph (a) of this clause does not contravene requirements applicable to Standard Form 312, Form 4414, or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(d)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), use of funds appropriated (or otherwise made available) under that or any other Act may be prohibited, if the Government determines that the Contractor is not in compliance with the provisions of this clause.

(2) The Government may seek any available remedies in the event the contractor fails to comply with the provisions of this clause.

(5) *Payment request* means any request for contract financing payment or invoice payment submitted by the contractor under this contract.

(b) *Electronic payment requests.* Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

(c) *Data transmission.* A contractor must ensure that the data transmission method and format are through one of the following:

(1) VA's Electronic Invoice Presentment and Payment System. (See Web site at <http://www.fsc.va.gov/einvoice.asp>.)

(2) Any system that conforms to the X12 electronic data interchange (EDI) formats established by the Accredited Standards Center (ASC) and chartered by the American National Standards Institute (ANSI). The X12 EDI Web site (<http://www.x12.org>) includes additional information on EDI 810 and 811 formats.

(d) *Invoice requirements.* Invoices shall comply with FAR 32.905.

(e) *Exceptions.* If, based on one of the circumstances below, the contracting officer directs that payment requests be made by mail, the contractor shall submit payment requests by mail through the United States Postal Service to the designated agency office. Submission of payment requests by mail may be required for:

- (1) Awards made to foreign vendors for work performed outside the United States;
- (2) Classified contracts or purchases when electronic submission and processing of payment requests could compromise the safeguarding of classified or privacy information;

The contractor guarantees the equipment against defective material, workmanship and performance for a period of no less than 12 months, said guarantee to run from date of acceptance of the equipment by the Government. The contractor agrees to furnish, without cost to the Government, replacement of all parts and material that are found to be defective during the guarantee period. Replacement of material and parts will be furnished to the Government at the point of installation, if installation is within the continental United States, or f.o.b. the continental U.S. port to be designated by the contracting officer if installation is outside of the continental United States. Cost of installation of replacement material and parts shall be borne by the contractor.

Diagnostic Screening Otoacoustic Emissions Equipment:

Audiology requires combined diagnostic/screening otoacoustic emissions equipment. The equipment must be capable of assessing both Transient Evoked Otoacoustic Emissions (TEOAE) and Distortion Product Otoacoustic Emissions (DPOAE) and poses the following minimal characteristics.

1. DPOAEs must have option to test 12 points between 1.5-12kHz in diagnostic mode with intensity level of 40-70 dB SPL
2. TEOAE must test .7-4kHz at 83 dB pe SPL
3. The unit must have options for configurable and fixed testing protocols with normative data.
4. The unit must be a hand held unit free of any power attachments to allow ease of access to patients unencumbered by cables.
5. The unit must have a charging base which requires no attachment/detachment of cables from the unit between uses to facilitate ease of rapid use.
6. The unit must have long battery life and retain data gained if the battery is discharged during testing.
7. Probe assembly must not require cleaning.
8. The unit must allow testing of patients with PE tubes.
9. The unit must include a color visual display of test results relative to normative values for ease of test analysis, displayed during test acquisition to facilitate suspension of test when appropriate.
10. Must include any user manual, specification manual, calibration cavity, rechargeable battery, software, ear tip kit, cleaning kits, as needed to support ongoing operations.
11. The unit and any accessories must meet any current regulatory standards for hospital equipment (i.e. IEC/EN 60601-1, IEC/EN 60601-1-2, UL 60601-1, IEC 60645-6 Electroacoustics -Audiometric equipment - Part 6: Instruments for the measurement of otoacoustic emissions.

Evoked Potential Unit:

The Audiology service requires an evoked potential unit capable of assessing Auditory Evoked Potentials (AEP) including auditory brainstem response, ECoG, cortical evoked potential, auditory middle latency response and otoacoustic emissions using distortion product techniques and is capable of completing Auditory steady state response (ASSR) measures.

For AEP/ASSR unit

1. True two channel operations to allow recording of contralateral measures as is essential in some test protocols.
2. Transducers should include insert phones, TDH phones and bone vibrator.
3. There should be normalized default test parameters and the capacity to develop customer specific test protocols.
4. ASSR protocol must provide estimated audiogram based on thresholds obtained.
5. Unit allows assessment of impedance either through the software or via the amplifier to facilitate integrity testing while attaching electrodes to patient.
6. Stimuli should include clicks, tone bursts, tone pips and ce chirp and ce chirp octave band to facilitate speedy frequency specific threshold measures.

7. Polarity should include condensation, rarefaction and alternating to improve response clarity for otoneurologic assessment even in the presence of hearing loss or aggressive recording environments.
8. High pass filtering including RC or digital Butterworth and low pass filtering including Butterworth or digital linear phase.
9. Intensity should range from 0 to 130 SPL to allow adequate stimulation for normal to severe hearing losses.
10. Masking should be available to allow isolation of single ear testing
11. All necessary electrode leads and attachments ; snap electrodes required for infection control purposes.

Diagnostic DPOAE

1. Records Distortion and Spontaneous OAEs
2. Configurable test protocols as well as default test protocols
3. Frequency range from 500-12000 Hz
4. Includes up to 12 points per octave

General

1. All patient information will integrate into on common database.
2. Includes suitable laptop computer to operate the integrated test system.
3. Power isolation transformer included.
4. Custom cart included.
5. All service manuals, users manuals and accessories required for operation included.
6. Calibration procedures for acoustic stimulus must meet ISO standards
7. Meets all standards for hospital equipment, (i.e. UL 2601-1 American Standards for Medical Electrical Equipment)

Real Ear Hearing Aid Analyzer Equipment:

Audiology requires real ear hearing aid analyzing equipment. Equipment should possess the following minimal characteristics.

1. Must be capable of performing real ear unaided, real ear aided, real ear occluded and real ear insertion gain responses, which are basic measurements of aided hearing aid function.
2. Tests for a frequency range of 200 to 12,500 Hz
3. Includes a variety of test stimuli suitable for modern hearing aids which will not activate the noise reduction algorithms, such as frequency modulated tones, tone bursts, pink noise, calibrated digitize speech signal, long term speech signal, and filtered speech for frequency lowering instruments.
4. Incorporates a hearing aid test box which includes an induction coil for the assessment of telecoil features and battery simulator, both compatible with ANSI S3.22, three speakers for directionality assessment, and binaural hearing aid testing capabilities to expedite testing processes.
5. Incorporates monitor headphones jack or wireless access to allow monitoring of signal emitted from hearing aid to patient in situ during testing to allow clinical real time evaluation of hearing aids under test conditions.
6. Incorporates external sound field speaker on retractable wall mounted arm which can be removed from test position and aligned with the wall to prevent patient injury and minimize visual barriers to communication.
7. Allows real time verification of binaural hearing aid fitting simultaneously, as well as assessment of hearing aid synchronization and streaming, allowing verification of CROS/biCROS fittings, significantly reducing the time for conventional hearing aid adjustments and improving verification of hearing aid features.
8. Has features supporting assessment of t-loop and FM fitting verification to allow improved fitting of assistive devices.

9. Incorporates a mechanism to update test parameters within the equipment so tests can align with changing technology and standards.
10. Allows network connection and completes transmission to/from NOAH module for ease and accuracy of testing and storage of test results.
11. Incorporates a variety of fitting formula including ones suitable for ABR derived hearing thresholds (eHL and nHL), DSL, NAL NL1, NAL NL2, and Camfit.
12. Incorporates a Speech Intelligibility Index based on measurements obtained to facilitate counselling on reasonable expectations for hearing aid performance with the patient and family.
13. Allows adjustment of fitting targets based on transducer used to obtain hearing threshold measures (TDH, ER-3A, ER with molds, Sound field) to refine the hearing aid fitting.
14. Allows incorporation of bone conduction thresholds / conductive hearing loss and Uncomfortable level (UCL) measurements for refinement of hearing aid fitting.
15. Adjusts fitting targets based on binaural vs monaural hearing aid fitting for refinement of hearing aid fitting.
16. Fitting formula incorporates a correction factor for microphone location effects based on the style of hearing aid being fit (CIC, ITC, ITE, BTE).
17. Meets all available standards of US medical equipment. (i.e. UL 2601-1 American Standards for Medical Electrical Equipment, IEC 601-1, EN 60601-1 International Standards for Medical Electrical Equipment, ANSI S3.39, ANSI S3.6, IEC 645-1, IEC 1027, ISO 389)
18. Any available calibration test cavities, cleaning kits, probe mount kits, user guides, reference instruction manuals, service manuals, computer remote linking systems are included.

Middle Ear Analyzer Equipment:

Audiology requires equipment to analyze middle ear function. Equipment should possess the following minimal characteristics.

1. Pre-set protocols for screening and diagnostic auto sequence as well as manual over ride or auto sequence features. This will facilitate ease of use while allowing customization for clients unable to follow instructions to remain motionless (i.e. neurodegenerative conditions).
2. Automatically determines best sensitivity scale for display based on the peak amplitude of responses obtained and notes magnitude of peak response.
3. Measurement of pressure variance from +400 mmH2O to -600 mmH2O are available to allow assessment even in situations of extreme middle ear dysfunction and notes pressure at peak response.
4. Measurement of Admittance (Y), Susceptance (B) and Conductance (G) at 226, 678 and 1,000 Hz to help determine where, along the ossicular chain problems are occurring.
5. Probe tones including 226 Hz, 800 Hz and 1200 Hz allowing assessment of middle ear resonance for appropriate diagnosis of middle ear pathology and for pre/post-operative comparisons.
6. Ability to start the test sequence from the probe assembly placed on the patient rather than from the equipment, allowing tester to remain in close contact with the patient when required.
7. Large monitor to display results for ease of viewing when distant from equipment.
8. Touch screen monitor to facilitate ease of use.
9. Capacity to assess Eustachian tube function for both intact and perforated ear drums.

10. Acoustic reflex threshold automatically or manually measured by time and magnitude for ipsilateral and contralateral mode using 250 Hz, 500 Hz, 1000 Hz, 2000 Hz and 4000 Hz, Low band, High band, Broad band click and non-acoustic stimuli to allow thorough assessment of auditory neural pathways and facial nerve integrity. Input for external signal is available.
11. Capacity to assess acoustic reflex decay using the available stimuli for reflex threshold testing, marking for 50% decay within the stimulus window of at least 10 seconds to identify a positive sign of retro-cochlear pathology.
12. Contralateral signal is presented via an insert phone assembly to minimize infection control issues from head worn devices.
13. Any available calibration test cavities, cleaning kits, probe mount kits, user guides, reference instruction manuals, service manuals, and computer remote linking systems are included.
14. Meets all available standards for US medical equipment. (i.e. UL 2601-1 American Standards for Medical Electrical Equipment, IEC 601-1, EN 60601-1 International Standards for Medical Electrical Equipment, ANSI S3.39, ANSI S3.6, IEC 645-1, IEC 1027, ISO 389)

High Frequency Clinical Diagnostic Audiometers:

Audiology requires clinical diagnostic audiometers capable of completing high frequency audiometry assessments. Equipment should possess the following minimal characteristics.

1. Must include true two channel performance to allow differing simultaneous ear specific stimuli for central auditory processing assessment.
2. Must present signals at audiometric frequencies 125 Hz, 250 Hz, 500 Hz, 750 Hz, 1000 Hz, 1500 Hz, 2000 Hz, 3000 Hz, 4000 Hz, 6000 Hz, 8000 Hz, 9000 Hz, 10000 Hz, 11200 Hz, 12500 Hz, 14000 Hz, 16000 Hz, 18000 Hz to be capable of fully assessing the auditory system.
3. Must be able to present signals at intensity levels ranging from -10 dB to 110 dB HL using insert earphones, -10 to 75 dB HL for bone conduction stimuli and -10 to 90 dB for sound field in 1, 2, and 5 dB increments to be capable of fully assessing the auditory system and include all transducers, including any necessary to complete high frequency audiometry and calibrated sound field testing.
4. Allows modulation of the test signal to include pulsing and frequency modulation , singularly or in combination, to allow patients to distinguish the signal from tinnitus.
5. Provides masking stimuli including speech noise, narrow band and white noise signals to prevent cross hearing from the non-test ear.
6. Capable of providing live voice via a monitor headset or recorded speech audiometry testing via internal or external inputs as needed based on patient cognitive abilities and test requirements.
7. Incorporates a talk back and a talk forward system to allow easy access to communicate between tester and patient during the assessment. Responses from the patient must be audible to the tester and, when necessary, others within the control booth, to facilitate student instruction. This should be accomplished without deactivation of the monitor headset; auxiliary speaker is acceptable.

8. Must be able to operate as a standalone audiometer without a PC required.
9. Control panel must light to allow ease of operations in the dimly lit testing booth.
10. Must have a means to retain data gathered in the event of a power surge/power loss.
11. Must allow transmission of audiometric data gathered directly to NOAH module and VA proprietary audiometric recording system (Quasar) to facilitate timely, accurate record maintenance.
12. Complies with all appropriate regulatory standards for hospital based audiologic testing equipment, such as ANSI S3.6, ANSI S3.43, UL 60601-1 American Standards for Medical Electrical Equipment.

The successful bidder or offeror will be required to submit proof that the item(s) he/she furnishes conforms to this requirement.
