2. Description of Supplies or Services:

The estimated value of the proposed action is \$ 101,563.20

The contractor shall provide to the Department of Veterans Affairs, Memphis, TN 9 Medical Phlebotomists. The contractor shall provide services on an as needed basis. Upon request for the medical Phlebotomist services, the contractor will also be provided with the term of services required. The Department of Veterans Affairs Medical Center Chief of Laboratory & Pathology Medicine Service will have final technical and administrative direction over all services provided.

Description of duties: The medical Phlebotomist will be assigned to work within the Pathology and Laboratory Medicine Service. Technician will perform emergency, STAT, and routine tests on blood, urine, and other fluids. Pathology and Laboratory Medicine Service provides services to wards, ICU, emergency room, and ambulatory care 24 hours each day. Primary duties include the following: Draw and collects and/or evaluates suitability of specimens for testing, accession the specimen, and perform limited processing of specimen. Medical Phlebotomist will use all the functions on the hospital computer system that relate to Pathology and Laboratory Medicine Service and patient data..


