

GENERAL NOTES: 4-WAY DUCT LINE

1. CONCRETE SHALL BE 2000 P.S.I. @ 28 DAYS, OR AS SPECIFIED.
2. PROVIDE #4 REINFORCING RODS ON TOP AND BOTTOM OF DUCTS WHEN CROSSING OR PLACED IN ROADWAYS.
3. MINIMUM COVER TO TOP OF ENVELOPE SHALL BE 610mm (24") OR AS OTHERWISE SPECIFIED IN SECTION 26 05 41.
4. PROVIDE 4-INCH, 3-CELL FIBER MESH INNERDUCT.







1. Manhole Grounding Detail. Delete Detail reference on plan and Add the following Detail for the Manhole Grounding Detail. NTS



ITEM NO: 5: Reference Sheets 5.AE411 and 5.AE412. Interior Elevations:

1. Clarification. Elevations for the GFRG columns are shown on 5.AE411 (per Addendum #1) and 5.AE412. Intended diameters are noted in Keynote 2 on Interior Elevation sheets. A plan detail for the GFRG cover is located on 1F/5.AE521 and can be used as reference for all the GFRG covers.

ITEM NO: 6: Reference Sheet 5.AE510. General Detail:

1. Type D3A. Change Wall Assembly and Delete inside layer of 5/8" gypsum board.
2. Type D3B. Change Wall Assembly and Delete inside layer of 5/8" gypsum board.
3. Type D6A. Change 4 1/4" dimension to read 6 5/8". Change Wall Assembly and Delete inside layer of 5/8" gypsum board.

ITEM NO: 7: Reference Sheet 5.AE511. Exterior and Roof Detail:

1. Detail 1B. Clarification. Stud framing forming the parapet is 20 GA metal, 3 5/8".
2. Detail 3B. Clarifications. Vertical and horizontal framing members for the fascia and soffit are 20 GA metal; vertical is 6", horizontal is 3 5/8".
