B.3 STATEMENT OF WORK

3.1 Salient Characteristics and Specifications

3.1.1. Equipment considered to be “equal” shall meet or exceed the specifications of the equipment listed below. Brand and model numbers are provided within the schedule.

- apochromatic optics throughout the entire visual pathway to eliminate spherical and chromatic aberrations
- stereo coaxial illumination
- two independently programmable 5-function handgrips from which key system functions can be accessed by the surgeon intra-operatively
- 14-function programmable footswitch which can be used tethered to the system or wirelessly, enabling hands-free access to key system functions.
- motorized zoom & focus adjustment that can be controlled from the programmable handgrips or the foot control panel
- electronically adjustable depth-of-field that can be activated from the programmable handgrips or the foot control panel
- integrated beam-splitter for an assistant scope that can be rotated to enable left-side or right-side stereo co-observation without disassembling co-observer
- integrated assistant's microscope with motorized zoom and focus that can be configured to be linked or adjusted independently of the main observer
- tiltable binocular tube that has optical inverters (manual or motorized available) integrated to enable image inversion without a 2-piece inverter and binocular tube setup for lower “stack height”
- image inversion can be activated from the programmable handgrips or the foot control panel
- non-contact fundus viewing system with sterilizable (and thus reusable vs. single use) aspheric lens options to enable customization based on surgeon preference of magnification, field-of-view and depth-of-field
- 180W illumination with foot-pedal activated HaMode filter and a Retinal Protection filter.
- A depth-of-field management system that allows the surgeon to, at the push of a button, choose between optimized depth perception at all magnification levels or maximum light transmission
- a system that receives biometry and keratometry information and uses it to project overlays into the eyepieces in a heads-up-display-like fashion
- integrated video cameras and recording and all associated cabling are all fully internalized into the system (no exposed wiring)

3.2. Support Features

3.2.1. Installation: The contractor shall provide coordinated professional installation services to implement the system specified in the SOW at all identified sites upon the request of the VA after placing an order. The contractor shall provide a firm estimate of working days required from date of delivery order to completion based upon the SOW.

3.2.2. Warranty: The contractor shall provide a minimum warranty of no less than one (1) year

- 3.2.3. User and Service Manuals: The contractor shall provide to each station at no charge, two (2) complete and unabridged printed copies and one (1) electronic version (CD) of operator manuals, service manuals, troubleshooting guides, any necessary diagnostic software and tools to the VA representative overseeing installation of equipment at the time of installation. Additionally any upgrades to these documents shall be provided by the Contractor free of charge. These manuals shall include all components and subassemblies, including those not manufactured by the contractor. These manuals and documentation shall be identical to the ones supplied to the manufacturer's service representatives and shall contain any diagnostic codes, commands, and passwords utilized in maintenance, repair and calibration of the equipment and provided for the life of the system at no additional cost.
- 3.2.4. Clinical Training: The contractor shall provide a training program that is coordinated with and timely to the equipment installation, sufficient to the size and scope of the facility's services, and completed no more than 15 days after installation at the request of the VA. Utilization of the training slots shall be mutually agreed upon between the VA and the contractor. Training shall include initial setup and user training; and follow-up training if requested.
- 3.2.5. Upgrade/Updates: The contractor shall provide updates to any critical software at no additional charge to the government. These shall be provided as they become commercially available and at the same time as they are being provided to commercial customers for the duration of the warranty period. This requirement only applies to "system updates" that enhance the model of equipment being offered, i.e. new version of software, correction of defect, update offered to commercial customers at no additional charge, etc. This does not refer to replacing the original piece of equipment. Should the VISN decide to upgrade their current equipment (i.e. replacement of existing equipment with newer models) the CO and contractor may do so under a signed supplemental agreement.

B.4 PACKAGING AND MARKING

4.1 Packaging

- 4.1.1 All equipment and supplies shall be adequately packaged to prevent damage during shipping, handling and storage. Bags or packages shall be whole, intact, and not otherwise torn or damaged. Upon delivery, the government shall examine all packages. The contractor shall be required to replace unacceptable or damaged products at the contractor's expense.

4.2 Marking

- 4.2.1 All items shall be marked clearly with the Contract Number, Delivery Order Number, Obligation number and delivery location within the hospital ie. Emergency Room.

B.5 DELIVERIES, ORDERING & PERFORMANCE

5.1 Ordering:

- 5.1.1 The VA will submit a purchase order using Standard Form 1449. The contractor shall provide all supplies contained in the purchase order provided by the VA. Contractors shall not ADD or SUBSTITUTE components without prior approval from the Contracting Officer responsible for the delivery order. All items provided by the contractor shall be new.

5.2 Delivery

- 5.2.1 The contractor will ship to the location listed in block 15 of the delivery order Standard Form 1449 unless prior approval is received in writing by the Contracting Officer.
- 5.2.2 Equipment shall be shipped within seven (7) calendar days after receipt of a purchase order unless prior approval is received in writing by the Contracting Officer.
- 5.2.3 The contractor must have the capability to receive order via facsimile transmission if necessary. The Government will generally submit all purchase orders to the contractor via email.
- 5.2.4 In the event the Government requires expedited delivery, the VA will contact the contractor and inquire into the feasibility of obtaining this condition. The contractor shall respond within 24 hours of the request. An expedited delivery date shall be mutually agreed upon between the contractor and the VA.
- 5.2.5 All deliveries will be made FOB destination.

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

“Service-disabled veteran-owned small business concern”—

 - (ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.
- (2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Small disadvantaged business concern”, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(2) The management and daily business operations of which are controlled (as defined at 13.CFR 124.106) by individuals, who meet the criteria in paragraphs (1)(i) and (ii) of this definition.

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

“Veteran-owned small business concern” means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned business concern” means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

“Women-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

“Women-owned small business (WOSB) concern eligible under the WOSB Program” (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.
