

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [FAR 13.106-1](#)
(OVER MICRO-PURCHASE THRESHOLD(\$3K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. COs may solicit from one source if the CO determines that the circumstances of the contract action deem only one source reasonably available (e.g., urgency, exclusive licensing agreements, brand-name or industrial mobilization). 2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

It is essential to the Government, that they purchase the Medivators Corporation Advantage Plus Automated Endoscope Reprocessor, since it is the only machine of its kind, that can utilize Rapicide PA, of which Rapicide PA is a trademarked product that is exclusive to Medivators Corporation, and since this machine is the only dual basin endoscope Reprocessor that utilizes single use Rapicide PA high level disinfectant and is compatible with all flexible endoscopes.

4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:

Medivators is manufacturer and seller of this product and they do not sell through any third party in the US with the exception of their authorized FSS re-seller, Surgical Tools, who can only sell these equipment products off a FSS contract, but cannot provide the needed installation and training services, which Medivators Corporation has indicated they can only provide, and for these reason, and since Medivators Corporation does not have a FSS contract, Medivators is the sole exclusive seller of the needed items, and sole provider of the needed services, in the open market.

5. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

Written confirmation in the form of an email, from Medivators Corporation, which confirms the claims being made under #3. And #4 above.

Google Search was conducted using the words "Medivators Corporation Endoscope Reprocessor" and no other matches came up other than Medivators Corporation.

GSA Advantage Search under Services was conducted and no matches came up.

Search of the VA Vetbiz VIP was conducted, using the words "Medivators" and no matches were found.

Written confirmation was received from Medivators Corporation, that confirms that the prices they are quoting for the equipment is the same as what their FSS re-seller Surgical Tools FSS prices for same equipment,, and copies of paid Medivators Corporation Paid invoices were obtained, that evidence they the prices quotes are less than they charged the VA Chicago IL and VA Saginaw Michigan, Facility, the same or less price, for the same equipment and services, in 1/7/2016 and 12/28/2015. .
