

B.4 PRICE SCHEUDLE

Contract Period will be from the date of award, April 1, 2016 through March 31, 2017, plus four (4), one (1) year option periods that may be exercised at the Department of Veterans Affairs' discretion. It is the Government's unilateral right to elect to exercise the option period.

Pricing of Quotes: Offerors are required to submit pricing for ALL years listed wherein costs associated with readjustment counseling are identified by clinical specialty. For example, if a psychologist is identified as a clinician who will provide services, the hourly rate for that clinician must be listed. When invoices are submitted to VA, the clinician who provided service must be identified. Reimbursement will be based on the costs for that clinician. Please refer to Section Reimbursement and Limitations on Services, on proposing per-session rate(s). Enter N/A if not applicable to bidder's organizational capabilities. The Base Period and Option Years will be included in the evaluation of the award.

The Government's minimum quantity for the Base Period and All Option Years under the resulting contract will be 10 sessions; the maximum quantity will be 150 sessions. For the purpose of the Government's minimum quantity requirements, each individual participating in a group session will count as one session. For example, a group session with 5 participants will count as 5 sessions. Services by any one of the provider specialties below will count as a session.
