B.2 Functional-Performance-Specification

This procurement is a brand name or equal to acquisition in accordance with Federal Acquisition Regulation (FAR) part 11.104. See Section 5 Provisions – FAR Part 52.211-6 Brand Name or Equal for further information.

Description & Salient Characteristics:

Smart pump with a customizable drug library that contains hard and soft limits to help reduce medication errors. Shall have 18 delivery modes that allow clinicians to use weight-based protocols, intermittent or continuous delivery modes with optional delivery features for loading dose, bolus does, flush standby and volume limit. Shall also have the ability to automatically detect syringe sizes from 1 ml up to 60 ml. This all helps to optimize patient safety in various situations where continuous infusions need to be used by anesthesia providers.

Shall be a small, lightweight, ergonomic and portable pump that makes thus making it ideal for taking to remote sites to provide anesthesia for patients that require IV sedation from anesthesia providers. The pump shall have maximum dimension of 13.5" wide X 5" high X 8" deep with a maximum weight of 6 lbs. to be considered. This is a huge benefit and safety feature for anesthesia providers in that they will not need to transport a big, heavy and bulky pump to and from each location throughout the hospital. Finally, it shall have a display screen that can be read in high or low light environments.

Shall have a horizontal design which protects the entire syringe barrel. This feature makes it extremely easy to load and unload a syringe from the pump for the anesthesia provider. By allowing the provider to easily load and unload the syringe from the pump it makes it ideal for anesthesia providers to quickly set up medication infusions and initiate therapies for patients. The machines must be calibrated for BD & Monoject syringes.

(i) Determine whether the product offered meets the salient characteristics requirement of the Invitation for Bids, and

The Contracting Officer is not responsible for locating or obtaining any information not identified in the offer.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

5.3 52.212-2 EVALUATION—COMMERCIAL ITEMS (OCT 2014)

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

“Veteran-owned small business concern” means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned business concern” means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

“Women-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.
