Nature and/or Description of the Action Being Processed: The North Chicago VA has a requirement for a one time firm fixed purchase order for a SIMJUNIOR patient training mannequin, accessory training items and consumables, installation, warranty and training.

1. Description of Supplies/Services Required to Meet the Agency's Needs:

Training aid, artificial anatomy, Sim Junior advanced with complete peripheral kit. Includes. Simjunior manikin, vitalsim control unit w/software & remote control, laptop pc, touch screen monitor, usb webcam, blood pressure cuff, consumables, advanced software, dfu & carry case. Simstore content. Pediatric trauma modules. Extended warranty, Simjunior advanced value plus platinum 2 year, includes installation, through year 2, preventative maintenance on-site and loaner program. Training: Intro to Simjunior advanced customer site 2 days. A laerdal instructor will travel to your facility & teach up to 8 participants.

3. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):

Laerdal is the only company with simulators that have scenarios validated and supported by the National League of Nursing, American Heart Association, and the American Academy of Pediatrics. These scenario packages will only work with Laerdal products.

- This is a purchase of additional high fidelity simulation equipment to be used in conjunction with existing equipment. Laerdal is the only maker of the SimJunior product. Continued use of their high fidelity simulators allows us to maintain the continuity of our training databases and operating systems in addition to familiarity of the equipment. It consists of a computerized control and audiovisual interactivity component. The SimJunior generates realistic and automatic responses to clinical interventions and drug administrations representing a true-to-life physiological response to a six year old child.

Laerdal provides an advanced patient simulator that employs multiple models of human physiology to include cardiovascular, pulmonary, neurovascular and central nervous system. The simulator exhibits life like clinical signs of breathing, eyelid movement and monitored parameters such as vital signs and electrocardiogram. It is the only pediatric patient simulator that automatically responds to changing cardiovascular system status (bleeding, IV fluids).

Laerdal provides the ability to assess chest compression and CPR compatibility with existing organization's defibrillators to adequately assess the effectiveness of quality CPR.

4. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:

In order to maintain continuity and level of fidelity in regards to simulators currently on station, it was deemed a requirement to maintain the same brand of simulator.

5. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable: The requested items are on DOD contract SPM2DE-09-D-7601-ECAT. This DOD contracting officer has determined these prices to be fair and reasonable. AMD has extended this pricing to the VA.

6. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: A GSA, Dynamics Small Business and Google search yielded no added sources or alternatives for the requested items.

7. Any Other Facts Supporting the Use of Other than Full and Open Competition: The contracting specialist received a memo from the manufacturer, Laerdal stating American Medical Depot is the sole authorized dealer of these items for federal healthcare facilities worldwide.
