1. **Contracting Activity:** Department of Veterans Affairs, NCO 01, Manchester VAMC
Procurement for: VA Connecticut Health Care System, 2237 No 689-16-2-7061-0059 (\$195,000.00).
2. **Nature and/or Description of the Action Being Processed:** Emergency contract for Special Mode (Ambulance) Transportation service.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** VA Connecticut Health Care System has a continuing need for special mode (ambulance) transportation. Changing requirements have caused a delay in processing and additional time is needed to complete the solicitation. This contract will be for 2 months (March 30, 2016 through May 31, 2016) with the vendor who held the last successful contract.
4. **Statutory Authority Permitting Other than Full and Open Competition:** *41 USC §3304(a)(1), as implemented by FAR 6.302-1. The specific paragraph must be cited. 5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):**): (2) Unusual and Compelling Urgency ([FAR 6.302-2](#), [6.303-2\(a\)\(9\)\(ii\)](#)) Continuation of the special mode transportation is needed at once to preclude impairment of healthcare delivery capabilities and mission performance. Without this continued service Veterans will not receive needed transportation to their healthcare appointments and will not receive the care they require and are entitled to.
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** There is currently an action to procure this vitally needed service. When solicited this will be posted on FedBizOps to allow for maximum participation by interested vendors.

7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** Market research, and pricing of similar contracts throughout the VISN, has shown that the current rates with the incumbent vendor are fair and reasonable.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Market research has shown that given the additional time for solicitation will allow for more vendors to respond increasing competition.
9. **Any Other Facts Supporting the Use of Other than Full and Open Competition** There are actions in place to procure a new contract for this service however, due to unforeseen delays, the new contract will not be in place in time to allow a seamless (uninterrupted) service for our Veterans. This contract needs to be placed in order to close the gap in service.
