CONSTRUCT NEW DIETETICS, BUILDING - 2

VETERAN AFFAIRS MEDICAL CENTER, 2401 MAIN STREET, MARION, IL 62959

GENERAL NOTES:

- General contractors are advised to visit site and to familiarize themselves with this project before bidding and starting any work. See specification section 01 00 00 for arranging site visit.
- General contractor shall verify all dimensions at job site. If any discrepancies are found, general contractor shall notify the architect before starting work.
- General contractor shall patch all the areas that have been disturbed. The patching material shall match existing condition.
- Do not scale drawings. Follow written dimensions only.
- General contractor shall protect building, staff, patients & public from all unsafe or hazardous conditions at all times of construction.
- Normal working hours are 8:00 a.m. - 4:00 p.m. Monday through Friday excluding weekends and holidays. However, per spec. section 01 57 19 Temporary Environmental Controls, contractor shall coordinate with Contracting Officer's Representative (COR) for the working time limitation to avoid the spreading of pollutants such as noise and odors to the neighboring area of the hospital.
- General contractor shall coordinate with COR for detailed construction schedule for this project. In order to minimize the disruption of hospital function, VAMC will assign construction accesses, material deliver routes, contractor parking, and storage areas for this project.
- General contractor shall propose construction schedule, phasing plan and detailed construction plan specifying area-to-area and date-to-date to VAMC and architect for approval.
- Contractor shall remove debris from construction inside buildings per VAMC requirements as outlined under general requirements in specifications on a daily basis. This includes debris (drop-off or falls) from renovation operations. Contractor shall not store or permit debris to accumulate on site. If contractor fails to remove debris promptly, VAMC reserves the right to cause same to be removed at contractor's expense.
- Temporary weather protection & overnight protection during the process of construction shall be ready and used whenever needed.
- Contractor shall provide A 3/4" min. thick plywood or heavy lumber such as 2x12's on ground for lifting equipment (boomer, swingstage, scaffolding or ladder etc.) to maneuver around working areas in order protect existing lawn, and pavement.
- Provide 6'-0" H. portable sight-proof chain link fence as barricade for different phases of construction. See Phasing Plan for more information.

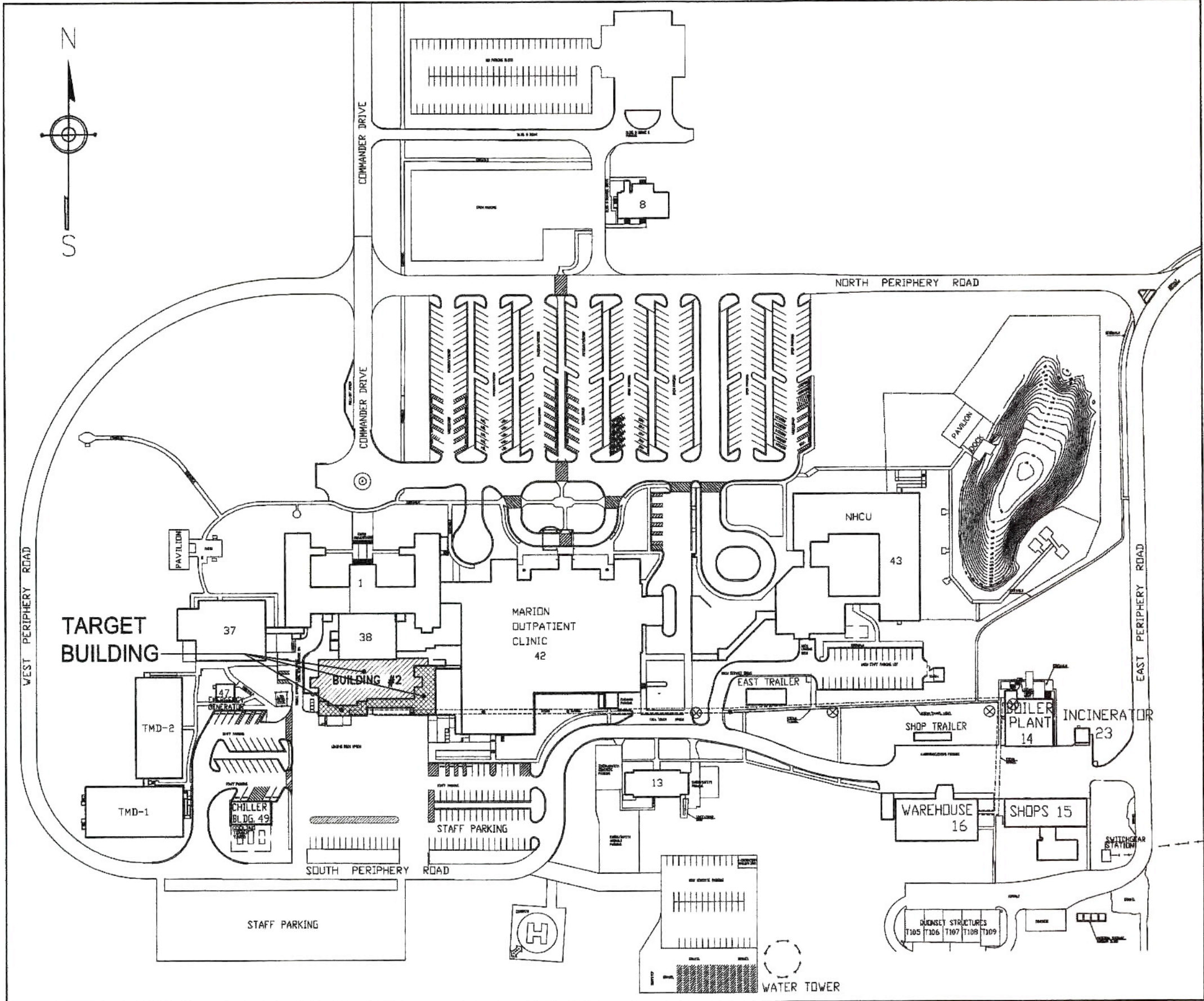
