Department of Veterans Affairs, VISN06, Network Contracting Office in support of the Veteran Affairs Medical Center, Salisbury, North Carolina for the Charlotte HCC.

2. Nature and/or Description of the Action Being Processed:

This is a Brand Name Only Request to supply the Salisbury VAMC in support of the Charlotte HCC with HD Ultra-Light URO Cameras and supporting accessories.

3. Description of Supplies/Services Required to Meet the Agency's Needs:

The Charlotte HCC requires this equipment and related instrumentation to enable the surgeon to see into the bladder and ureters and enable them to do procedures aimed at curing disease. The cameras and instrumentation must be compatible with Olympus CV-190 video processor.

The HD Ultra-Light URO Cameras are manufactured by Olympus and are the only equipment that can meet the minimum needs of the Government based on compatibility with existing equipment inventory at the Salisbury VAMC/Charlotte HCC as well as VAMC standardization efforts executed in 2012.

Competition will be achieved by soliciting to three small business authorized dealers. Market Research identified the manufacturers cost to the small business dealers thereby allowing for determination of fair and reasonable.

Market Research included searching for other sources utilizing SAM, GSA, and SBA in accordance with standard market research practices. Confirmation of small business was received through SBDS verification.
