

COMBINED SYNOPSIS / SOLICITATION VA246-16-Q-0833

Replace Bldg. 2 Backup Generator for VA Medical Center Salem

This is a combined synopsis/solicitation, written under the authority of FAR part 13.5, for commercial items, prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation. Quotes are being requested, and a written solicitation will not be issued. Quotes shall reference VA246-16-Q-0833. This Request for Quote (RFQ) document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2005-87.

The Network Contracting Office 6 - SAO East intends to award a firm-fixed-price contract for the replacement of a 600kW Diesel Generator at the Salem VA Medical Center in Salem, Virginia. This procurement is being conducted under FAR Part 13.5 simplified acquisition procedures for certain commercial items and FAR Part 12.603 for Streamlined Solicitation of Commercial Items.

The North American Industrial Classification System (NAICS) code for this procurement is 335312 with a small business size standard of 1,250 employees. This procurement is 100% set-aside for small businesses. All offerors must be registered in the System for Award Management (SAM) at <https://www.sam.gov> to be considered for an award of a federal contract. The record must be complete and not missing elements such as representations and certifications.
