Definitions:

- Total Enrollment (A)** The number of individuals enrolled as tribal members.
- Total Eligible for Services (1)+(2)+(3)** The number of enrolled tribal members residing on the reservation. Age distribution for reservation residents is listed under columns 1, 2, 3.
- Not Available for Work (4)** Reflects the number of individuals who are disabled or incarcerated.
- Available for Work or Total Labor Force (5)** The number of enrolled tribal members on the reservation between the ages of 16-64 (column 2) minus those not available for work (column 4).
- Number Employed (6)** Those individuals working for money.
- Number Not Employed (7)** Total Work Force (column 5) minus Number Employed (column 6).
- Unemployed as % of Labor Force (8)** Number Not Employed (column 7) divided by Total Labor Force (column 5).
- Public (9)** Includes all types of government employment (local, county, state, federal, tribal)
- Private (10)** Includes all types of non-government employment.
- Total (11)** Public employment plus private employment.
- Employed, but below poverty guidelines** Working, but falling below the federal poverty guidelines established by the federal Department of Health and Human Services.

This information is posted to the Montana Department of Labor and Industry as required by HB 2, enacted by the 2003 Legislature. The Bureau of Indian Affairs collects labor market information every two years. Data is compiled and distributed in odd numbered years. 2005 data will be available around July 2007.
