2. All work shall be completed in accordance the Statement of Work (SOW), titled "Pulse Oximeters & ETCO2 Monitors", dated December 3, 2015.

#### 1.0 PURPOSE

1.1 The purpose is to provide bedside pulse oximetry and end tidal carbon dioxide ETCO<sub>2</sub> monitoring devices that will be stationed on various patient care areas at Southeast Louisiana Veterans Health Care System (SLVHCS) Medical Center, located at 2400 Canal St, New Orleans, LA 70119.

## 2.0 SCOPE

2.1 The Contractor shall provide all listed equipment. All products must meet all salient characteristics defined in this section.

### 2.2 PULSE OXIMETERS

#### SALIENT CHARACTERISTICS

2.2.1 Standalone portable bedside monitor with oxygen saturation (SpO<sub>2</sub>) and pulse rate (HR) parameters for adult monitoring. Suggested Manufacturer Brand Name: Nellcor™ Bedside Respiratory Patient Monitoring System, PM1000N OR EQUIVALENT as follows:

- 3.3 Package to prevent damage or deterioration during shipment, handling, and storage.
- 3.4 Maintain protective covering in place and in good repair until delivery is necessary.
- 3.5 Any government requested delayed delivery up to 90 days after initial negotiated delivery date, shall be at no additional cost to the Government.
- 3.6 A pre-delivery meeting will be conducted 60 days prior to initial delivery date for verification of delivery.

- 4.1 The contractor shall provide all manufacturers' warranty with products upon delivery.

(a) *North American Industry Classification System (NAICS) code and small business size standard.*
