

1. **Contracting Organization:** Department of Veterans Affairs, VISN 3, Network Acquisition and Logistics.
2. **Description of Action:** This is a request for other than full and open competition for the procurement of continued Laboratory testing with Esoterix Genetic Laboratories (Genzyme Corp).
3. **Description of Supplies or Services:** Laboratory services will include special tests performed on pathology specimens. Transaction number: 526-12-1-108-0005.





Notice of Intent for Sole Source of Esoteric Testing.

The Veterans Affairs James J. Peters Medical Center, Network Contracting Acquisitions (VISN3) intends to enter into sole source procurement Pursuant to FAR Subpart 6.302-1, with Esoterix Genetic Laboratories Inc. The period of performance will be for Fiscal Year 2012, in the estimated amount of \$250,000. Services will be performed for James J. Peters Medical Center (Bronx, New York). These test performed include Chromosome Analysis, Lymphocytic Antibodies, Cytokeratin Antibodies, Tumor Markers, Immunohistochemistry staining with 1, 2, 3 of pathological material and 4 for other antibodies as needed for correct diagnosis. The intent is for services to be continued at the Bronx location while a competitive contract is issued to include all of the following stations: Bronx, Manhattan, Hudson Valley and Northport and New Jersey. Any firm that believes it can provide the stated service to all the locations mentioned can provide supporting documents demonstrating their products capability; and specifications within five (5) calendar days from the date of publication of this notice. This procurement will be prepared in accordance with FAR Part 13, using Simplified Acquisition Procedures.
