

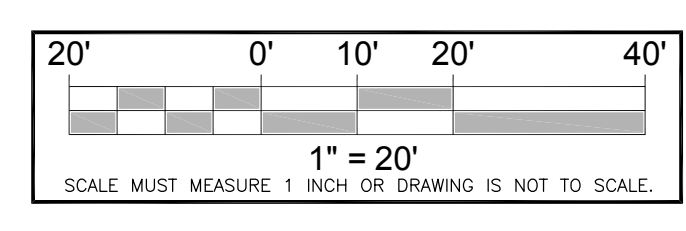
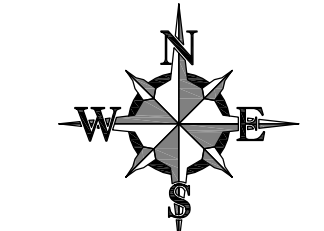


**DEMOLITION LEGEND**

**DEMOLITION NOTES**

- D1 VERIFY OPERATION OF ALL AFFECTED REMOTE CONTROL VALVE ASSEMBLIES FROM THE CONTROLLER PRIOR TO DEMOLITION. NOTE ANY REMOTE CONTROL VALVE ASSEMBLIES NOT OPERATING ELECTRICALLY FROM THE CONTROLLER AND NOTIFY THE CONTRACTING OFFICERS TECHNICAL REPRESENTATIVE IMMEDIATELY.
- D2 UNKNOWN LATERAL PIPE ROUTING. VERIFY LOCATION IN FIELD. EXCAVATE AND EXPOSE LATERAL PIPE IN APPROXIMATE LOCATION INDICATED AND CAP PIPE FOR FUTURE USE WITH SOLVENT WELD SCHEDULE 40 CAP.
- D3 UNKNOWN MAINLINE PIPE ROUTING. VERIFY LOCATION IN FIELD. EXCAVATE AND EXPOSE MAINLINE PIPE IN APPROXIMATE LOCATIONS INDICATED. REROUTE MAINLINE AND CONTROL WIRE. MOVE ALL EXISTING IRRIGATION COMPONENTS ON MAINLINE TO BE REROUTED TO NEW MAINLINE AND RECONNECT TO APPROPRIATE LATERAL AND SPRINKLERS.
- D4 EXCAVATE EXISTING IRRIGATION SPRINKLER IN APPROXIMATE LOCATION INDICATED WITHIN THE DEMOLITION BOUNDARY AND REMOVE. TURN SPRINKLER OVER TO CEMETERY MAINTENANCE SUPERVISOR ON SITE.
- D5 PROTECT EXISTING MAINLINE AND MAINLINE COMPONENTS DURING EXCAVATION OF LATERAL AND MAINLINE PIPE. CONTRACTOR IS RESPONSIBLE FOR REPAIR OR REPLACEMENT OF ANY IRRIGATION COMPONENTS OR SITE FURNISHINGS DAMAGED OR DESTROYED DURING CONSTRUCTION.
