Amendment to the solicitation issued to address the following questions from prospective vendors.

Q.1. “The solicitation does not include a Registered Professional Land Surveyor or Registered Civil Engineering Report. Spec Section 31 20 11 sections 1.4 and 1.5 have provisions for Differing Site Conditions but they are to be based on quantities identified in this report. Is there one available for the area to be worked in?”

A.1. There is no Surveyor or Engineering report. Prospective offers are encouraged to conduct a site visit prior proposal submission, see FAR Clause 52.237-1 Site Visit.

Q.2. “Estimating the size and amount of rock, slate rock or shelf rock within an area with unknown density and distribution of rock materials without such a report may lead to inaccurate estimation or over estimation of the amount of soil and rock materials to be removed. Is there a base amount of suitable fill as well as rock/slate that has been identified within the area?”

A.2. Based on excavations performed by the cemetery in the section, it is estimated that approximately 1/3 of the excavated material is rock that must be removed from the cemetery.

Q.3. “The site plan provided in Amendment 1 does not have a dimensional area of work called out or defined on it from known landmarks. Are there specific measurements of the area to be excavated within the area called out as Section 25?”

A.3. The site plan does not specifically identify the area to be excavated (approximately 9000 square feet). The portion of Section 25 to be excavated is to be coordinated with the cemetery.
