B.3 STATEMENT OF WORK (SOW)

(a). GENERAL INFORMATION

- (1) Title of Project: Window and Screen Cleaning
 - (2) Scope of Work: The contractor shall furnish all labor, travel, lodging, per diem, supervision, materials, supplies and equipment necessary to accomplish complete window and screen cleaning services at the VA St. Louis Health Care System (VA) to the buildings and the estimated number of windows and screens identified in this SOW. Services include, but are not limited to, windows (inside and outside), cleaning of window frames, screens, sills (inside and out), sashes, and replacement of any window units or fixtures damaged during accomplishment of contracted services.
 - (3) Location: Services shall be furnished on-site at the following locations:

Jefferson Barracks (JB) Division,
#1 Jefferson Barracks Drive,
St. Louis, MO 63125

John Cochran (JC) Division,
915 North Grand Ave.,
St. Louis, MO 63106
 - (4) Performance Period:
 - (A) The Contractor shall furnish the required services commencing with the effective date of award, unless otherwise directed by the CO, and shall provide the required services until the date of contract expiration.
 - (B) All windows and screens will be cleaned once a year during the month of July.
 - (5) Type of Contract: Firm-Fixed-Price.
 - (6) Extension of Contract. This contract may be extended for up to four (4) one (1) year option periods at the option of the VA in accordance with FAR 52.217-9, Option to Extend the Term of the Contract and up to six (6) months in accordance with FAR 52.217-8, Extension of Services. Notice of an extension must be served in writing by the VA prior to the scheduled expiration date. An extension may be exercised subject to the continued acceptable performance and responsibility of the Contractor, the continued requirement for services, and the availability of funds.
- (b). CONTRACT AWARD MEETING: The Contractor shall not commence performance on the tasks in this contract until the CO has conducted a kick-off meeting, or has advised the Contractor that a kick off meeting is waived.

(c). SCOPE OF WORK:

- (1) Services required: Contractor shall furnish all labor, materials, tools, supplies, supervision and equipment necessary to complete window cleaning services as described herein. The buildings and the estimated number of windows and screens that require cleaning are identified below in section (d). Services shall include, but not be limited to:
 - (A) Cleaning windows (inside and out) including screens.
 - (B) Cleaning frames, sills, and sashes (inside and out).
 - (C) Replacing screens after cleaning - note some screens are screwed in and tools will be required to remove and replace them.
 - (D) Removal and re-hanging inside blinds that may hamper cleaning.
- (2) Access tools: The Contractor shall provide all tools such as ladders, ropes, fixed and suspended scaffolding, tool extension, etc. required to access the exterior of windows and the screens.
- (3) Standards: All cleaning tasks shall be accomplished to meet all standards as follows:
 - (A) Remove all paint, dirt, soil and other substances that may be found on the windows. After cleaning windows must be streak and spot free. Screens removed for cleaning must be replaced and securely fastened. Some screens may be attached by screws that will require tools to remove.
 - (B) Any damages caused by contractor's personnel will be repaired to previously existing condition at contractor's expense.
 - (C) All work is to be performed in accordance with the guidelines established by Federal, State and Local ordinances and with contractor's procedures manual and quality control manual. Contractor must follow OSHA guidelines, policies, procedures and directives, as well as fire and safety regulations of the VA.
 - (D) Work of the contractor is to be coordinated to prevent conflicts with the treatment of patients and the functioning of the facility. No medical apparatus will be moved without approval.
 - (E) Contractor personnel must wear identifying clothing, such as caps or shirts with contractor logo while on facility grounds.
 - (F) Contract project manager is to submit to EMS, the plan for how areas/rooms are to be serviced each workday.
- (3) Rejected work: Contractor is required to re-clean where deficiencies have been noted at no additional expense to the VA. Re-cleaning is to be accomplished within five (5) working days of identification. Re-cleaning is required until the deficiency has been corrected. Payment will be withheld until all areas are cleaned to the satisfaction of the VA.
- (4) Scheduling: The contractor shall provide a written work schedule identifying when the work will be accomplished no later than the date identified in this solicitation for work to begin. For

example: A schedule identifying when work will be accomplished shall be furnished at time of contract award. All work must be scheduled through the Contracting Officer's Representative.

- (5) Invoicing and Payment. Invoices shall be submitted in arrears annually after completion and upon written acceptance of all work by the COR. Invoices will be processed as specified in section B.1. No advance or progress payments will be authorized.

- (e) **FACILITY SECURITY REQUIREMENTS.** Each day, upon arrival at the VA Medical Center all Contractor personnel shall be required to report to the VA Medical Center Police for a temporary ID. They must then report to EMS to coordinate that day's work area and at the end of the day they shall report back to EMS and report what they accomplished during that day. For the Jefferson Barracks (JB) Division, report to Bldg. 52, Room GS22. For the John Cochran (JC) Division, report to Bldg. 1, 9th Floor, Room A919.
- (f) **INSURANCE.** The Contractor shall maintain Workers Compensation, General Liability and Property Damage Liability insurance as required by the state of Missouri and contract section C.5 52.228-5 INSURANCE—WORK ON A GOVERNMENT INSTALLATION (JAN 1997) and section C.6 SUPPLEMENTAL INSURANCE REQUIREMENTS.

(g) **SPECIAL REQUIREMENTS.**

(1). Hours of Coverage:

(A). The contractor will provide all required services within the normal business hours (7:00 AM to 4:30 PM (CST) M-F).

(B). All services shall be performed during these normal hours of coverage unless the contractor wishes to furnish services at a time that is outside of the normal hours of coverage, at no additional cost to the Government, the contractor submits a request to the COR prior to the proposed start of the work, and the request is approved in writing by the COR before work is begun.

(2). Exposure to blood borne or infectious material: There is a potential for exposure to blood borne or other infectious material with surfaces throughout the medical centers. All Contractor personnel must use the "Universal Precautions" (i.e. decontamination of medical equipment, wearing protective gloves, aprons, and goggles) during cleaning and maintenance/repair procedures.

(3). Identification, parking, smoking and VA regulations:

(A). Contractor's personnel shall wear visible identification at all times while on the premises of the VA. Identification shall include, as a minimum, the employee's name, position, and the contractor's trade name.

(B). It is the responsibility of the contractor to park in the appropriate designated parking areas. Information on parking is available from VA Police Service. VA will not

invalidate or make reimbursement for parking violations of the contractor under any conditions.

(C). Possession of weapons is prohibited. Enclosed containers, including tool kits, shall be subject to search. Violations of VA regulations may result in citation answerable in the United States (Federal) District Court, not local district, state, or municipal court.

(D). Smoking is prohibited inside all VA buildings.

(4). Required registration with Contractor Performance Assessment Reporting System (CPARS):

(A). As prescribed in Federal Acquisition Regulation (FAR) Part 42.15, the Department of Veterans Affairs (VA) evaluates Contractor past performance on all contracts that exceed \$150,000, and shares those evaluations with other Federal Government contract specialists and procurement officials. The FAR requires that the Contractor be provided an opportunity to comment on past performance evaluations prior to each report closing. To fulfill this requirement VA uses an online database, CPARS, which is maintained by the Naval Seal Logistics Center in Portsmouth, New Hampshire. CPARS has connectivity with the Past Performance Information Retrieval System (PPIRS) database, which is available to all Federal agencies. PPIRS is the system used to collect and retrieve performance assessment reports used in source selection determinations and completed CPARS report cards transferred to PPIRS. CPARS also includes access to the federal awardee performance and integrity information system (FAPIIS). FAPIIS is a web-enabled application accessed via CPARS for Contractor responsibility determination information.

(B). Each Contractor whose contract award is estimated to exceed \$150,000 is required to register with CPARS database at the following web address: www.cpars.csd.disa.mil. Help in registering can be obtained by contacting Customer Support Desk @ DSN: 684-1690 or COMM: 207-438-1690. Registration should occur no later than thirty days after contract award, and must be kept current should there be any change to the Contractor's registered representative.

(C). For contracts with a period of one year or less, the contracting officer will perform a single evaluation when the contract is complete. For contracts exceeding one year, the contracting officer will evaluate the Contractor's performance annually. Interim reports will be filed each year until the last year of the contract, when the final report will be completed. The report shall be assigned in CPARS to the Contractor's designated representative for comment. The Contractor representative will have thirty days to submit any comments and re-assign the report to the VA contracting officer.

(C). Failure to have a current registration with the CPARS database, or to re-assign the report to the CO within those thirty days, will result in the Government's evaluation being placed on file in the database with a statement that the Contractor failed to respond.

(h) IT SECURITY REQUIREMENTS. IT Security requirement will not apply to this contract.

(i) CONTRACT ATTACHMENTS. The following attachment has been provided in Section D and is applicable to this contract: Attachment (1) – Wage Determinations Incorporated by Reference. Most current Wage Determinations as published by the Dept. of Labor. Furnished to provide the Contractor information on the minimum wages that must be paid to Contractor personnel in accordance with the Service Contract Act of 1965.

(b) *General.* (1) Offers are solicited only from service-disabled veteran-owned small business concerns. Offers received from concerns that are not service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a service-disabled veteran-owned small business concern.

(c) Agreement. A service-disabled veteran-owned small business concern agrees that in the performance of the contract, in the case of a contract for:

(1) Services (except construction), at least 50 percent of the cost of personnel for contract performance will be spent for employees of the concern or employees of other eligible service-disabled veteran-owned small business concerns;

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.
