This addenda modifies the original solicitation by incorporating the following questions and answers into the solicitation:

QUESTION #1 – Are these services currently being performed under contract?

ANSWER #1 – No. These services were previously being provide under contract VA255-13-C-0138 commencing 07-01-2013. The contract ran for one year but was not extended for the 2014 option year due to lack of funding. The windows and screens have not received routine cleaning since that time.

QUESTION #2 - How may a site visit be arranged? Who is the point of contact?

QUESTION #3 - What is the maximum window height to be accessed (John Cochran)?

ANSWER #3 - figure 115ft from the lowest finished grade. For information, the facility has stated that there are 135ft JLG (portable self-propelled all-terrain boom lifts) available for commercial rental in the area that will accommodate the required height.

QUESTION #4 - Are structural anchors in place to support scaffolding?

ANSWER #4 - There are no structural anchors to support scaffolding from the many roofs.

QUESTION #5 - Is the Attachment 1 Wage Determination available?
