ECorp archaeologists also identify historic archaeological sites including homesteads; agricultural or ranching features; mining-related features; water storage and conveyance features such as culverts, reservoirs, and dams; and refuse concentrations. ECorp archaeologists excavate archaeological sites in order to evaluate their significance and to recover data as mitigation of impacts.

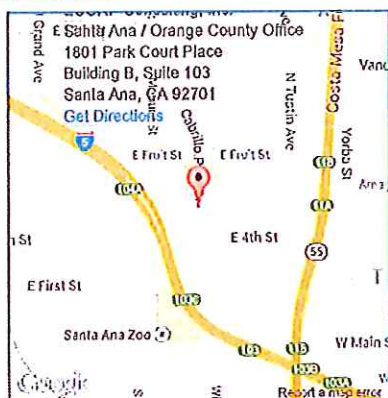
