

ATTACHMENT 4 – POTENTIAL DEMONSTRATION CRITERIA

1. Search for laws in different languages. Ex. PR Law 408 (Involuntary Commitment) in Spanish and English.
2. Can your system search foreign law and does it provide translation?
3. Searching legislative history for both simple and complex bills - for example, a bill naming a VA facility (e.g., H.R. 2814) versus the Affordable Care Act (PL 111-148 and PL 111-152).
4. The ability to conduct a terms and connectors search of the entire legislative history for any given public law. Currently, the user has to download and search through each document from the congressional record individually.
5. Comparable cases within 5 years by injury type with breakdown of allocated damages
6. Ability to access specific state practice manuals
7. Access to state pattern jury instructions
8. Ability to cross-reference to state legislative materials where damages cap increases are linked yearly to legislative adjustments.
9. Search of state case law for fiduciary appointments for veterans
10. Search of briefs on apportionment of veteran's disability compensation
11. I have a contract for severable services with various options. What Fiscal Year funds can I use for the base or option years? Can I incrementally fund contracts with multiple option years?
12. Can your system search for information about individuals? Such as locating former medical residents have relocated and are now practicing. Can I search for criminal histories, marriage records, or other information.
13. Can we perform a single global search to determine if a person had filed for bankruptcy instead of going through PACER in a Judicial District by Judicial District manner.
14. The search of MSPB case law regarding Chapter 43 cases and within-grade increases.
15. Search FMCS arbitrator statistics
16. Search MSPB case law (published and unpublished decisions)
17. Search US Court of Appeals for the Federal Circuit case law (published and unpublished decisions)
18. Search FLRA case law (published and unpublished decisions)
19. Statutory interpretation treatise
20. Search legislative history, including pending legislation that may impact a statute
21. Links to case opinions attached to relevant statutes
22. Short summaries of relevant law in decisions and opinions of Federal courts, MSPB and FLRA
23. Search regulatory history, including proposed regulations that may impact promulgated ones
24. White papers on various Federal civil service employment matters, including short summaries of relevant law
25. Ability to receive email updates on relevant case law and news articles
26. Simple search functions (e.g., Google) and Boolean search functions for advanced users

27. Ability to talk to a research librarian for assistance finding information or troubleshooting searches
28. search for state trial court opinions for MVA personal injury cases
29. Find Legislative history to explain the limitation of payment under 38 U.S.C. 5313 for incarcerated veterans, Such as why Congress chose to limit payment to certain levels.
30. Researching history of 38 CFR 4.16 (a) and specifically if there is anything in the regulation's history regarding "marginal employment"
31. find history on the definition of "active military, naval, or air service," currently codified at 38 U.S.C. § 101(24). Specifically, pre-1958 re-codification history of § 101(24)(B) and (C), regarding Reserve training periods like "active duty for training" and "inactive duty training."
32. Find House and Senate Reports for the predecessor statute for 38 U.S.C. § 1154(b) which was passed in 1941.
33. Pub. L. 104-275, the original authority for the contract examination pilot program, states that a report was to provided three years after passage on the effect and use of the contracting authority. Can you locate a copy of that report?
