3. STATEMENT OF WORK

Statement of Work

FIRE ALARM DEVICE INVENTORY SYSTEM, FIRE ALARM PANEL REPLACEMENT, AND FIRE ALARM STROBE INSTALL

I. GENERAL REQUIREMENT

1. Contractor shall install Honeywell Notifier Fire Alarm Equipment for 226 each required Notifier Fire Alarm Strobes, all required Notifier Field Charger Power Supplies (FCPS), Notifier Fire Alarm Speakers, Notifier Fire Alarm Smoke Detectors and Notifier Control/Relay Modules. All Cabling and Electrical Connections are required to be installed in Conduit Raceways, including Fire Alarm Network connections of existing and remaining Notifier Fire Alarm System.
2. Contractor shall deliver materials to install a Fire Alarm Inventory, Tagging, and Inspection Reporting System
3. Contractor shall replace obsolete Fire Alarm Panels (3 ea.), Fire Alarm Devices, and cabling including network connections whose specifications are described in detail below.
4. Contractor shall provide the following:-
 - All Fire Alarm materials to be delivered to the Michael E. DeBakey VA Medical Center (MEDVAMC) just prior to installation and contractor will be required to provide storage container(s) while MEDVAMC will provide space for onsite placement of the storage container(s).
 - Deliver Shop Design Drawings, Amperage Draw Calculations, and Device Schedules for all installed wiring, panels, devices, wiring terminations, Fire Alarm Strobes, Speakers, Field Charger Power Supplies, including all existing and remaining devices/wiring to the Contracting Officer (CO), Resident Engineer (RE), and Contracting Officer's Representative (COR) for review and approval prior to proceeding with delivery and installation.
 - Ensure panel and device installations are installed according to ALL NFPA Codes.
 - Ensure all panels shall be compatible with existing Notifier ONYX Series Panel NOTI-FIRE-NET Network and all panels and related hardware shall be furnished by a Honeywell Notifier manufacturer who has regularly engaged in the manufacturing of such products for a minimum of five (5) years, and shall be of premium grade material, construction, finish, and manufactured in 2016 model year or later.
 - Review daily work progress during construction and communicate with the Contracting Officer's Representative (COR) for any requirements for Fire Alarm Panels and Software installation and Programming.
 - Tag ALL installed devices and program into Existing Fire Alarm Inventory System
 - Provide Honeywell Notifier Training Certification and Licensing for the hardware, software and programs associated with all Fire Alarm System installation.

- Ensure contractor staff shall not enter any government building without the approval and escort of the COR.

II. SPECIFIC CONTRACT WORK REQUIREMENTS

1. Notifier Fire Alarm System Devices

All devices installed shall be installed and work with existing Fire Alarm System panels and components.

2. All Devices and Circuits

Contractor shall:

- Install Notifier Strobes, Speakers, Smoke Detectors, and Power Supplies
- Install all wiring in ¾" or larger Conduit Raceways
- Submit recommended Inspection intervals and schedules for all devices installed

3. Fire Alarm Panel Programming and Field Charger Power Supply (FCPS)

Contractor shall:

- Install Notifier Panels and Notifier FCPS matching existing panels on network
- Connect all panels, devices, and modules to existing Fire Alarm Panel Network and program into system
- Ensure all wiring shall be run in conduit raceways
- Install the maximum applicable Ampere Hour (AH) Back-up batteries for each panel
- Update software versions of existing panels and hardware to match newly installed panels' software versions
- Ensure all panels on the Fire Alarm Network have the same Software Versions
- Test all installed devices and panels for proper function and Synchronization of Strobes
- Test and document Speakers and Smoke Detectors

4. Fire Alarm System Tagging and Inspection

Contractor shall:

- Tag ALL Fire Alarm devices including Strobes, Speakers, Flow and Tamper Switches, Door Locks and Door Holders, Pull Stations, Sprinkler Heads and Sprinkler Components including all auxiliary equipment and provide two (2) Scanner Modules for recording actual visual inspections with photo recording capabilities for documentation
- Install a Centralized Inspection Computer Work Station with monitor to Track/Monitor and Control Fire Alarm System Devices, generate Reports, and track all Fire System Events and Inventory.
- Ensure all recorded data shall be sent to local primary database on Fire Alarm Computer Work Station network.
- Ensure system shall generate repair recommendations and schedules.

5. Fire Alarm Panel and Device Installation

Contractor shall:

- Install Notifier Panels matching existing panels on network
- Connect all panels to existing Fire Alarm Panel Network
- Ensure all wiring shall be run in conduit raceways
- Install the maximum applicable Ampere Hour (AH) Back-up batteries for each panel

- Update software versions of existing panels and hardware to match newly installed panels' software versions
- Ensure all panels on the Fire Alarm Network have the same Software Versions
- Ensure Network cards of all existing panels will be upgraded to digital high speed network cards, repeaters, and upgraded network wiring connections if required
- Test all installed devices and panels for proper reporting and function

8. **Location of Work**

MEDVAMC located at 2002 Holcombe Boulevard, Houston, Texas 77030.

9. **Materials and Workmanship**

All new material becomes the property of the Government. When requesting approval, the contractor is required to provide full information concerning the material or articles. When directed to do so, the contractor shall submit samples for approval at the contractor's expense, with all shipping charges prepaid. The Contracting Officer may require, in writing, that the contractor remove from the workplace any employee the Contracting Officer deems incompetent, careless, or otherwise objectionable. All work under this contract shall be performed and accomplished by competent and experienced personnel who are trained and certified by the manufacturer of the model listed in this contract. The contractor can be required to furnish valid proof of this training and certification as well as related work experiences as one of the bidder's qualifications for the offer to be considered.

10. **Inspection of Materials and Articles**

Notwithstanding any other terms and conditions of this contract,

- Inspection of materials and articles furnished under this contract will be made at the site by the COR or his designee, unless otherwise provided for in the specifications.
- Final inspection will not be made until the contract work is ready for beneficial use or occupancy. The contractor will be required to notify the Contracting Officer, through the COR, prior to the date on which the work will be ready for final inspection.

11. **Safety Requirements**

In the performance of this contract, the Government is seeking a contractor who can take such safety precautions as the Contracting Officer, or his/her designee, may determine to be reasonably necessary to protect the lives and health of occupants of the building. The contractor will be required to have one supervisory employee, who will disseminate requirements to those who work at our facility, report to the Safety Manager's office for a one- (1) time training class before working on-site. The Contracting Officer or his/her designee will notify the contractor of any noncompliance with the foregoing provisions and the action to be taken. The contractor, after receipt of such notice, will be required to immediately correct the conditions to which attention has been directed. Such notice, when served on the contractor or his representative at the site of work, shall be deemed sufficient for the purpose aforesaid. If the contractor fails or refuses to comply promptly with such notice, the Contracting Officer may issue an order stopping all or any part of the work and hold the contractor in default.

12. **Progress Schedule**

The Contractor shall submit with the quote, a progress schedule that indicates the anticipated progress toward installation/completion of work versus the elapsed contract time, for the approval of the Contracting Officer Representative.

13. **Submittals**

The Contractor shall submit two (2) copies of material, serial numbers, operation and installation manuals, cut sheets, device lists, and equipment submittal catalogs data for approval.

14. **Work Schedule**

Work hours: work hours are normally 8:00 A.M. - 4:30P.M., weekdays excluding Federal holidays.

(Contact COR for approval to work outside these hours).

Federal holidays: Without prior approval from the COR no work shall be performed on these days. The ten Federal holidays are:

If a holiday falls on Saturday or Sunday it is observed on Friday or Monday, respectively and no work shall be performed on these days without prior approval.

15. Utility Interruptions

The Contractor shall coordinate any planned utility shutdowns with the COR. Contractors shall not work on energized circuits. Only testing of energized circuits is authorized, provided that proper ARC Flash Hazard PPE is worn. The contractor will be required to notify the Electric Shop (phone: 713-794-7591 or 713-791-1414 X-25884) immediately if Electrical Circuits are accidentally interrupted.

16. Warranty

The warranty should at a minimum include, but may not be limited to the following:-

- i. In addition to any other warranties in this contract, the contractor warrants, except as provided in paragraph (i) of this clause, that work performed under this contract conforms to the contract requirements and is free of any defect in equipment, material, or design furnished, or workmanship performed by the contractor or any subcontractor or supplier at any tier.
- ii. This warranty shall continue for a period of **one (1) year** from the date of final acceptance of the work. If the Government takes possession of any part of the work before final acceptance, this warranty shall continue for a period of 1 year from the date the Government takes possession.
- iii. The contractor shall remedy at the contractor's expense any failure to conform, or any defect. In addition, the contractor shall remedy at the contractor's expense any damage to Government-owned or controlled real or personal property, when that damage is the result of—
 1. The contractor's failure to conform to contract requirements; or
 2. Any defect of equipment, material, workmanship, or design furnished.
- iv. The contractor shall restore any work damaged in fulfilling the terms and conditions of this clause. The Contractor's warranty with respect to work repaired or replaced will run for 1 year from the date of repair or replacement.
- v. The Contracting Officer will notify the Contractor, in writing, within a reasonable time after the discovery of any failure, defect, or damage.
- vi. If the Contractor fails to remedy any failure, defect, or damage within a reasonable time after receipt of notice, the Government shall have the right to replace, repair, or otherwise remedy the failure, defect, or damage at the contractor's expense.

- vii. With respect to all warranties, express or implied, from subcontractors, manufacturers, or suppliers for work performed and materials furnished under this contract, the contractor shall —
 - 1. Obtain all warranties that would be given in normal commercial practice;
 - 2. Require all warranties to be executed, in writing, for the benefit of the Government, if directed by the Contracting Officer; and
 - 3. Enforce all warranties for the benefit of the Government, if directed by the Contracting Officer.
- viii. In the event the contractor's warranty under paragraph (b) of this clause has expired, the Government may bring suit at its expense to enforce a subcontractor's, manufacturer's, or supplier's warranty.
- ix. Unless a defect is caused by the negligence of the Contractor or subcontractor or supplier at any tier, the contractor shall not be liable for the repair of any defects of material or design furnished by the Government or for the repair of any damage which results from any defect in Government-furnished material or design.
- x. This warranty shall not limit the Government's rights under the Inspection and Acceptance clause of this contract with respect to latent defects, gross mistakes, or fraud.

17. Delivery Schedule

The Contractor shall deliver all materials within 12 weeks after Contractor receives the notice to proceed. Installation shall be completed **within 180 calendar days** after the date of delivery.

18. Identification Cards

PIV badging and background checks required for all contractor personnel. Allow ample time for fingerprinting, background checks, and PIV badge printing (up to 4 months) or flash badging to be determined by VA management.

19. Device Locations

Contractor shall provide Device Lists and locations will be provided by MEDVAMC.

20. Invoice and Payment

All invoices shall be submitted in arrears, properly prepared in accordance with FAR 52.212-4, contain sufficient details, and match with the service tickets for the work rendered.

a. Monthly Invoices

5. 52.203-99 PROHIBITION ON CONTRACTING WITH ENTITIES THAT REQUIRE CERTAIN INTERNAL CONFIDENTIALITY AGREEMENTS (DEVIATION) (FEB 2015)

The contractor shall obtain all necessary licenses and/or permits required to perform this work. He/she shall take all reasonable precautions necessary to protect persons and property from injury or damage during the performance of this contract. He/she shall be responsible for any injury to himself/herself, his/her employees, as well as for any damage to personal or public property that occurs during the performance of this contract that is caused by his/her employees fault or negligence, and shall maintain personal liability and property damage insurance having coverage for a limit as required by the laws of the State of Texas. Further, it is agreed that any negligence of the Government, its officers, agents, servants and employees, shall not be the responsibility of the contractor hereunder with the regard to any claims, loss, damage, injury, and liability resulting there from.

9. LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-6 Limitations on Subcontracting. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the

CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor's compliance with the limitations on subcontracting or percentage of work performance requirement.

Offeror has identified and submitted documents to illustrate processes, methods, plans, personnel, licenses permits and other resources as necessary that together demonstrate an adequate technical approach that will satisfy the requirements.

There are no significant weaknesses.

Fail: Offeror failed to submit a detailed technical and management plan describing their proposed capability and methods to manage the performance of all work and requirements in the Statement of Work (SOW). Offeror has failed to identify or submit documents to illustrate processes, methods, plans, personnel, licenses, permits and other resources as necessary that together demonstrate an adequate technical approach that will satisfy the requirements. There are no strengths and many weaknesses, or some significant weaknesses.

There are significant weaknesses.

1. Technical - The Offeror shall provide evidence of a technical and management approach to the requirements in the statement of work that shall meet the following minimum requirements:-
 - a. Offeror shall have at least five (5) years of experience testing, maintaining, repairing, diagnosing, programming, modifying and installing Honeywell Notifier Fire Alarm System.
 - b. Offeror shall submit Texas State fire alarm license(s), Honeywell Notifier training certificates and evidence of authorization letters for OEM described in statement of work.
 - c. Offeror shall submit a progress schedule (See #12 SOW)
2. Past Performance – Offeror past performance will be evaluated for responsibility purposes only. Past performance information will be reviewed in the Contractor Performance Assessment Reporting System (CPARS), and Past Performance Information Retrieval System (PPIRS) systems. Past Performance comments of Satisfactory and higher will be considered technically acceptable.
 - a. Offeror shall provide past performance information regarding relevant contracts over the past five (5) years with Federal, State, or local governments, or commercial customers. If the offeror intends to subcontract with another firm(s) for part of this requirement, that firm's past performance information shall also be provided.

If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.
