

## GENERAL NOTES

- THE CONTRACTOR SHALL REVIEW ALL DOCUMENTS AND VERIFY DIMENSIONS AND FIELD CONDITIONS AND SHALL CONFIRM THAT WORK IS BUILDABLE AS SHOWN. ANY CONFLICTS OR DISCREPANCIES SHALL IMMEDIATELY BE REPORTED TO THE ARCHITECT FOR CLARIFICATION PRIOR TO SUBMISSION OF A BID. WHEN CONTRACTOR ACCEPTS DELIVERY OF ALL ITEMS NOTED ON PLANS WHETHER IN CONTRACT OR NOT IN CONTRACT, HE SHALL BE RESPONSIBLE FOR LOSS AND/OR DAMAGE TO THESE ITEMS.
- THE CONTRACTOR SHALL MAINTAIN FOR THE ENTIRE DURATION OF THE WORK ALL EXITS, EXIT LIGHTING, FIRE PROTECTION DEVICES AND ALARMS IN CONFORMANCE WITH ALL APPLICABLE CODES AND ORDINANCES.
- ALL SAW CUTTING AND CORING LOCATIONS SHALL BE REVIEWED IN FIELD BY OWNER'S REPRESENTATIVE AND COORDINATED WITH THE OWNER PRIOR TO CUTTING/CORING.
- DURING ALL PHASES OF WORK, DO NOT DISTURB THE DELIVERIES AND FUNCTIONS OF ADJACENT AND NEIGHBORING BUILDINGS. TYPICAL SHOULD MEAN THAT THE CONDITION IS REPRESENTATIVE FOR SIMILAR CONDITIONS THROUGHOUT. UNLESS OTHERWISE NOTED, DETAILS ARE USUALLY KEVED AND NOTED TYP. ONLY ONCE WHEN THEY FIRST OCCUR.
- FIRE EXTINGUISHERS WILL BE PROVIDED BY THE VA. ARCHITECTURAL DRAWINGS WILL DEFINE T.E. LOCATIONS. CONTRACTOR SHALL PROVIDE AND INSTALL FIRE EXTINGUISHERS AND (AS APPLICABLE) WALL MOUNTED HANGERS. DO NOT SCALE DRAWINGS. WRITTEN DIMENSIONS GOVERN ALL PARTITION LOCATIONS. ALL DOOR AND OPENING LOCATIONS SHALL BE SHOWN ON FLOOR PLAN. IN CASE OF CONFLICT, NOTIFY THE ARCHITECT. FLOOR PLAN BY ARCHITECT SUPERSEDES OTHER PLANS. ALL DIMENSIONS MARKED "CLEAR" SHALL BE MAINTAINED AND SHALL ALLOW FOR THICKNESS OF ALL FINISHES INCLUDING CARPET, PAD, TILE, SHEET VINYL, WAINSCOT, ETC.
- ALL DIMENSIONS ARE TO FACE OF FRAMING OR MASONRY UNLESS COLUMN CENTER LINE (OR GRID) IS SHOWN FOR DIMENSIONING. VERIFY EXACT LOCATIONS IN FIELD.
- NOT USED.
- ALL PRODUCTS AND MATERIALS SHALL BE INSTALLED IN ACCORDANCE WITH THE MANUFACTURER'S INSTRUCTIONS UNLESS SPECIFICALLY NOTED TO THE CONTRARY.
- ALL MATERIALS AND EQUIPMENT FURNISHED BY CONTRACTORS SHALL BE NEW AND FREE FROM DEFECTS.
- MATERIALS, EQUIPMENT, ETC., NOT INDICATED ON DRAWINGS OR SPECIFIED HEREIN, BUT REQUIRED FOR SUCCESSFUL AND EFFICIENT COMPLETION OF THE INSTALLATION, SHALL BE HELD TO BE IMPLIED AND SHALL BE FURNISHED AND INSTALLED AT NO ADDITIONAL COST TO THE OWNER. NOTIFY ARCHITECT FOR CLARIFICATION OF ANY SUCH ITEMS PRIOR TO ORDERING.
- THE CONTRACTOR SHALL BE RESPONSIBLE FOR MAINTAINING THE BUILDING AND SITE, CLEANING AND PROVIDING ANY AND ALL SAFETY PROVISIONS TO ENSURE THE PUBLIC SAFETY. ALL DAMAGED WORK MUST BE REPLACED AT NO ADDITIONAL COST TO THE OWNER. CONTRACTOR IS RESPONSIBLE FOR A SITE VISIT LOG OF ALL TRADES NOT UNDER GENERAL CONTRACTOR'S CONTROL.
- WHERE REFERENCE IS MADE TO VARIOUS TEST STANDARDS FOR MATERIALS, SUCH STANDARDS SHALL BE THE LATEST EDITION AND/OR ADDENDUM, EXCEPT WHERE NOTED OTHERWISE.
