General

A New Majors Construction Project, found at 26001 Redlands Blvd, Loma Linda, CA 93254, referred to as the VA Loma Linda Ambulatory Care Center (ACC), shall be completed on or shortly after June 1, 2016. The ACC will have four buildings, three-stories each with 300,000 square feet of total space. The building is projected to hold 500 staff, 2,000 parking spaces and approximately 50% of all outpatient care visits to the VA Loma Linda Healthcare System. Spaces include private and shared offices, exam rooms, large and small group rooms, conference & training rooms, break rooms, storage rooms, lobby/waiting areas and warehouse facilities.

The purpose of this Statement of Work (SOW) is to outline the tasks and responsibilities of the successful offerors in relation to the VA Loma Linda Ambulatory Care Center (VALLACC) installation, integration, and implementation of all furnishings. All counts and specific sizes are addressed in the attached floor plans, quantity spread sheets, request for bid and salient specifications.

Due to pending completion of the ACC Building there shall be a 10% quantity margin for any variations in quantities and size.

3.1 Scope- Provide, Deliver, and Install Furniture Package 20 – Desktop Power & Accessories

3.2 Tasks

3.2.1 Product

- The vendor shall submit a cost proposal with an associated project management plan addressing the tasks associated with the SOW, as described in the evaluation criteria section. All substitute products will need written specifications and samples must be provided to be approved by VALLACC management and design team.
- Referrals on past experience on a project of this size must be submitted with cost & overall proposal.
- Subtasks not specified in the SOW will be identified and include associated costs by project task, milestones and deliverable dates.
- All written deliverables must be phrased in terms and language that can be easily understood by non-technical personnel, i.e. a person without subject matter expertise.
- All document deliverables, hard copy and electronic, must be in formats as specified-at a minimum, the formats must be in industry accepted standards.
- The vendor and/or its staff must have knowledge and expertise of the environment for which the work is to be performed.

3.2.2 Installation-The vendor shall deliver and install all furniture per floor, per building based on Bid Package Product/Specifications/Timeline. All furniture will be delivered to Building A / Freight Dock, 26001 Redlands, Blvd, Loma Linda, CA 93254. Freight elevators are to be used only for access to upper floors. Additional furniture package vendors will be installing within the same time frame.

- All furniture is to be tagged with floor/room number locations on each item.
- The installation team must be qualified furniture installers with no less than one year experience installing the products awarded.
- Installation labor will be at the rate of prevailing wage.
- Installation team must be staffed appropriately to meet the installation timeline.

- All packaging, trash and extra materials shall be removed at the end of each work day.
- Trucks cannot be left unattended and must be removed from the dock or other directed area after unloading.
- A delivery schedule will be provided to the awarded vendors.
- Project manager & vendor representative must be present on all installation days.
- Installation completion date August 31, 2016.
- Punch list items to be completed no later than 61 days after receipt of products.

3.2.3 Project Management Plan

- The vendor shall provide a Project Management Plan to document procedures, schedules and time lines for delivery and installation.

3.3 Acceptance/Period of Performance

- Spring to Fall 2016

3.4 Vendor Responsibilities

- Any damage to the ACC facility incurred through the installation process must be repaired within 30 days at the furniture vendor's expense
- The vendor shall be responsible for any and all liability actions or suits when the vendor is at fault or negligent in the performance of installation period. Pecuniary liability is also included for any and all damages to VA buildings and equipment caused by installation activities. The vendor shall comply with all local building and fire codes in addition to VA policy and procedures at the site.
- The vendor shall operate under, but not limited, to the following national codes, telecommunications industry standards and practices: Americans with Disabilities Act (ADA), and National Fire Protection Association (NFPA).
- Prior to commencing work, vendor shall provide proof that a OSHA certified "competent person" (CP) (29 CFR 1926.20 (b) (2) will maintain a presence at the work site whenever the installers are present.
- Design changes and modifications presented as an addition by the vendor shall be the responsibility of the vendor.
- Vendor is responsible to attend a mandatory kick-off meeting held at the ACC or designated location. The date and time to be scheduled by the VALLACC. ACC management and design team will meet the vendor and its staff. Schedules will be reviewed and confirmed at this time.
- Deliveries and installation must be scheduled through ACC management and interior design team.

3.5 VALLACC Responsibilities

- Provide Masonite or floor cover, corner guards and other protective covering for delivery of furniture
- Any necessary painting or patching as specified in the original design.
- Any modifications or changes to the vendor's design to accommodate additional VA equipment.
- THE VHALLACC shall provide the vendor a list of key personnel associated with the project along with the name and contact information for the POC/Project Manager.
- The Project Manager shall provide access to the appropriate personnel (technical, subject matter expertise, etc.) necessary to fulfill the vendor's requirements in a timely fashion.
- The VHALLACC shall provide the vendor with detailed electronic drawings of the finished, installed project.

3.6 Travel

- All travel shall be responsibility of the vendor.
- Whenever possible, conference calls and video conferencing should be used.

3.7 Security

- Vendor is responsible for registering with the VA Police upon entrance and exit of the building. Vendor is responsible for notifying ACC management and interior design team in advance of arrival and departure, providing review of all product and site conditions before sign off.

3.8 Completion Date-The vendor shall have all services rendered and equipment received no later than 91 working days from the date of Contract Award and receipt of Contract Award.

B.4 PACKAGING AND MARKING

4.1 Marking

- 4.1.1 All items shall be marked clearly with the Contract Number, Delivery Order Number, Obligation number and delivery location within the hospital ie. Emergency-Room.

4.2 Packaging

- 4.2.1 All equipment and supplies shall be adequately packaged to prevent damage during shipping, handling and storage. Bags or packages shall be whole, intact, and not otherwise torn or damaged. Upon delivery, the Government shall examine all packages. The contractor shall be required to replace unacceptable or damaged products at the contractor's expense.

B.5 DELIVERIES, ORDERING & PERFORMANCE

5.1 Ordering:

- 5.1.1 The VA will submit a delivery order using Standard Form (SF) 1449. The contractor shall provide all supplies contained in the purchase order provided by the VA. Contractors shall not ADD or SUBSTITUTE components without prior approval from the CO responsible for the delivery order. All items provided by the contractor shall be new.

5.2 Delivery

- 5.2.1 The contractor will ship to the location listed in block 15 of the delivery order SF 1449 unless prior approval is received in writing by the CO.
- 5.2.2 Delivery schedules will be discussed with the Contracting Officer within seven (7) calendar days after receipt of a delivery order unless prior approval is received in writing by the CO.
- 5.2.3 The contractor must have the capability to receive order via facsimile transmission if necessary. The Government will generally submit all purchase orders to the contractor via email.
- 5.2.4 In the event the Government requires expedited delivery, the VA will contact the contractor and inquire into the feasibility of obtaining this condition. The contractor shall respond within twenty-four (24) hours of the request. An expedited delivery date shall be mutually agreed upon between the contractor and the VA.

5.2.5 All deliveries will be made Freight on Board (FOB) destination.

This factor will be used to determine if the proposed equipment meets or exceeds the technical specifications of the current equipment in use at the medical center. Supplies submitted as equal to the brand and model listed within the schedule shall be accompanied with technical brochures outlining their specifications and how they meet the salient characteristics outlined in section B and the attachments.

2. Factor 2- Project Management Plan (PMP):

Award may be made without discussion.

E.3 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS— COMMERCIAL ITEMS (APR 2016)

The offeror shall complete only paragraph (b) of this provision if the offeror has completed the annual representations and certifications electronically via <http://www.acquisition.gov>. If an offeror has not completed the annual representations and certifications electronically at the System for Award Management (SAM) website, the offeror shall complete only paragraphs (c) through (r) of this provision.

(a) *Definitions.* As used in this provision—

“Economically disadvantaged women-owned small business (EDWOSB) concern” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

- (1) Means a small business concern—
 - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
 - (ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.
- (2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Small disadvantaged business concern”, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

- (1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—
 - (i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and
 - (ii) Each individual claiming economic disadvantage has a net worth not exceeding \$750,000 after taking into account the applicable exclusions set forth at 13 CFR 124.104(c)(2); and
- (2) The management and daily business operations of which are controlled (as defined at 13.CFR 124.106) by individuals, who meet the criteria in paragraphs (1)(i) and (ii) of this definition.

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

“Successor” means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name.

The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

“Veteran-owned small business concern” means a small business concern—
