

JUSTIFICATION FOR SINGLE SOURCE AWARDS IAW [FAR 13.106-1](#)
(OVER MICRO-PURCHASE THRESHOLD(\$3.5K) BUT NOT EXCEEDING THE SAT (\$150K))

IAW [FAR13.104](#), COs must promote competition to the maximum extent practicable to obtain supplies and services from the source whose offer is the most advantageous to the Government, considering the administrative cost of the purchase. When competition is not practicable, IAW [FAR13.106-1\(b\)](#), COs solicit from a single source for purchases not exceeding the simplified acquisition threshold. Brand Name Justifications:

It is essential to the Government that they purchase the NetApp equipment, since to expand an existing NetApp system, currently being used by VA Pittsburgh Healthcare system, NetApp and its resellers are the only sources capable of providing the hardware upgrades, hardware support, increased storage capacity, and annual software maintenance for the entire infrastructure to function properly and securely. Additionally, no other products are interoperable or compatible with the currently fielded NetApp infrastructure. Specifically, the current storage system communicates through a source code that is based on NetApp's proprietary ONTAP Operating System. No other products can provide the increased storage and provide the support that integrates into VA's current environment without access to that source code." (See email from NetApp, under P02 of the Procurement Action Briefcase, in the eCMS Contract File).

It is essential to the Government, It is essential to purchase a new computer hardware backup storage device, which comes preconfigured to work with Commvault Software, since this equipment is needed to connect to an existing backup storage system that is running Commvault Software, and no other company's preconfigured hardware would be compatible with the existing Commvault software.(See email from Commvault under P02 of the Procurement Action Briefcase in the eCMS Contract File).

It is also essential to purchase the NetApp and CommVault equipment, and have it installed, by the same Contractor, to avoid delays in installation, in order to ensure timely use of both pieces of equipment, since the Commvault licenses are needed to utilize the NetApp Storage equipment being purchased.

Justification for turnkey furnish and install requirement:

The above needed equipment is not sold on the Federal Supply Schedule, and since there is more than one source to purchase this equipment from, and who can have it installed, this requirement will be competed in the Open Market.

4. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:

Written confirmation in the form of an email, from NetApp and CommVault, that confirms no other company's equipment will be compatible with the existing NetApp hardware, and the hardware that is running Commvault software.

Google Search was conducted using the words "NetApp" and "CommVault" and using Product No.s, and no matches came up other..

Search of the VA Vetbiz VIP was conducted, suing the words "NetApp" and "Commvault and no matches were found.
