

**Statement of Work**  
**Install Components on Security Camera System**

1. **Overview** The Contractor for the Sheridan VA Medical Center in Sheridan, Wyoming shall supply and install the equipment on the Bill of Material below; Contractor shall install and configure multiplexor and fiber interconnections from Bldg 86 to VA Police Office. Interconnect 19 existing cameras (6 in VCS store and 13 in SNU) in Bldg 86 to new VA PD DVR for real-time monitoring and recording in VA PD. This system will piggy back off the existing Bldg 86 cameras and monitors (leaving intact) and relay duplicate video signal to VA PD from the cameras. Contractor shall install and configure multiplexor and fiber interconnections from Bldg 6 to VA Police Office. Interconnect 15 existing cameras in Bldg 64 to new VA PD DVR for real-time monitoring and recording in VA PD. This system will piggy back off the existing Bldg 64 cameras and monitors (leaving intact) and relay duplicate video signal to VA PD from the cameras. Contractor shall install and configure multiplexor and fiber interconnections from Bldg 6 to VA Police Office. Interconnect 16 existing cameras in Bldg 6 to new VA PD DVR for real-time monitoring and recording in VAPD. This system will piggy back off the existing Bldg 6 cameras and monitors (leaving intact) and relay duplicate video signal to VAPD from the cameras. Contractor shall install and configure multiplexor and fiber interconnections from Bldg 71 to VA Police Office. Interconnect two (2) existing cameras in Bldg 71 to VA PD DVR for real-time monitoring and recording in VA PD. Contractor shall install and configure multiplexor and fiber interconnections from Bldg 61 to VA Police Office. Interconnect one (1) existing cameras in Bldg 61 to VA PD DVR for real-time monitoring and recording in VA PD
  
2. **Equipment Warranty:** Contractor shall warrant products sold under this agreement for a period of one (1) year from date of purchase. Contractor's obligation under this warranty is limited to repairing or replacing any part of the products sold under this agreement that we agree is defective in materials or workmanship under normal use and service during the warranty period.
  
3. **The Contractor will have access to VA sensitive information and a VA form 6500 appendix A must be completed.**
