2. All work shall be completed in accordance the Statement of Work (SOW), titled “Portable Dental Unit”, dated June 2, 2016.

1. PURPOSE

- 1.1 The purpose is to provide Portable Dental Units at Southeast Louisiana Veterans Health Care System (SLVHCS), Central Energy Plant building, 2400 Canal St, New Orleans, LA 70119.

2. SCOPE

2.1 The Contractor shall transport all listed equipment. All products must meet all salient characteristics defined in this section.

2.2 All equipment must meet manufacturers and VA specifications.

2.3 The Contractor shall furnish all supplies, equipment, facilities and services required for delivery of the supplies and equipment.

2.4 The Contractor is responsible for any missing parts and components not included.

3. DELIVERY

3.1 Contractor shall deliver all equipment to the Southeast Louisiana Veterans Health Care System (SLVHCS) Central

Energy Plant building, 2400 Canal St, New Orleans, LA 70119 on August 31, 2016.

3.2 Deliver materials to job in manufacturer's original sealed containers with brand name marked thereon.

- 3.3 Package to prevent damage or deterioration during shipment, handling, and storage.
- 3.4 Maintain protective covering in place and in good repair until delivery is necessary.
- 3.5 Any government requested delayed delivery up to 90 days after initial award delivery date, shall be at no additional cost to the Government.
- 3.6 A pre-delivery meeting will be conducted 60 days prior to initial award delivery date for verification of delivery.

4. INSPECTION AND ACCEPTANCE:

- 4.1 The Contractor shall conduct a joint inspection with the COR upon delivery of Portable Dental Units.
- 4.2 Contractor shall provide dates of completion of punch list items and replacement parts and/or short ship items from the manufacturer(s).

- 5.2 Deliver compilation of all manufacturer recommended maintenance schedule and operation materials packaged in binder(s) to COR upon completion of installation.

6. SECURITY REQUIREMENTS

- 6.1 The Authorization & Accreditation (A&A) requirements do not apply and a Security Accreditation Package is not required.

7. WARRANTY

- 7.1 The contractor shall provide minimally a one year manufacturer's warranty on all parts and labor.
- 7.2 The warranty shall include all travel and shipping costs associated with any warranty repair.

- 8. The system must permit maintenance professionals the ability to perform diagnostics, troubleshooting, and maintenance as required.

- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;

(8) PSC 9610, Ores;

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—
