B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes . Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Accordingly, to insure that sufficient information is available, the bidder must furnish as a part of his/her bid all descriptive material (such as cuts, illustrations, drawings or other information) necessary for the purchasing activity to:

(i) Determine whether the product offered meets the salient characteristics requirement of the Invitation for Bids, and

(ii) Establish exactly what the bidder proposes to furnish and what the Government would be binding itself to purchase by making an award. The information furnished may include specific references to information previously furnished or to information otherwise available to the purchasing activity.

(2) If the bidder proposes to modify a product so as to make it conform to the requirements of the Invitation for Bids, he/she shall:

(i) Include in his/her bid a clear description of such proposed modifications, and

(ii) Clearly mark any descriptive material to show the proposed modifications.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Small disadvantaged business concern”, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

“Successor” means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

“Veteran-owned small business concern” means a small business concern—

FUNCTIONAL PERFORMANCE SPECIFICATION

1.1 Background

- A. The Fargo VAMC, Laboratory and Pathology department has a requirement for the equipment and installation of modular component systems. Device locations and arrangements are indicated on "Exhibit 1 – Plan Drawing". Installation must be coordinated with other equipment and systems in the space shown. The construction project preparing the site for this equipment was designed and constructed based on the referenced furniture below. Therefore the facility is seeking a procurement to ensure full compatibility of the products with the building systems as designed, thus eliminating the risk to the Government of increased costs and delays to the construction project, and ultimately service to the Veterans.
- B. An on-site visit to review the proposed space is **HIGHLY** recommended. A shop drawing will need to be provided as part of the quote with dimensions of all utilities and mounting locations. Additionally, all equipment will be reviewed by the facility to ensure that the offered equipment can be installed without further modification to the installation site.

2.1 Description & Salient Characteristics:

- A. ***THIS IS A BRAND NAME OR EQUAL PROCUREMENT.*** The basis of this specification is a modular component system manufactured according to the standards used by Kewaunee Scientific Corporation, 2700 Front Street, Statesville, North Carolina. The specified design is ENTERPRISE. All steel components covered by the specification shall be the product of one manufacturer and be fabricated at one geographic location in the United States to assure shipping continuity and single-source responsibility.
- B. Materials
 - 1. General Requirements: High quality adjustable and moveable system made from high quality cold rolled steel that is prime grade
 - 2. Sheet Steel: Roller leveled, and shall be treated at the mill to be free of scale, ragged edges, deep scratches or other injurious effects. All U.S. Standard gauges.

2.2 Modular Component System

- A. Construction
 - 1. Freestanding workstation system shall be comprised of Work Surface Support Frames adjustable from 31" to 37" AFF, and a Rear Frame Support Structure, single or double sided, incorporating a vertical post and horizontal support. The vertical supports shall incorporate individual slots for adjustable shelving and accessories. The vertical support shall incorporate a chase for plumbing and wiring of services.
 - a. Work surface Support Frame:
 - 1) Welded four sided assembly consisting of 11 gauge steel channel formations, front adjustable legs, and rear attachment collars. Nominal lengths are 42", 48", 60", 72" and 96".
 - 2) Adjustable height shall be 31" to 37" AFF including 1" work surface
 - 3) Front leg members shall be 11 gauge steel tubes, 2" outside diameter and 1.75" inner telescoping leg capable of vertical adjustment in 2" increments
 - 4) Legs shall include non-marring, 3/8" diameter, levelers
 - 5) Rear corners shall have 2.25" diameter x 6" high, 11 gauge half-round collars welded to the work surface frame with supporting gussets and shall be mechanically fastened to the rear upright supports with Button head socket cap screws.
 - 6) Load rating shall be 100lbs per linear foot of length to a maximum of 800 lbs. With Uniformly distributed load, the maximum allowable deflection shall be .125" measured at the center of the front rail.
 - 7) An optional full length horizontal rear cabinet stop shall be located under the work surface frame to position 24" deep mobile base cabinets 1" behind the front edge of the work surface
 - b. Double-sided rear frame support structure:
 - 1) The rear frame support structure shall be 84" in height and available in nominal lengths of 42", 48", 60", 72" and 96".
 - 2) Rear frame support structures shall consist of four (4) 2" diameter full height vertical members, connected with a horizontal framing assembly that incorporates upper and lower horizontal cross rails. The upper cross rail shall provide a utility trough the full length of the

table. The lower cross rail shall support integral double sided electrical and central plumbing raceway containing plumbing, electrical and data. Plumbing lines and wiring shall feed through a 6" vertical member centered between the full height vertical members. The 6" vertical member and the lower horizontal member shall have easily removable access panels, with no exposed fasteners. For 42" and 48" tables, the center vertical member may be eliminated if plumbing fittings are not required in the horizontal lower member, allowing for full length shelves.

- 3) In addition to the horizontal framing structure, the 2" vertical members each and a duplex electrical receptacle located below the worksurface.
 - 4) Each vertical member shall include non-marring 3/8" diameter, levelers.
 - 5) The vertical members shall have shelf/accessory slots punched on 1" increments starting at 55" above AFF to top of upright.
- c. Single-sided Rear Frame Support Structure
- 1) The rear frame support structure shall be 84" in height and available in nominal lengths of 42", 48", 60", 72" and 96".
 - 2) Rear frame support structures shall consist of two (2) 2" diameter tube vertical members, with horizontal framing members. The vertical members shall allow the installation of service fittings.
 - 3) The vertical members shall be able to accommodate up to three services each and a duplex electrical receptacle or data outlet.
 - 4) Vertical members shall include non-marring, 3/8" diameter, levelers.
 - 5) All rear frame support structures in widths of 60" wide and over shall have a center support to accommodate split shelving.
 - 6) The vertical members shall have shelf/accessory slots punched on 1" increments on the front starting at 55" above AFF to top of upright.
 - 7) Rear frame support structures shall incorporate upper and intermediate horizontal cross rails. The intermediate cross rail shall support an integral two channel raceway with removable access panel. The raceway can be specified with electrical & data as required.

2.3 Molded Epoxy Resin Worksurface and Sink

- A. Materials: Counter tops shall be as indicated on the drawings and all clips, screws and parts for fastening top to table frame and/or cabinet shall be included.
1. Worksurface: Molded epoxy resin tops (KEMRESIN) shall be molded from a modified epoxy resin that has been especially compounded and cured to provide the optimum physical and chemical resistance properties required of a heavy-duty laboratory table top. Tops and curbs shall be a uniform mixture throughout their full thickness, and shall not depend upon a surface coating that is readily removed by chemical and/or physical abuse. Tops and curbs shall be non-glaring, black, grey, or slate color to be selected. Table tops shall be 1 inch thick, with drip grooves provided on the underside at all exposed edges.
 2. Sinks: Molded epoxy resin, carefully compounded with selected materials to provide maximum physical and chemical properties. Sinks shall be non-glaring with all inside corners coved and the bottom pitched to the drain outlet. Sinks shall possess a high resistance to mechanical and thermal shock. Sinks shall be 11 inches deep.

2.4 Sink Service Fittings and Accessories: Not in this contract.

2.5 Electrical Service Accessories

- A. Power bar electrical fixture:
1. Custom three compartment configuration for power, emergency power and data.
- B. Ceiling service panel:
1. Size: 2' x 2'
 2. Quantity: Ten (10)
 3. Receptacle types, quantities, and configurations: To be determined.
- C. Blank panel for mechanical exhaust:
1. Size: 2' x 2'
 2. Quantity: Two (2)

2.6 Finish and Performance Requirements

A. Steel Paint System Finish and Performance Specification:

1. **Steel Paint System Finish:** After the component parts have been completely welded together and before finishing, they shall be given a pre-paint treatment to provide excellent adhesion of the finish system to the steel and to aid in the prevention of corrosion. Physical and chemical cleaning of the steel shall be accomplished by washing with an alkaline cleaner, followed by a spray treatment with a complex metallic phosphate solution to provide a uniform fine grained crystalline phosphate surface that shall provide both an excellent bond of the finish and enhance the protection provided by the finish against humidity and corrosive chemicals. After the phosphate treatment, the steel shall be dried and all steel surfaces shall be coated with a chemical and corrosion-resistant, environmentally friendly, electrostatically applied powder coat finish. All components shall be individually painted, insuring that no area be vulnerable to corrosion due to lack of paint coverage. The coating shall then be cured by baking at elevated temperatures to provide maximum properties of corrosion and wear resistance. The completed finish system in standard colors shall meet the performance test requirements specified under PERFORMANCE TEST RESULTS.
2. **Performance Test Results (Chemical Spot Tests):**
 - a. **Testing Procedure:** Chemical spot tests for non-volatile chemicals shall be made by applying 5 drops of each reagent to the surface to be tested and covering with a 1-1/4" dia. Watch glass, convex side down to confine the reagent. Spot test of volatile chemicals shall be tested by placing a cotton ball saturated with reagent on the surface to be tested and covering with an inverted 2-ounce wide mouth bottle to retard evaporation. All spot tests shall be conducted in such a manner that the test surface is kept wet throughout the entire test period, and at a temperature of $77^{\circ} \pm 3^{\circ}$ F. For both methods, leave the reagents on the panel for a period of one hour. At the end of the test period, the reagents shall be flushed from the surface with water, and the surface scrubbed with a soft bristle brush under running water, rinsed and dried. Volatile solvent test areas shall be cleaned with a cotton swab soaked in solvent used on the test area. Immediately prior to evaluation, 16 to 24 hours after the reagents are removed; the test surface shall be scrubbed with a damp paper towel and dried with paper towels.
 - b. **Test Evaluation:** Evaluation shall be based on the following rating system.
 - Level 0 – No detectable change
 - Level 1 – Slight Change in color or gloss
 - Level 2 – Slight surface etching or severe staining
 - Level 3 – Pitting, cratering, swelling, or erosion of coating. Obvious and significant deterioration.

After testing, panel shall show no more than three (3) Level 3 conditions.

- d. Performance Test Results (Heat Resistance): Hot water (190°F – 205°F) shall be allowed to trickle (with a steady stream at a rate not less than 6 ounces per minute) on the finished surface, which shall be set at an angle of 45° from horizontal, for a period of five minutes. After cooling and wiping dry, the finish shall show no visible effect from the hot water treatment.
- e. Performance Test Results (Impact Resistance): A one-pound ball (approximately 2" diameter) shall be dropped from a distance of 12 inches onto the finished surface of steel panel supported underneath by a solid surface. There shall be no evidence of cracks or checks in the finish due to impact upon close eye-ball examination.
- f. Performance Test Results (Bending Test): An 18 gauge steel strip, finished as specified, when bent 180° over a ½" diameter mandrel, shall show no peeling or flaking off of the finish.
- g. Performance Test Results (Adhesion): Ninety or more squares of the test sample shall remain coated after the scratch adhesion test. Two sets of eleven parallel lines 1/16" apart shall be cut with a razor blade to intersect at right angle thus forming a grid of 100 squares. The cuts shall be made just deep enough to go through the coating, but not into the substrate. They shall then be brushed lightly with a soft brush. Examine under 100 foot-candles of illumination. Note: This test is based on ASTM D2197-68, "Standard Method of Test for Adhesion of Organic Coatings."
- h. Performance Test Results (Hardness): The test sample shall have a hardness of 4-H using the pencil hardness test. Pencils, regardless of their brand are valued in this way: 8-H is the hardest, and next in order of diminishing hardness are 7-H, 6-H, 5-H, 4-H, 3-H, 3-H, F, HB, B (Soft), 2-B, 3-B, 4-B, 5-B (which is the softest). The pencils shall be sharpened on emery paper to a wide sharp edge. Pencils of increasing hardness shall be pushed across the paint film in a chisel-like manner until one is found that will cut or scratch the film. The pencil used before that one, that is the hardest pencil that will not rupture the film, is then used to express or designate the hardness

Upon removal of the cooled crucible, there shall be no blisters, crack or any breakdown on the top surface whatsoever.

4. Performance Test Results (Chemical Spot Tests – 24 Hours): Chemical spot tests shall be made by applying 10 drops (approximately ½ cc) of each reagent to the surface to be tested. Each reagent (except those marked**) shall be covered with a 1-1/2" diameter watch glass, convex side down to confine the reagent. Spot tests of volatile solvents marked ** shall be tested as follows: A 1" or larger ball of cotton shall be saturated with the solvent and places on the surfaces to be tested. The cotton ball shall then be covered by an inverted 2-ounce, wide moth bottle to retard evaporation. All spot tests shall be conducted

- B. Coordination: Coordinate the work of the Section with the schedule and other requirements of other work being prepared in the area at the same time both with regard to mechanical and electrical connections and the general construction work.

 - a. Set components plumb, square, and straight with no distortion.

 - 1. Provide reasonable protective measures to prevent components and equipment from being exposed to other construction activity.
 - 2. Advise procedures and precautions for protection of material, installed components and fixtures from damage by work of other trades.

B. Training and Cleaning

- 1. Onsite training of operating and cleaning must be available to staff immediately after the installation of equipment
- 2. Training and cleaning materials to be provided upon delivery of equipment.

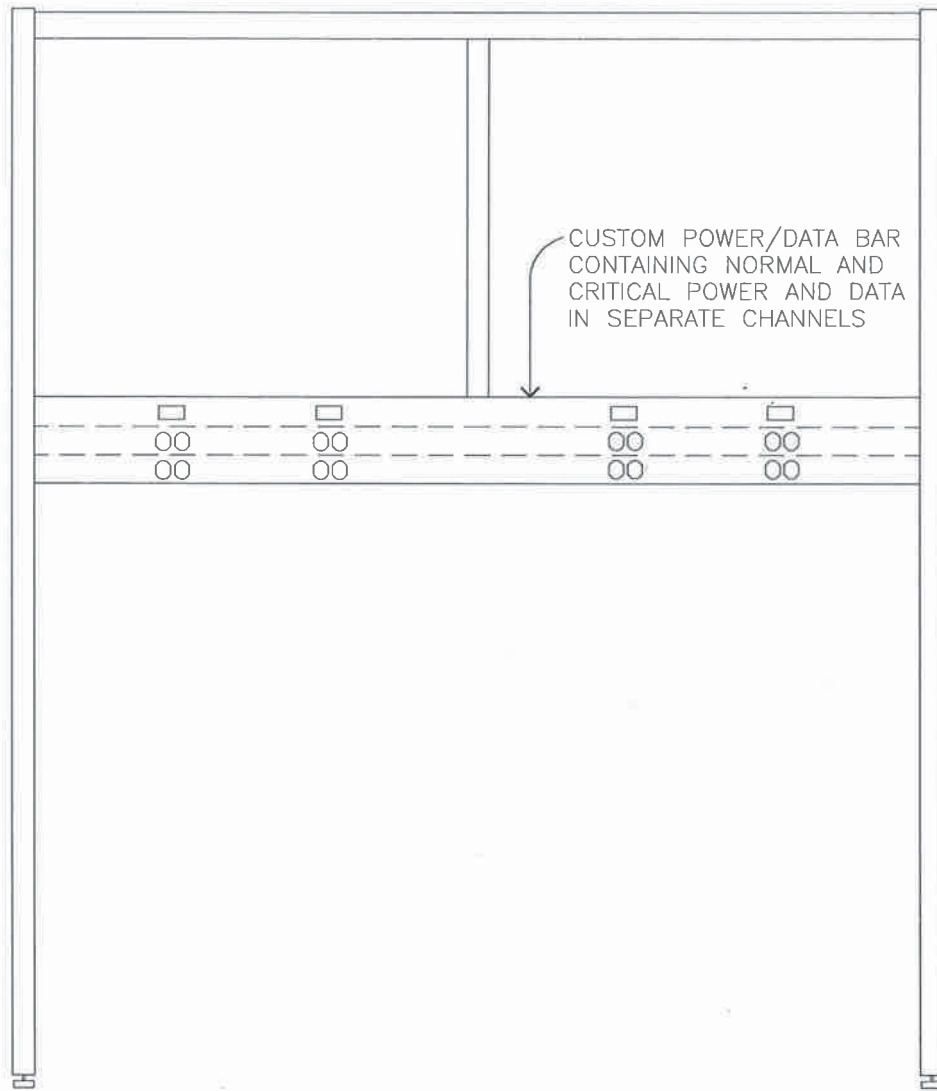
C. Delivery and Installation

Delivery and installation is needed, tentatively on July 19, 2016 (subject to change) as long as the final contractor punchlist is complete. Notification of final date will be sent to awarded offeror closer to completion date. Scheduled delivery will be at the discretion of the Fargo VA presented to the vendor by Chief Logistics. The vendor will have a window of 1 week from notification to provide furnishings as needed if it changes from tentative completion date. Materials of all pieces to which make the equipment fully functional, including all accessories must be present upon delivery.

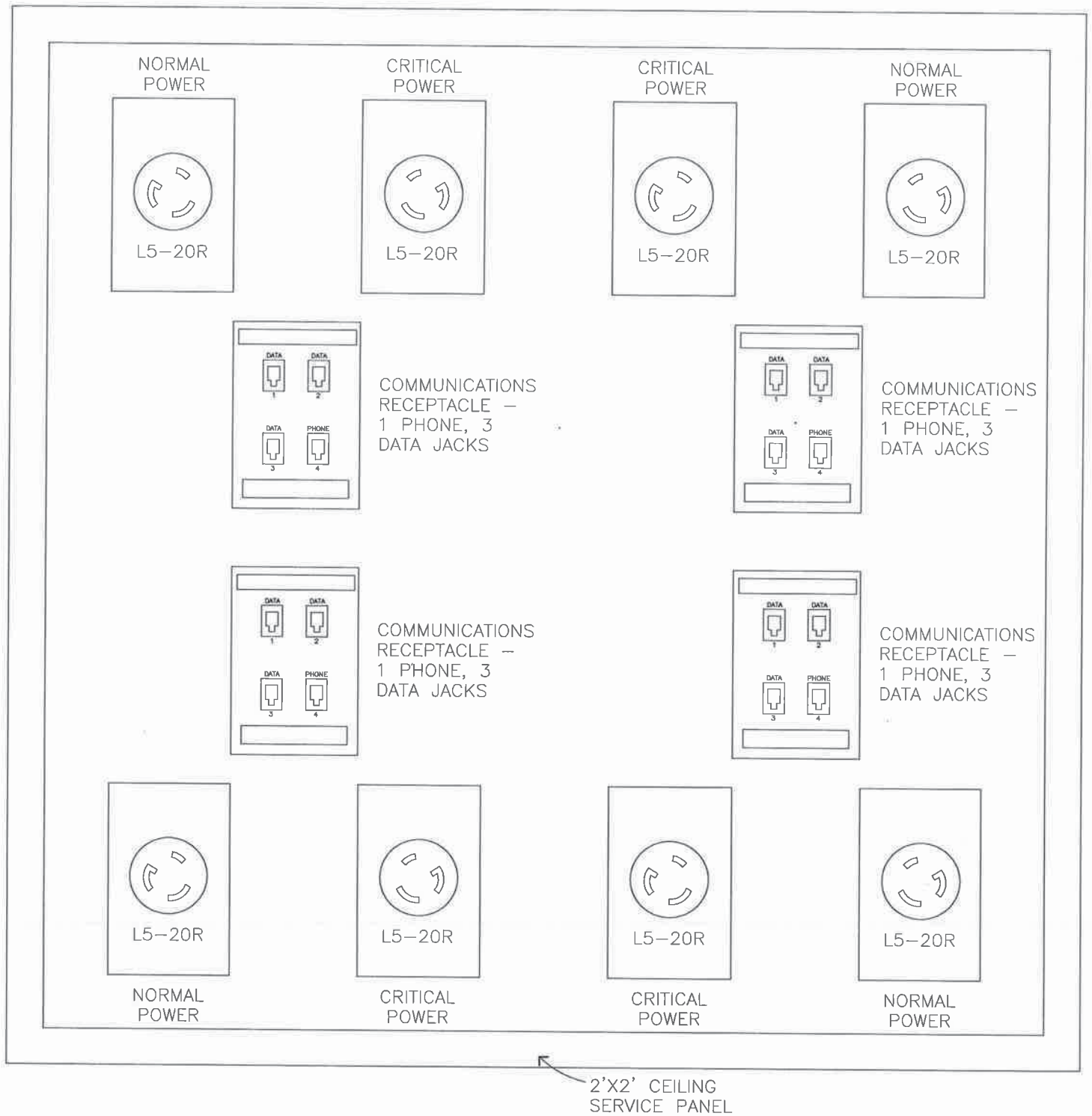
