The purpose of this sources sought/RFI is to gain knowledge of potential qualified sources and their size classification relative to NAICS 339112 (size standard of 1000 Employees). Responses to this sources sought will be used by the Government to make appropriate acquisition decisions. After review of the responses to this sources sought, a solicitation announcement may be published. Responses to this sources sought synopsis are not considered adequate responses for a solicitation announcement.

The Department of Veterans Affairs (VA), VISN 22 Network Contracting Office, is seeking sources that can provide a *Robotic Prescription Dispensing System* that at a minimum meets the following salient characteristics with a brand name or equal product for the VA Loma Linda Healthcare System:

- 1) Prescription Filling Robot and workstations must work with ScriptPro's SP Central software**
- 2) Prescription Filling Robot and workstations must work with the VA OPAI Class 1 Interface**
- 3) Prescription dispensing robot must support the ability to bulk load prescription vials**
- 4) Prescription dispensing robot medication dispensing cells must be configurable on-site to be able to dispense different sizes and shapes of oral solid medications**
- 5) Prescription Filling Robot and workstations shall use barcode verification during the prescription filling process**
